INTRODUCTION

This book is an exposition of the beliefs propounded by what might be called **Brahmanic theology**. It is intended for the common mass of Hindus who need to be awakened to know in what quagmire the Brahmins have placed them and to lead them on to the road of rational thinking.

The Brahmins have propagated the view that the Hindu civilization is *Sanatan*, that is, unchanging. This view has been reinforced by a good many of European scholars who have said that the Hindu civilization is static. In this book I have attempted to show that this view is not in accord with facts and that Hindu society has changed from time to time and that often times the change is of the most radical kind. In this connection, compare the Riddles from *Himsa* to *Ahimsa* and from *Ahimsa* to *Himsa*. **I want to make the mass of people to realize that Hindu religion is not *Sanatan*.**

The second purpose of this book is to draw attention of the Hindu mass to the devices of the Brahmins and to make them think for themselves how they have been deceived and misguided by the Brahmins. It will be noticed how the Brahmins have changed and chopped. There was a time when they worshipped the Vedic gods. Then came time when they abandoned their Vedic gods and started worshipping non-Vedic gods. One may well ask them — where is Indira, where is Varuna, where is Brahma, where is Mitra the gods mentioned in the Vedas? They have all disappeared. And why, because the worship of Indira, Varuna and Brahma ceased to be profitable. **Not only did the Brahmins abandon their Vedic gods but there are cases where they have become the worshippers of Muslim Pirs.** In this connection one glaring case may be referred to. In Kalyan near Bombay there is a famous Darga of Pir called Bawa Malangsha on the top of a hill. It is a very famous Darga. Every year a *Urs* (pilgrimage) is held and offerings are made. The person who officiates at the Darga as a

priest is a Brahmin, sitting near it, wearing the clothes of Muslims and receiving monies offered at the Darga. This he did for the sake of money. **Religion or no religion what the Brahmin wants is *Dakshina*. Indeed the Brahmins have made religion a matter of trade and commerce.** Compare with this faithlessness of the Brahmins the fidelity of the Jews to their gods even when their conqueror Nebuchadnezzar forced the Jews to abandon their religion and adopt his (religion).

"Nebuchadnezzar, the king, made an image of gold, whose height was three score cubits, and the breadth thereof six cubits; he set it up in the plain of Dura, in the province of Babylon.

"Khatri Sick" PM — Brahminist darling — is cause of current all-round crisis & confusion

The country is under a terrible confusion and chaos created by its micro-minority ruling class (15%). This crisis is deliberately created by the Brahminists so that we, the victims of their slow, painless blood-sucking operation, will not make out who actually is doing it. This centuries-old operation is being carried out by the enemy keeping us dirt poor. Hence illiterate and unthinking.

Only the poverty-stricken Eastern part of India with predominant Tribal and Dalit population — reduced to bones and skin — has started getting angry and protesting. The Brahminist blood-suckers quickly made use of the opportunity and took over the leadership calling them Naxalites and Maoists. Leading them are Brahmins, Reddis and Khammas. It is these oppressors who named our people fighting for human rights as Naxalites and Maoists.

Dantewada massacre: The Dantewada massacre of 76 CRPF (reserve police) men in the dense Chhattisgarh forest on April 6, 2010 — a four-decade-old conflict between the Brahminical state and the starving people of India — brought the whole contradiction once again to the centre stage with parliament opposition members demanding the head of the Home Minister, the Tamil Chidambaram Chettiar.

But in the dust and din raised on the Dantewada disaster the most important point was missed. If the so-called Maoists are the dust poor wretched of the earth, whom the ruling Brahminists have deliberately abandoned and forgotten, the CRPF men who died unsung, unwept also belonged to the same category.

The Brahminist strategy is so fine and flawless that it is making brothers fight brothers as they sip whiskey watching in cool comfort the stupid IPL cricket in metropolitan cities.

Chettiar had the licence to kill: Their enjoyment has no limit. But remember all those who laugh today will have to pay through their nose tomorrow.

The parliament debate on Dantewada massacre was furious. Even the Congress upper caste leaders like Digvijay Singh and Manishankar Iyer rightly demanded the Chettiar's head. But the confident Chettiar defended himself because he had the licence to kill — authorised by his boss.

Gujarati Bania hailed as Mahatma: Did not the same Chettiar play havoc as the Finance Minister? Did he not give free hand to the Marwadi monsters and Dalal Street *dagalbajis* to loot and murder? Did he not then also have the licence to kill? Except DV, did anybody else in India demand his skull? DV proved right then. And it will prove right again today. The

micro-minority Tamil Chettiars belong to a blood-sucker money-lender class. What else we can expect from such a class — except looting, shooting and blood-sucking?

Did not India's blood-sucker ruling class hail the Gujarati Bania as "Father of the Nation" and *Mahatma* who deceived all of us?

The logic of this land ruled by our blessed Brahminists is truth-seekers like Dr. Babasaheb Ambedkar, who fought and died for the liberation of the oppressed, are called traitors but money-mongering monsters are called mahatmas.

Look at another fellow. Human Resources Minister Kapil Sibal, the darling of the dragons, who came out with two "wonder projects" — a red carpet welcome to foreign universities (DV April 16, 2010 p.7: "Foreign universities will expand India's vast intellectual desert) and free, compulsory and universal education up to 8th standard (DV May 1, 2010 p.10: "*Khatri Sick's another false promise*"). If the first is to please the Brahminist rulers, the second one is to deceive the over 60% of the innocent masses of India kept illiterate even after 63 years of "independence". Why Sibal is trying to deceive our innocent producers of wealth when no funds are provided to implement the project?

The answer is Kapil Sibal has the permission from his boss.

Israeli hold on Defence Ministry: India's entire Defence setup is controlled by the Zionist-Jew Israel. The Syrian Christian A.K. Antony is the Defence Minister. Muslims who form 20% of India and those outside have been protesting the invasion of Mossad and the Zionist-Jews into India.

The Abhinav Bharat, the Chitpavan super-Hindu terrorist gang, has already announced the setting up its shadow govt. in Israel, the homeland of their cousins, and launched the "Bombay terrorist attack" killing the police officer Karkare. (See also p.23).

S.M. Mushrif in his book has said the Intelligence Bureau was fully aware of the Bombay terrorist attack of 2008.

Why the IB, which is directly under the *Khatri Sick* PM, found fault with the upright police officer Karkare for arresting the *Abhinav Bharat* leaders who killed hundreds of Muslims in Malegaon and other places? How did top Army officers permit

the *Abhinav Bharat* to steal RDX explosives which is available only with the Army? Why the Bombay "terrorist attack" was not prevented though the IB was in possession of the information of the attack five days in advance?

Who blocked the IB from informing the Bombay police and plunged Bombay in blood bath?

Show boy made Foreign Minister: Shashi Tharoor, a silly Nair buffoon from Kerala, since dismissed, is too small a person to be mentioned in DV. He was a nuisance to the United Nations as its under secretary in New York. Who brought him to India, gave him a Congress ticket and made him a Minister?

But what is worrying is the selection of a show boy S.M. Krishna as the Foreign Minister who proved to be a total misfit.

Sachar Commission gave the report long, long back recommending reservation to Muslims which they fully deserve as India's most persecuted religious community.

But who came in the way of its implementation?

Women's Reservation Bill: Look at the Women's Reservation Bill to which over 85% of Indians are opposed. The BJP Govt. headed by Vajpayee tried to push it but failed. Who did it this time and suffered humiliation in the Rajya Sabha?

The pure *Brahmana Jati Party* (BJP) itself has now backed out of the Bill fearing revolt within. Who is behind the Congress Party pushing this notorious Bill cheered by the 15% anti-women upper castes? (DV Edit April 1, 2009: "*Democracy subverted: Women's Bill further strengthens Brahminical rule*").

This is the problem of having a PM who cannot get elected even to the lowest panchayat post. Is it possible to rule a 1,300-million-strong country getting orders from World Bank Zionist-Jews?

The ruling class is against SC/ST reservations, it is against reservations to Muslims and Dalit Christians. It is against OBC reservation as recommended by the Mandal Commission. When it is opposed to reservation itself as a principle why it is seeking reservation to their women? Look at the mischief. Who is the mischief-maker behind this Bill?

India's total isolation: Who caused the total isolation of India in the world? Why all the countries surrounding India —including the

Buddhist Lanka and the Hindu Nepal — are hating India while all of them love China and offered it all the facilities? Even the USA, where the Brahminists keep their heart, has started going away after Obama took over as President.

When China has already become a super power, which is feared even by USA and others, why India is treated like a worm? Why every UN agency and govt. of the world is finding fault with India for neglecting the welfare and well-being of its 85% the have-nots? Why India has not fulfilled even a single goal fixed by the UN under the Millennium Development Goals (MDG)?

Who caused the deliberate neglect of this over 85% massive majority producers of wealth? And converted India into a heaven for fascists, frauds and fiends?

The unanimous opinion is the "Khatri Sick".

Vajpayee was much better: The *Brahmana Jati Party* (BJP) had a two-term rule, also under a multi-party coalition headed by the Vaidik Vajpayee. DV was very critical of his prime ministership.

But compared to the *Khatri Sick*, we feel the Brahmin Vajpayee was much better.

The entire Brahminical ruling class abandoned their favourite BJP and plumped for the Congress only because it was assured of their blue-eyed boy, Khatri Sick, becoming the next PM. They did it and the PM is serving the cause of these blood-suckers going out of the way — even at the peril of ruining the health and happiness of the people.

Cricket loving crooks: This less than 15% upper castes, who today are busy with their sex-drink-entertainment-cum-multi-million dollar fraud through their stupid cricket, are the greatest admirers of the *Khatri Sick*.

They love him even more than their darling, pure Brahmin Vajpayee. They manipulated and managed the Congress Party victory only because they were assured that the *Khatri Sick* would ensure free and uninterrupted opportunity to suck of our blood. (See also p. 25)

Why the poor not getting angry: Yes. The poor, oppressed *Moolnivasi Bahujans* (85%) cannot and do not know how their blood is being sucked. The entire countryside is devastated. Yet they are sleeping. Slaves enjoying their slavery.

The Muslims (15%) are threatened and silenced

by calling them terrorists and thousands thrown into jails.

The SC/ST/BCs (65%) are mesmerised by using two powerful weapons: (1) the Hindu opium called religion which tells the poor, oppressed, starving SC/ST/BCs — who are not Hindu and never Hindu but sworn enemies of Hindu — that their suffering is due to past *karma* which they can overcome by going to the Brahmin temples, put their little money there and get the blessings of the god (meaning the Brahmins). By this tricky process, the *Moolnivasi* will become further poor and his money enriching the *Bhoodevatas*.

(2) TV in every language of India giving day and night entertainment, a poison that will further damage and destroy the brain. Rulers are supplying cheap if not free colour TV to every house so that they stop thinking.

This is what is happening to the "Father of India", Dr. Ambedkar's *Moolnivasi Bahujan Bharat*.

The *Khatri Sick* is the cause of all the problems — the fall and slow death of India.

He is fully supported by the Zionist-Jews controlling America because he is their nominee as a former World Bank man. He is faithfully following their dictates causing the slow death of India. As the "Jews of India" do not belong to India, they don't care what happens to this country. Since the Jews and the "Jews of India" are cousins, they are backing him to the hilt — but killing the *Bahujan Bharat*.

But who will reach our voice to Delhi? We have no media of our own.

Who encouraged the gamblers: The ruling class (15%) is encouraged to become man-eaters, ruthless gamblers and fraudsters by our corrupt Brahminical "national" toilet papers. The latest instance of their highway robbery is the IPL cricket which turned into gambling and looting. How could these rascals get the courage to flout every law of the land — unless they were confident of the blessings from the highest authority of the land?

We have nothing personal against the PM. It is purely ideological. The ruling class may ask: "How can you criticise a person who leads such a simple life?" Yes. We agree. Money corruption is the last among the four varieties of corruption (*India's Intellectual Desert*, DSA-1999, Rs. 50). The worst form of corruption is intellectual dishonesty which generates all other three types of corruption. That is our charge. ■

Brahmin birth-rate falling ? Fear of genetic extinction

Pune: The Brahmin birthrate is falling causing serious worry in *Bhoodevata* circles, according to a secret circular distributed in Pune city Chitpavan circles.

Brahmin scholars and experts are discussing the projection that by the year 2050 — 40 years away — the Brahmin population in the country will go down from the present 2.5% to less than 2%.

"GODS ON EARTH"

Already a micro-minority in a country of 1,300 millions, the Brahmins have been the unquestioned lords of the land presiding over every section of the society: social, cultural, economic, political, media, legal, academic.

They have been also the country's wealthiest and the most powerful — rightly winning the title of the *Bhoodevatas* (gods on earth).

Lately, the Editor of *Dalit Voice* has added a new feather on their cap calling them the "Jews of India", more powerful than the 2% Jews who control the world's most powerful country of America.

Caste-wise census enumeration is blocked in India because a true picture of the country would reveal the undemocratic picture of power. Not only that. The *Moolnivasis* (indigenous), who form over 85% of the country's population, would get tremendous courage and strength on realising their population power. Already the Muslims (20%) are joining the Dalits in a big way to forge a powerful anti-*Bhoodevata* battle front.

When such a powerful united front of the oppressed is taking a solid

shape, if the news of the grass-eating Brahmins — already physically weak and facing genetic extinction — spreads it will only hasten the gloom and doom surrounding the country's worst oppressor community which unfortunately happens to the country's core ruling micro-minority ruling class.

But the different oppressed castes and communities are not aware that within a couple of generations their oppressor *jati* will be facing total extinction.

REASONS FOR POPULATION FALL

The two reasons given for the steep fall in their population is the widespread religious custom of killing the female child at birth (or before) and their speedy migration to the West, mainly USA.

Even the thinking sections among non-Brahmins are not aware that the Brahmins will be left in a state of peril if these facts are published.

At the recent gala Pune Marathi Sahitya Sammelan, which is monopolised by the Chitpavan Brahmins, the killers of their own "Father of the Nation", Gandhi — such a life and death issue of the *Bhoodevatas* — the suicide of the gods on earth — was secretly discussed but not publicised.

MOOLNIVASIS BECAME MUSLIMS

The Brahmins, it is learnt, are seriously worried that the land — into which they came as thugs and pindaries from West Asia over 3,000 years ago — easily fell into their hands and they became its

rulers after killing the Budhists and finally driving the liberating Budhism out of India. After killing Budhism, they welcomed the Muslims, became their loyal servants to further oppress the *Moolnivasi Bahujans*.

GUJARATI BANIA MADE MAHATMA

Fortunately the oppressed *Moolnivasis* themselves became Muslims and fought back the Brahmins and became their blood enemies.

Then came the British who again were fooled so that they remained as the *Bhoodevatas*. They caught hold of the Gujarati Bania and made him give up his Western dress, beef-eating and drinking habits, called him *mahatma* to fool the innocent *Moolnivasis* and ultimately forced the British to quit — but only after vivisectioning the country so that the Dalit-Muslim unity would not imperil their rule.

For about 65 years the *Bhoodevatas* ruled India enjoying heavenly bliss, manufacturing loyal stooges and destroying the health and happiness of the *Moolnivasis*.

At a time when they became the supreme rulers with none to challenge them, they get the alarming report that they are facing a genetic genocide.

It means our centuries-old oppressors are dying not out of any war and violence launched by the oppressed majority but because of their own conspiracies, crimes, perversion, in-breeding as the world's original founders of racism. Meanwhile, the "Jews of India" have received enough hints that

their own cousins, the zionist Jews — on whom they are today totally depending for their survival — are no longer trusting them. The zionist Jews have come to know the secret that it was the Aryan

Brahmins who brainwashed Hitler and the innocent Germans to launch the mass murder of Jews which became world famous as "Holocaust". The zionist Jews have at least thoughtfully, carved out a

homeland for themselves (Israel) but the hated "Jews of India" can go nowhere as they have created too many enemies all round including their own blood brothers, the zionist Jews.

EVERY ETHNIC IDENTITY IS INTACT

Rulers hate our caste but keep their castes safe & strong

Bangalore: Caste enumeration in the current ongoing census operation (2010) is banned by the upper caste rulers on the ground that such a head-count will promote "casteism". The mere 15% upper castes are ruling India only on the strength of their caste. Even the Supreme Court — dominated by upper castes — helped the Brahmin castes by ruling that a Brahmin alone must be the temple priest. The upper castes are holding on to their caste privileges even as successfully making the SC/ST/BCs lifeless — of course with the help of their Brahminical casteist media.

Women's Bill: When the Editor of *Dalit Voice* got the international LISA award in London (2005), for his book, *Caste — A Nation Within the Nation* (Books for Change, Bangalore, 2002, photocopy available with DV office Rs.100) the Brahminical media blacked out the report. Not a single paper reviewed the book which went into three editions and translated to Hindi and Kannada — all sold out.

The politics of "caste", however, came to the forefront when the upper caste rulers cunningly got the Women's Reservation Bill passed in the Rajya Sabha after clamping "martial law" and physically throwing out the protestors. The Bill has to be brought before the Lok Sabha but the upper castes are nervous. Because the caste is killing the *Brahmana Jati Party* (BJP) also.

Thakur caste party: The 15% micro-minority upper caste rulers have successfully broken the backbone of the 85% *Moolnivasi Bahujan Bharat*, made them deaf, dumb and blind. And yet the oppressors trumpet through their casteist "national" toilet papers that "India is the world's greatest democracy".

But with all the Brahminical efforts to beat the "caste" to death, the sole single "ethnic identity" of the indigenous people, the "caste" is not only not dying but fully alive and kicking.

The notorious UP Thakur, Amar Singh, thrown out of the party by Mulayam Singh, wants to start a caste party of Thakurs. No Brahmin has so far criticised his proposal.

DV has long back welcomed caste-based parties which will pave the way for caste wars.

Bihar experiment: In the neighbouring Bihar, the Brahmin favourite, Nitish Kumar, a Kurmi, wants to give land to certain Dalit subcastes. He has already introduced a new caste-based reservation to "Maha Dalits" comprising 21 castes. The Kurmi leader is the latest blue-eyed boy of the Brahmins. He now wants to include the Paswan *jati* also. (DV April 1, 2010 p.20: "Brahminic hand boosting Nitish Govt. to keep Lalu out").

The four castes — Dusadh, Pasi, Dhobi and Chamar — constitute 69% of Bihar's Dalit population living in subhuman condition. Of this Ravidas and Dusadh (Paswan) form 31.4% and 30.1%. Only 26% of the Dalits in Bihar are literate.

No subcaste among the Dalits, OBCs or upper castes is ready to give up its "caste identity" because that is their ethnic origin. And yet these Dalit castes are brainwashed by Brahmin to say that caste must go — even as every oppressor caste retains its "caste identity" in tact.

Not a single Aryan upper caste (15%) has given up its "ethnic identity". They are only asking our people to destroy our castes. This will never happen.

But the Iyengar Brahmins belonging to the House of the *Hindu*, called the "Mount Road Mahavishnu" of Madras, are not only quarreling but washing all the dirty linen in public.

The *Indian Express*, its rival, was the first to expose the frauds allegedly committed by the Editor of the *Hindu*, N. All his posing as a "marxist", giving lavish publicity to the bogus Brahmins in CPM, is an attempt to deceive the gullible.

Madras: The Madras High Court has directed at least five nationalized banks to follow the rule of reservation for promotion of SC/ST candidates to officer ranks.

A division bench comprising Justice Elipe Dharma Rao and Justice C.T. Selvam, citing a central govt. memo of Aug. 13, 1997, said: "When the Constitution has given an extra protection to the underprivileged communities so as to ensure equal opportunities as guaranteed by the constitution, the banks are not justified in sleeping over the matter of providing reservation in promotions for a decade with no good reason to offer". The petitions and appeals were filed by the SC/ST employees associations of various nationalized banks, seeking a direction to the banks to provide reservation in promotions to officers from scale I to Scale VII as per the instructions issued by the Centre.

The banks, however, said promotion to officers grade is on the basis of merit-cum-seniority, to which reservation policy cannot be made application.

Justice Dharma Rao said: "We are unable to understand such a sweeping and generalized argument advanced on the part of the banks, as if all the employees belonging to these underprivileged classes are inefficient and not suitable for promotion. When the Union of India has directed the banks to follow the rule of reservation in promotions in all cadres as early as in the year 1997, there is no impediment for the banks to implement the same. However, for no better reason to be appreciated, the banks are adamant in not implementing the office memo". ■

Women's Bill on death bed

Racism in Canara Bank

Bangalore: On the historic occasion of the Dr. Ambedkar birth anniversary (April 14, 2010), this correspondent visited the headoffice of the Canara Bank in Bangalore to find out the representation of Dalits in this state-owned bank, 50 years after the constitution came into being. The following shocking facts have been gathered.

The bank has about 12,000 Dalit employees but only 3,000 officers — that too at lower levels.

Though the bank is govt.-owned it is run by micro-minority Brahmins and other upper castes (15%) who never allow Dalits to come up.

This is evident from the following negligible representation of SC/ST in the executive posts. Even

the couple of SC/STs promoted to executive jobs are not given responsible postings. Such is the extent of racism inside this bank and all other govt. institutions.

Need for decentralised Dalit leadership

The famous English writer Carlyle has something significant to say about the question of leadership in a society. He says leaders are required to lead different societies to accomplish their well being and to create harmony in chaotic situations. But Carlyle has laid down a prerequisite for the leader who has to be 100% honest, selfless, righteous, intelligent and a staunch believer in social dynamics. Carlyle's ideal leader, undoubtedly, is to be a very great personality or in other words a saviour. Humankind has seen such saviour leaders once in a blue moon as they are not born frequently. Such saviour-leaders are trusted by the society blindly without having an iota of doubt about their credentials because the followers know that their leader would not let them down.

Dr. Ambedkar as a saviour: Dr. Babasaheb Ambedkar — VTR calls him Father of India — totally fits in the definition of Carlyle. Looking at the plight of Untouchables in India, he said:

If I fail to bring the millennium of these unfortunate people, I will shoot myself dead.

That was the determination of a leader who had absolutely blended himself with the society he wanted to uplift. And unflinchingly, not only he uplifted them but laid down the foundation of "modern India" by writing the constitution of the country. Babasaheb gave his entire life and blood to liberate the Indian underdog from the cultural terrorism of Hinduism. Babasaheb developed a model of his movement and mission, himself provided ideological base to the model and demonstrated its implementation for future generations leaving behind a colossal bulk of ideological fuel in his writings and speeches for future guidance.

In the absence of saviour-leader: If a saviour-leader, having maternal love and affection for his people, leads his folk, there is no danger if his leadership becomes centralised. As he is born for the emancipation of his people, his death also culminates into the well being of those whom he emancipates. There does not arise any occasion when he puts his people's lives in jeopardy. That is why even after 60 years his people are living undisturbed as far as their basic human rights are concerned.

Even a saviour-leader — due to limitations to his life — is not able to complete the mission he has undertaken. In such a situation the entire responsibility of steering ahead the mission falls on the shoulders

of his lieutenants. Babasaheb has clearly mentioned that in the absence of a saviour leader, it is the responsibility of the intellectual class to lead the society.

Definition of intellectual: Babasaheb has given the definition of an intellectual and pointed out his qualities. He has given the example of Voltaire — the pioneer of French Revolution — as a true intellectual. If examined in the light of Babasaheb's interpretation, we get the names of Martin Luther, Galileo, Abraham Lincoln and others who were truly emancipated beings, not afraid of telling the truth.

When Babasaheb talks of intellectual class and imposes on them the responsibility of leading the society in the absence of a saviour leader, he indirectly mentions the necessity of decentralisation of leadership. Now, what is decentralised leadership? This surely means collective leadership. No single leader is appointed to lead the movement. If such a leader is not honest, intelligent and righteous, he can lead the society and the mission astray because of his whimsicalities, which common masses find difficult to control. In such a situation he is bound to cause an unlimited damage to the movement and mission which coming generations find difficult to salvage.

Psychology of Dalit leadership: If we examine and evaluate psychology of post-Ambedkarite Dalit leadership, the picture appears very dismal and discouraging. The vacuum created after the leadership of a towering intellectual giant like Babasaheb cannot be filled up. But still the centralisation of Dalit leadership has been continuing in the absence of a saviour leader. Secondly, those who claim themselves as post-Ambedkarite leaders do not have that stature and appear as pygmies. They seem to suffer from inferiority complex, self love, greed, rivalry phobia, intellectual dishonesty and a complete lack of scientific interpretation of Ambedkarite mission. In fact these worthies have misinterpreted the mission after Babasaheb and battered the Ambedkarite chariot of the movement causing the halt of its dynamism.

Centralisation of leadership: Yet their the-king-can-do-no-wrong attitude shocks us. Even Kanshi Ram could not save himself from the centralisation trend though he proved himself a much better political leader

than any other post-Ambedkarite mission has been thoroughly politicized because of centralisation of leadership.

The politicization has percolated in social, cultural organisations functioning in total isolation having no coalescence with each other. This has happened due only to centralisation of leadership. Dalit masses have been thrown to winds because of the whimsicalities of self-styled and dishonest leaders.

Want decentralised & collective leadership: Ambedkarite intellectuals are scattered throughout the country in different states. Because of Babasaheb's struggle and constitutional safeguards, a middle class has emerged in different Ambedkarite communities. There is a pan-Indian presence of Ambedkarite followers and intellectuals who have become capable of leading the Ambedkarite mission by providing collective and responsible leadership.

The only rider is that this decentralised and collective leadership should train itself to work like missionaries not hankering for any posts and vested interests. They should train themselves to work like the Buddhist monks in the time of the Buddha binding themselves with a strict moral code. The collective leadership should function like philosophers, guides and researchers. They need to enact the role of a mother to protect,

propagate and nourish the Ambedkarite model of the movement spearheaded by Babasaheb himself for nearly 40 years. By applying the principle of research and development and proper evaluation, any movement can be successfully launched to emancipate Dalit-Bahujan masses from the tyranny of Brahminism. Babasaheb's social, political and cultural movement was the result of his brain storming research he had done in these fields. Just like an affectionate mother he had nourished his movement with the food of his research in different sectors.

Mother organisation: The Ambedkarite intellectuals would have to become the mother of the mission by developing and activating a model divided into two parts: (1) Mother organisation (which will function like the Buddhist sangha) and (2) Front organizations (functioning like organs of mother organization).

The mother organization would have to control, discipline, and provide programs and logistics to the front organizations. The front organization will, in return, provide energy and potential to the mission by their field work. There needs an intra-organizational and intra-front co-ordination, co-operation and coalescence between mother and front organizations.

Dr. Ambedkar, "Lincoln of India" in the Time magazine

Found this very interesting Time magazine interview of Babasaheb (1936). Interesting to look back how history has developed.

Religion: Untouchable Lincoln

(Monday, Mar. 16, 1936)

One of the few men who have risen from the malodorous sink which is below the lowest caste of India is Dr. Bhimrao Ramji Ambedkar, No. 1 Untouchable. This plump, cheery, bespectacled man of no caste, whose very shadow would outrage high-caste Hindus, managed to get a good education in Indian Government schools, was staked to courses at the University of London and Columbia University by the highly democratic Gaekwar of Baroda.

CONVERSION TO CHRISTIANITY

Dr. Ambedkar is probably the only man alive who ever walked out in a huff from a private audience with the Pope of Rome. His Holiness Pius XI having heard from Dr. Ambedkar about the miseries of Indian outcastes, replied: "My son, it may take three or four centuries to remedy these abuses, be patient."

Impatient Dr. Ambedkar summoned 10,000 raggle-taggle Untouchables to Nasik, near Bombay, last autumn, said deliberately:

"I had the misfortune of being born with the stigma of Untouchability. But it is not my fault. I will not die a Hindu, for this is in my power. I say to you, abandon Hinduism and adopt any other religion which

gives you equality of status and treatment."

Thereupon the 10,000 adopted a resolution advising India's Untouchables — some 60,000,000—to desert Hinduism en masse. Then a mob of Untouchables made a mighty bonfire of the most sacred Hindu books they could find. At Lucknow volunteers were solicited to force entry into Hindu temples, from which Untouchables have been barred since time immemorial. At Barabanki 28,000 Untouchables shouted their support of Dr. Ambedkar, laid plans for an All Indian Untouchable Conference. Millions of leaflets bearing Untouchable Ambedkar's message began fluttering out over India.

To what faith the Untouchables should turn for "equality of status and treatment," Dr. Ambedkar did not hasten to explain. Since he was reported dallying with Mohammedanism, Christian leaders in India exhibited pious skittishness. Declared the National Christian Council of India: "The harvest is ripe for the gathering in many quarters and we urge that volunteer bands be sent forth to gather it."

HINDUISM IS A DISEASE

This week in *Zion's Herald*, New England Methodist weekly, appears the first interview with Dr. Ambedkar to be published in the US since he made his Nasik speech. To get it, able Editor Lewis Oliver Hartman went to India, sought out its No. 1 Untouchable, plied him with practical questions. Wrote the editor of *Zion's Herald*:

"The [Untouchable] leader was rather critical of Christianity's

constant emphasis upon personal experience at the expense of any wider reference. 'Why have you not seen the importance of a religion that reaches out into all life and all relationships?' he asked. Continuing, he declared with deep feeling, 'If you are going to compromise with evil conditions while you stress personal religion exclusively, I tell you now I am not with you.'

... "I pointed out in answer that, so far as the Methodist Episcopal Church was concerned, our watchword was this: 'Nothing that has to do with human welfare is foreign to Methodism.' This seemed to please him. . . ." Of Hinduism the man whom Editor Hartman calls "India's Lincoln" said: "Hinduism is not a religion; it is a disease."

SETTLED QUESTION

Editor Hartman's interview concluded thus:

"This much is settled,' he said to me, 'we are through forever with Hinduism. We are going somewhere, but are not ready yet to say in what direction 'Yes,' I answered, 'you are not strong enough yet to announce a decision. If you compromise with the Hindus, all is lost; if you choose Mohammedanism, the Hindus will crush you; if you go Christian, both the Hindus and the Moslems will be on your back.'

" 'Exactly,' replied Dr. Ambedkar. 'We are not ready—yet.' " (mosesparmar@gmail.com)

IV. Annulment of Marriage

In the matter of marriage between man and woman, that is, in life as husband and wife, it can be said that in no other country such atrocities are committed as in our own. If it is to be expressed in short, the philosophy of marriage here, is nothing but that which leads to the enslavement of women by men. The rituals etc. are only intended to cover up this enslavement and cheat women, in addition, by giving it a meaningless and bogus label of divine marriage we indeed deceive them.

Fair-minded people anywhere cannot deny the fact that generally, that is, not only in our country but the entire world, women are treated most cruelly and forced to behave unnaturally in the matter of marriage. But our own country is clearly the worst-behaved in this. If these cruelties are continued in the same way, within a short while, that is, half a century or so, all marriage formalities and marriage relationships will totally disappear from all over the world. It is on account of this, that learned men everywhere are relaxing the constraints on women. However, our country alone like a monkey, is doggedly holding on to the same old practices. That is why there is an urgent need for a radical women's movement here. In the Chengalpet Self-Respect Conference, a resolution was passed to the effect that both men and women ought to have the right of divorce in marriage, later at the women's conference, Chennai a resolution again was passed demanding that a law on marriage be enacted. At this, many, including those who parade themselves as reformers raised a hue and cry as though everything was lost. However, after the Chengalpet resolution, in several places both India and abroad laws for annulment of marriage have been enacted. In Russia, marriage is being treated as a daily contract. A law was brought in Germany providing for the annulment of marriage without even adducing reasons, if so desired by the parties concerned. This is a matter known to everyone. More recently, the state of Baroda also has enacted in their Legislative Assembly a law for annulment of marriage. There

has been a similar law in many Western countries. It needs to be said that it is a matter for concern, that in our country alone no one is bothered to think of making a law in this matter. We have been reading in the daily newspapers that generally in the south many men are committing murders on account of suspicion concerning the behaviour of their wives. Some times we also read that multiple murders took place on suspicion of the behaviour of a single wife. People of inveterate religiosity do not have the basic sense to question why do marriage of "divine nature" end up like this? If the world of women is to progress, that is, they also are to actualise their own human dignity, human rights and self respect, for men satisfaction, happiness, true love, and morality were to be possible, it is important that space must be created for the cancellation of marriage. Until then, for both men and women true happiness and life of freedom will be impossible.

Many of our reformers raise a hue and cry on the issue of one man having two wives. It is not clear to us, on what count such a din is raised — because of religion or rationalism? Or do they speak like this on account of human morality? We will dilate on this some other occasion. We want to ask this of those who oppose a man marrying more than one woman: is marriage for human happiness and satisfaction or for ritual rectitude. We ask, what is the duty of a man who for some reason or other becomes the husband of an unwilling, cantankerous or sexually deficient woman? In the same way, what is the fate of a woman, who happens to get a similar man as her husband? If marriage is indeed divine and is indissoluble as claimed, would such inadequacies and complications occur? This alone is sufficient to understand that the claim of the divine marriage is a complete fraud.

Therefore, if a law is not enacted soon in our country for the annulment or marriage just as they exist in others, it may be that propaganda against marriage itself as well as in favour of multiple spouses both for men and women will have to be carried out.

Dr. K. Jamanadas, "Shalimar", Main Road, Chandrapur - 442402: This refers to Karan Jagtap's article in DV of Feb. 16, 2010, p. 6. If you excuse me, I would say it a thoughtless, jumbled up collection of confused ideas, without any purpose. He does not have clear target audience, any definite aim or any certain prescription. He is utterly confused what he wants. Some times he seems to refer to situation in Maharashtra and some times he seems to think of the destitutes of the world over. Some times he seems to talk of Dalits, some times of Ambedkarites and

some times of Bahujans. Some times he laments that we are failures, ostensibly referring to political power, and some times he declares political power is no power. Armed struggle was tried in India by Kashmiris, Khalistanis, Northeast groups, Jharkhand, Andhra, Orissa Naxals. All these groups are much stronger, more powerful and more resourceful than the Dalits. Even then they did not succeed, what of the Dalits? Nobody should advocate armed struggle. He has confused ideas about revolution. Even Karl Marx, referring to situation in England, had observed that there could be a bloodless revolution. Dr. Ambedkar and later his disciple Kanshi Ram have successfully proved that such revolutions could be possible. It is true that the revolution effected by Mayawati is limited to one single province. The reason for that, as expressed by V. D. Chandanshive (DV Feb. 16, 2010, p. 20) is the "rivalry phobia" of Mayawati.

As I have observed earlier, no one can become PM without first getting CMs support. Jagtap thinks there are many gods, worshipped by followers of Dr. Ambedkar. This is false, at least in Maharashtra. PO, Paschim Medinipur dt. - 721 101: In the last one and half years Lalgah and Jangalmahal have become familiar to most of India. But still there are something unknown to DV readers. Southern or western portions of three districts of WB (West Medinipur, Bankura and Purulia) have some natural similarity with the Chhotonagpur plateau that spreads well across the middle of India. Undulating terrain of a bout 20 blocks of the three districts 50 years ago was covered under deep forests. But today dwindling forests have been marginalized to only some blocks. Infrastructural developments in the area is very low. Against this backdrop Lalgah came to prominence with the blast of a land mine behind the convoy of Chief Minister Buddhadev Bhattacharya on Nov.2, 2008. The govt. accused the Tribals and Maoists for the blast and started torturing them from Nov.4. However the state govt. is silent on how mine could be placed there with about half kilometer of wire lying open on paddy field for hours together and where there was no forest within one km radius and directly under the nose of strict police patrol on the road for about a week prior to the incident. There are enough evidences to suspect that it was pre-planned by the CPM Govt. But the CPM and the central UPA Govt. had the compulsion to accuse the Tribals for the blast. Why the compulsion. From last quarter of 2006, land grabbing programme for Jindal Steel at Salboni for about 5,000 acres was on. Bengal's atmosphere right from the middle of 2006 to almost middle of 2008 was charged with high decibel uproar for industrialization. And as a result hundreds of acres of land in different parts of the state were looted by the state govt. and other industrial houses. The media, the central and LF Govts. were advocating that for development of the country, employment generation we have to switch over from agriculture to industry and SEZ is the best solution. As for Salboni, the CM announced that Jindals would set up India's largest steel plant there. Even amidst tremendous resistance of the people at Singur and Nandigram against land grabbing or plans to do so, the govt. was silently performing the task at Salboni. The people of Medinipur by swallowing the govt's publicity, were not very unnaturally dreaming of having a big steel plant and transformation of the poor-dry area into a busy industrial belt. Lands of Salboni being mostly vested-barren or single-crop and tribal or low caste people illiterate and poor, resistance against land acquisition for Jindal was almost nil there. After totally driven out of Nandigram and also in October 2008 from Singur,

the WB Govt. was trying to come out of the utter darkness and before Lok Sabha 2009 to project themselves as harbingers of industrial developments. So even when nothing of industrial infrastructure was built up at Salboni (till now there is no structure) on Nov.2, 2008 the CM along with over half a dozen central and state ministers came to unveil the JSW Steel Plant. But unveiling of a small skeleton structure was not enough for the CM because by then it has become clear that Jindal and the govt. have some dubious plans for setting up a SEZ there and not a normal steel plant. Even more than that the CPM Govt. has no such earnest intention that there would be any kind of industry or small SEZ except underhand dealings and siphoning of crores of rupees into party fund from public exchequer and companies. For serving many purposes at the same time the CPM was in search of some convincing excuse and weapon. The UPA Govt. (past and present) also having some common agenda later on joined hands with them. First, it is already stated that the CPM (the *Manuwadi* marxists) had never any real intention to develop the under-developed districts with industry or other infrastructure. But they have to show to the hungry and unemployed voters that they are all for development. So they started mine blast incident. Pointing at the blast they started roaring: "Look we are planning to develop the state and the backward areas but the unruly opposition and Maoists are against all our good activities". Following the blast the police started torturing the poor tribals from the very next day even at a distance of 35 kms from the blast site. The low caste people of all the adjoining areas of the three districts formed Peoples' Committee against police atrocities and demanded that the then SP of West Medinipur had to beg pardon before them for undue atrocities. But the arrogant state administration continued to kill them allowing the situation to deteriorate till Lok Sabha election in May 2009. Police boycott was continuing in 4- blocks for more than six months and taking that opportunity the Maoists entered through the back-door and started mobilizing their plans. The rein of resistance movement of the low caste people gradually went over to the Maoists and joint police operation began from June 18, 2009. The joint paramilitary operation has been going on for the last more than nine months and the latest phase is nicknamed as "Operation Green Hunt" — spreading across the borders of Orissa, Jharkhand and Bihar. Secondly, during Nandigram movement in 2007 the peoples resistance

was showing signs of a newer kind of political alliance in the state but effectively that was checked by the Brahminical media in favour of TMC. Here in Lalgarth and Jangalmahal the tribals and backward class people started agitating against the frauds and torture of the CPM/LF. Social and political polarization along caste line was gaining ground. But that is fully against the interests of CPM or LF (polished Brahminical forces under the control of 3 upper castes - Brahmin, Kayasth and Baidyas). To dismiss that kind of political movement or uprising the CPM Govt. deployed para military forces there. To crush the undernourished people all kinds of tortures have been going on. The third ground for prolonged para-military operation is in the interest of both CPM and Central UPA Govt. It has got no doubt link with the all-out war against Maoists in the whole of middle India. Selling of mineral rich areas to several industrialists, setting up of SEZ in number of places — all these are being resisted by the local tribal people and Maoists. For smooth and hazardless operation of selling out the country the tribals and the Maoists are to be crushed. The fourth game plan is that of CPM only. In the last Lok Sabha elections of 2009 the LF lost in about 195 seats out of total 294 seats — that is, even if that trend goes on till 2011 Assembly election, they will lose the 35-year-old empire. Unparalleled in the history of post-independent Indian politics for totalitarian rule, corruption breeding, cruelty, frauds, upper caste hegemony — these communists of Bengal even after sucking and pauperizing the state for marathon 35 years are not in a mood to get out of the Writers Buildings. They are manouvering all kinds of possibilities (howsoever inhuman that be) to manage at least 150 seats (clear majority is 148) for them. And if that fails the second option of capturing at least 120-125 seats is there with channel open for alliance with Congress with around 40 seats. There are so many Congress leaders in Bengal who feel always attracted to CPM. But for the pressure of the people and Congress high command they avoid hobnobbing with CPM. Even if the TMC and Congress alliance win majority in 2011 election — the prolonged cohabitation of Cong. leaders with CPM may break down the tie-up in post election scenario. By keeping the paramilitary forces (fully under the control of state police) till at least 2011 election the CPM is planning to capture about 13-15 seats in the Jangalmahal. Under security of paramilitary forces the CPM *harmads* (armed *goondas* - who ironically are all damn poor SC or Muslims) have been torturing

and terrorizing the voters in the region. Another 15-20 seats on the fringe area of Jangalmahal, the CPM is expecting with reign of *harmads* under emasculated state administration. So all these may make up their tally to around 120-130 (if not 150) and rest may be fulfilled by the Congress. And if they are able to muddle the Congress-TMC pre-election alliance, their hardship will be much less. In addition to all these political game plans, the Maoists philosophy of armed revolution has made the situation all the more miserable. Lawlessness, regular killings of poor low caste people, non-existence of many things — education, transport, water, food, work, business transaction — have become normal way of life there. Maoists are resorting to the stark poverty of the tribals for furthering their aim and on the other hand the ruling govts. taking it as law and order problem have been deploying hundreds and thousands of para military personnels to curb the terrorism. Stoic philosophy of languishing in primitive religious cults and fanning of such kind of stupefying religious rituals by state machineries or other organizations and apathy of ruling class towards development of the poor areas since independence — are the principal factors behind the insurgency in various forms. Clear diagnosis and forecast by Dr. Ambedkar in Nov. 1949 may be aptly quoted here to explain the crisis:

On 26th January, 1950 we are going to enter into a life of contradictions. In politics we will have equality and in social and economic life we will have inequality... If we continue to deny it for long, we will do so only by putting our political democracy in peril. We must remove this contradiction at the earliest possible moment or else those who suffer from inequality will blow up the structure of political democracy which this Assembly has so laboriously built up.

Dr. M. Vasu, MD, Asso. Professor, Santhikonath Veedu, Pazhakutty PO, Nedumangad - 695 561: I am writing this after reading Adv. Hamid Vaduthala's Letter in DV (April 1, 2010). I also try my level best to increase the DV circulation, at least in my Trivandrum district by paying the subscription fee from my own pocket which most of the time I will not get back. Still I am trying. Hamid Vaduthala's desire to have a Malayalam DV gives me pleasure because I also dream such a venture. Dr. K. Jamanadas, Shalimar, Main Road, Chandrapur - 442 402: I could not understand the rationale of the debate on Jews and the "Jews of India" but I like to read Kautilya's book again. But these days, I am trying to correlate all international news with the Zionist *Arthashtra* and may be it makes sense. But then why Dr. Ambedkar or for that matter even Gandhi or any Indian leader did not talk of "Elders of Zion? Writings of Karl Marx — are they colored by his being a Jew? Raju Thomas, Kottayam, Kerala (indigenouraju@yahoo.com): A seminar was held at Vaikom Municipal Town Hall on March 27, 2010 on the famous "Vaikom Satyagraha" and Punnoose Mathen and I participated. Dalit Bandhu N.K. Jose presented a paper. So also the former Vice-Chancellor of Calicut University, Dr.K.K.N. Kuruppu (a *shudra* Nair from Kerala), a Dalit Activist K.M. Salim Kumar and Adv. P.K. Harikumar (another *shudra* Nair and a Marxist but RSS). The seminar was inaugurated by the Kerala State Assembly Speaker, K. Radhakrishnan, a Pulaya-Dalit-Marxist, and was presided by another Pulaya Dalit MLA of Vaikom. I have never heard any communist Dalit in the whole of Kerala in the way these two Dalits spoke in the exact language of *Dalit Voice*. Speaker K. Radhakrishnan said nowadays even parents of our students ask why should our children know the past history. Why should we teach the children the past history which is useless. Radhakrishnan was bold enough to say that there was a time that the majority *avarana* people in Kerala were not allowed to walk on the public roads but the animals could use the same roads near the Vaikom temple. The Dalits, mainly the Pulayas, and the OBCs, mainly the Ezhavas, were not allowed to walk on the

public roads. Even M.K. Gandhi had come to Vaikom to involve in the Vaikom Satyagrah but the poor fellow, instead of coming to the venue, straight away went to the Brahmins to convince them to allow the *avarna* people to walk on the roads but he failed. The Brahmins told Gandhi that it was because of the *karma* they were born as *avarnas* and hence no right to walk on the public roads. He said that through several struggles the *avarna* made some gains but all those gains are going to be defeated by the fascist forces. K. Ajit, MLA, challenged all those "bogus historians" who constantly propagate that Vaikom Satyagraha was a struggle of the *avarna* non-Hindu people to enter the Hinglu temple at Vaikom. Never. From my own Gujarati language, I find many important writers and poets missing just because they do not belong to the camp. The missing ones are the most militant and committed pens Gujarati Dalit literature can boast of — Joseph Macwan, Sahil Parmar, Raju Solanki, Shankar Painter, Chandu Maheriya, Yashvant Vaghela, Shamat Parmar, Tikesh Makwana, Purushottam Jadav, Jayant Parmar, Babaldas Chavda, Chandrika Shrimali, Jasumati Patel, Neerav Patel just to name a few glaring omissions. The *babus* with their money and influence have captured the literary scene in Gujarat and that does not augur well for the future of the movement of Dalit literature. I am afraid this could be the case even in other languages as well. Others can shed light in their respective tongues. In any case I will write its review for DV. And I will touch on its content - quality of literature and quality of translations.

Hindus exhibit their racist caste face even in UK

DEAN NELSON, NEW DELHI

A House of Lords Bill has been welcomed by Dalits, (Untouchables) who suffer extreme violence and persecution, but has been rejected by the Indian Govt.

Over 250 million Dalits are denied water, access to schools, and in some cases right to pass through villages by Hindus. Some Dalits still work as scavengers transporting human waste from latrines.

A report by the anti-Caste Discrimination Alliance, surveyed 300 British Asians and cited cases of children being bullied at school, bus inspectors refusing to work with lower caste drivers, and employees being sacked after their bosses discovered their caste status. Until now victims of caste apartheid in Britain had no recourse to law. India has a name-sake law but it is fiercely opposed to any comparison with racism.

Caste and race discrimination are two separate issues and there is no case to equate the two. We are opposed to attempts at international fora to equate the issues, an Indian official said.

The Equity Bill will now face final consideration by the House of Commons prior to receiving royal assent. It is expected to become law before the general election expected in early May.

The amendments suggested by the House of Lords on April 6 included a power to outlaw discrimination on the basis of caste; a ban on asking for health and disability information prior to making a job offer; and removing the ban on civil partnership ceremonies taking place in religious premises. There has been mounting evidence of the prevalence of caste-based discrimination among people with origins in the Indian subcontinent.

Keith Porteous Wood, Executive Director of the National Secular Society, said: "The blight of caste discrimination, under which millions in India are regarded as 'Untouchable', has spread to this country virtually unnoticed." In November 2009, research conducted in the universities of Manchester, Hertfordshire and Manchester Metropolitan University said tens of thousands of people with origins in the Indian sub-continent faced caste discrimination in Britain.

The new study, whose main conclusion is that there is considerable evidence of caste-based discrimination

among the Asians in Britain, was coordinated by the Anti-Caste Discrimination Alliance and included academics from three universities.

The report, titled "Voice of the Community — A Study into Caste and Caste Discrimination in the UK", says that the caste system is widespread and that it affects tens of thousands of people in the workplace, the classroom and even the doctor's surgery.

The study says: "There is clear evidence from the survey and the focus groups that the caste system has been imported into the UK with the Asian diaspora and that the associated caste discrimination affects citizens in ways beyond personal choices and social interaction. "There is a danger that if the UK Govt. does not effectively accept and deal with the issue of caste discrimination the problem will grow unchecked." ■

Hindu terrorists to set up Israel-based govt.

Bangalore: The Maharashtra Police have detected that the powerful Chitpavan Brahmin-led *Abhinav Bharat* (AB) terrorist force is proposing its headquarters in Zionist Israel.

The Maharashtra Anti-Terrorism Squad (ATS) chargesheet in the Malegaon blast case claims that as per statements from the accused the town was singled out for the blast as "it was the ideal place where the Muslim community crowd was the maximum" and that prime accused Lt. Col. Prasad Purohit had told fellow conspirators it was time to set up a parallel Hindu Govt. in-exile which could operate out of Israel and ensure a completely *sashastra* (armed) India. Purohit, according to the 4,528-page chargesheet, promised "all logistic help" with finances from several quarters and support from some of his contacts in Thailand.

But the entire govt., both central and state, are silent on the AB terrorist activities including its involvement in the terrorist attack (26/11) on Bombay disclosed in the book, *Who Killed Karkare?*, by S.M. Mushrif.

The govt. itself is afraid of the AB because all the culprits being Brahmins are above the govt.

The Zionist Israeli connection revealed in the ATS report is yet another proof that strengthens DV theory that the Jews and "Jews of India" are cousins. ■

Zardari bent upon destroying Pak at the behest of Brahminists

Every time the bogus Afghan President in dressing gown visits Pakistan, the people become very apprehensive. Who does this fellow — Karzai — represent? Not Afghans. Who does he work for? Not Afghanistan. He will be on the first plane out of Afghanistan when the US withdrawal, if it is disorderly, begins. Why is President Zardari so eager to please him? Does he want to secure a seat on the same plane? But it does not matter what either of them wants because the people of Pakistan see Zardari's role to be to frustrate every effort to safeguard Pakistan's national interests and to advance India's agenda.

SOVIET DEFEAT

Pakistan's military has with some consistency argued that the Americans can make a dignified withdrawal from Afghanistan only if Pakistan helps. Generals Petraeus and MacChrystal now agree with General Kiani and they are writing a narrative which makes that possible. But "Hindu India" is very upset and is acting the role of a spoiler. Even in its 'strategic partnership' with erstwhile USSR, all the damage was suffered by the Soviet Union while India walked away un-blamed from the disastrous Soviet exit from Afghanistan.

ZARDARI KILLING PAKISTAN

Typical of its past conduct, Hindu India wants the US to dig in and 'tough it out' but is not ready to send fighting formations to Afghanistan. India needs the US presence to continue its support to the Baloch and TTP terrorists. That is all it cares about.

It is clear what India wants, whereas Pakistan is working with the Americans to bring a negotiated settlement in Afghanistan. But what do Zardari and Prime Minister Geelani want? Geelani, typically, usually does not know what he wants, drags his feet for a while to make public show of defiance, and then submits to the wish of Zardari.

SECURITY COUNCIL SEAT

This 'Punch and Judy show' has been mildly amusing when it comes to 'minor matters' like load shedding that has blighted the industry; like precipitous decline in the value of rupee, declining exports and rising imports; like stealing of billions from public sector corporations by Zardari-appointed kleptomaniacs in charge. But it is in foreign policy that the most damage — largely irreversible — is being done to Pakistan's national interests.

Zardari and Geelani do not even understand the question on policy matters let alone provide answers or give guidance. The military was able to sideline India over Afghanistan because its role is that of a spoiler.

But Karzai promptly turned up in Islamabad to secure endorsement of an Indian role in Afghanistan.

Not just that, the Punch and Judy 'duo' are prepared to facilitate the Indian role. They have privately told India that they will not oppose India getting a permanent seat in the UN Security Council. Until now, Pakistan had not just objected but mobilised opposition to a seat for India until 'it implements the UN Security Council Resolutions on Kashmir.' Who are these people?

Who is the 'duo' working for? Clearly it is for India.

As if that was not bad enough the Minister of Railway, one Billor from ANP — protégés of India of long standing — has said that he is going to move a resolution in the parliament to allow SAARC to be connected by rail with Central Asia through Afghanistan. Thankfully, the insurrection in FATA makes that impossible, but the readiness of the ruling coalition parties in Pakistan, all of who are pro-India, to allow Indian vehicles through passage into Pakistan, Afghanistan and beyond, is mind boggling. Has India decided to hold a plebiscite in Kashmir? Has India decided not to build dams on Rivers Chenab, Jhelum and Indus in Jammu and Kashmir? What has India done to deserve so many favours from the 'duo'? It just could not be pressure from the USA not to defend Pakistan against military or water aggression by India! That is of long standing; that is not a change.

BREAK-UP OF PAK

I am reminded of a research paper by 'Global Research' of Toronto, Canada, which was printed in *LISA Journal* two years ago. In this paper Professor Michel Chossudovsky stated that the objective (from 2008 Elections in Pakistan) of the USA is: 1) to install a government in Pakistan that does not care about national interests, and 2) which allows Pakistan to suffer the fate of Yugoslavia under pressure from a demand for "Provincial Autonomy". It appears that Zardari is under pressure to deliver. He has to deliver on 1) 'economic collapse', 2) breakdown of law and order, and 3)

'Provincial Autonomy' that propel Pakistan towards chaos and disintegration. Zardari has made sure that energy crisis is exacerbated by the day leading to fall in industrial production and exports and ballooning balance of payment deficit. It has to be deliberate because solution to the energy crisis was simple. All that was needed was to address the issue of 'circular' debt; restart closed down thermal power plants; provide electricity without load shedding; provide gas to industry and power plants; carry out load shedding of gas to domestic users for as much as 20 hours a day providing gas only for two hours in the morning and two hours in the evening. It is not rocket science and yet it is not being done. The sabotage of industry is indeed deliberate and Zardari-Geelani Administration is culpable.

KARZAI PLEADING FOR INDIA

The Government has not deployed the arguments that al-Qaeda and TTP are *Takfiri*, like the *Khawarji* before them, they are the instruments of *kufr*. On the contrary, the Government has allowed JI, JUI, and TI to decry Pakistan as the agents of *kufr* i.e. America. The law and order minister — Rehman Malik — does look and behave like the agent of *kufr* thus giving some credibility to the *Takfiri* argument. But the real test of Zardari-Geelani Administration would come perhaps this month when a consensus on constitutional amendments at Committee Stage would come before the parliament. That would show if the MQM-ANP view of provincial autonomy has been accommodated. If it is, Pakistan would be ready to follow the example of Yugoslavia. However, it is unclear yet if the Obama Administration has indeed changed its policy on Pakistan and Afghanistan and is ready to give non-military measures a chance

with a view to stay in Afghanistan and have some influence over Central Asia. But it is quite clear that India wants the ISAF to keep fighting in Afghanistan so that India can continue to use its soil for clandestine operations against Pakistan.

INDIAN P.M. VISIT TO SAUDI ARABIA

It was not just Hamid Karzai who is pleading India's case, Prime Minister Manmohan Singh tried to outflank Pakistan and warm up towards Saudi Arabia. The objectives of India are not mysterious. India plays its card of 150 million Muslims in that country very skilfully but has not been confronted with the cries of anguish that India keeps muted by portraying the Muslims as terrorists and thus successfully terrorising them into submitting to structural unemployment, alienation, repression and social decline. India may want to buy oil from Saudi Arabia which is no bad thing.

FOOLISH ARABS

But India wants to pay for it by Saudi investment in India. No one has made money by investing in India — not even America. Indian companies like Tata and Mittal Steel have become big in UK and Europe by transferring their capital outside. It would be very foolish Arab who saw investment in India to be secure

let alone lucrative. But the effort to lure the Arab capital to India is being led by Jewish banks in the USA because decline in economic prospects of North America has made every investor wary of investment in the USA. The Arabs have better beware; the trap is being set by the experts — the Jews.

KASHMIR

The most pressing problems of Pakistan spring from the Zardari-Geelani administration being unwilling as well as unable to safeguard Pakistan's interests. They are on probation and the people are watching how they deal with India over Afghanistan, Kashmir and the issue of water of river flowing into Pakistan from Kashmir. Militarily, India is not a bigger problem than what Pakistan has faced and defeated in FATA and NWFP. After all, India is not stronger than the USA and the Kashmiris are not as friendless as the resistance in Afghanistan. Those who say there is no military solution to the problem of River water and Kashmir should look at the example set by the USA. When your national interests are at stake, be ready to fight. If you are not, the enemy would not be softened by flattery, concessions or begging.

The dark face of Jewish nationalism

March 19, 2010 "Redress" - Israeli Prime Minister Binyamin Netanyahu once remarked to a Likud gathering that "Israel is not like other countries". Oddly enough for him, that time he was telling the truth, and nowhere is that more evident than with Jewish nationalism, whether or not one pins the "Zionist" label on it.

Nationalism in most countries and cultures can have both positive and negative aspects, unifying a people and sometimes leading them against their neighbours. Extremism can emerge, and often has, at least in part in almost every nationalist/independence movement I can recall (e.g. the French nationalist movement had The Terror, Kenya had the Mau Mau, etc.).

JEW HATE NON-JEW

But extremism in other nationalist movements is an aberration, extremism in Jewish nationalism is the norm, pitting Zionist Jews (secular or observant) against the goyim (everyone else), who are either possible predator or certain prey, if not both sequentially. But it does mean that Israel today is what it cannot avoid being, and what it would be under any electable government.

The differences between Jewish

nationalism (Zionism) and that of other countries and cultures here I think are fourfold:

1. Zionism is a real witches' brew of xenophobia, racism, ultra-nationalism and militarism that places it way outside of a "mere" nationalist context — for example, when I was in Ireland (both parts) I saw no indication whatsoever that the Provisional Irish Republican Army or anyone else pressing for a united Ireland had a shred of design on shoving Protestants into camps or out of the country, although there may well have been a handful who thought that way — and goes far beyond the misery for others professed by the Nazis;

2. Zionism undermines civic loyalty among its adherents in other countries in a way that other nationalist movements (and even ultra-nationalist movements like Nazism) did not — e.g. a large majority of American Jews, including those who are not openly dual citizens, espouse a form of political bigamy called "dual loyalty" (to Israel and the US) that is every bit as dishonest as marital bigamy, attempts to finesse the precedence they give to Israel over the US (lots of Rahm Emanuels out there who served in the Israeli army but NOT in the US armed forces), and has

absolutely no parallel in the sense of national or cultural identity espoused by any other definable ethnic or racial group in America — even the Nazi Bund in the US disappeared once Germany and the US went to war, with almost all of its members volunteering for the US armed forces;

UNIQUE IN THE WORLD

3. The "enemy" of normal nationalist movements is the occupying power and perhaps its allies, and once independence is achieved, normal relations with the occupying power are truly the norm, but for Zionism almost everyone out there is an actual or potential enemy, differing only in proximity and placement on its very long list of enemies (which is now America's target list); and

4. Almost all nationalist movements (including the irredentist and secessionist variants) intend to create an independent state from a population in place or to reunite a separated people (like the Sudeten Germans in the 1930s) — it is very rare for it to include the wholesale displacement of another indigenous population, which is far more common of successful colonialist movements as in the US — and perhaps a reason why most

Americans wouldn't care too much about what the Israelis are doing to the Palestinians even if they DID know about it, is because that is no different than what Europeans in North America did to the Indians/Native Americans here in a longer and more low-tech fashion.

The implications of this for Middle East peace prospects, and for other countries in thrall to their domestic Jewish lobbies or not, are chilling. The Book of *Deuteronomy* come to life in a state with a nuclear arsenal

would be enough to give pause to anyone not bought or bribed into submission — which these days encompasses the US government, given Israel's affinity for throwing crap into the face of the Obama administration and Obama's visible affinity for accepting it with a smile, Bibi Netanyahu's own "Uncle Tom" come to Washington.

The late General Moshe Dayan, who — Zionist or not — remains an honoured part of my own Pantheon of military heroes, allegedly observed that Israel's security depended on its

being viewed by others as a mad dog. He may have been correct. But he neglected to note that the preferred response of everyone else is to kill that mad dog before it can decide to go berserk and bite. It is an option worth considering.
