THE MENACE OF HINDU FASCISM

Says the three "eminent" Congress leaders — Lal, Bal, Pal — engineered partition of India. Hindu terrorist Savarkar's call to "Hinduise politics and militarise Hinduism" inflicted so much violence on Muslims.

Even Swami Vivekananda said "Islam was a great blessing and liberated the oppressed". Upper castes partitioned Bengal. Gandhi was a cunning fox" and "a Hindu revivalist".

"Babri Masjid" was a Hindu conspiracy. Muslims are too poor to be polygamous but Bengali Brahmins were polygamous.

Though an upper caste Hindu (Kayasth), Deb is very critical of Gandhi, Nehru, and all the Bengali upper castes. On the Babri Masjid, he says it was a Brahmin-instigated conspiracy as old as 1885. He quotes L.K. Advani, the villain who demolished the Masjid: "The Congress wanted the demolition and they had it done by us".

When Veda was not a book of authority :

THUS SPAKE AMBEDKAR

Thus Spake Ambedkar

"If authorities of equal force are conflicting, (either may be followed at) pleasure" I-4

the *Vashishta Dharma Sutra* propounds the following view:

"The sacred law has been settled by the revealed texts i.e. Vedas and by the tradition of the sages" I-4.

"On the failure of (rules given in) these (two sources) the practice of *Shishtas* (has) authority". I-5.

The views of Baudhayana are given below:

Prasna I, Adhyaya I, Kandika I.

(1) The sacred law is taught in each Veda.

(2) We will explain (it) in accordance with that.

(3) (The sacred law), taught in the tradition (*smriti*) stands second.

(4) The practice of the *Sishtas* (stands) third.

(5) On failure of them an Assembly consisting at least of ten members (shall decide disputed points of law).

The view taken by the *Apastamba Dharma Sutra* is clear from the following extract from that Sutra:

"Now, therefore, we will declare the acts productive of merit which form part of the customs of daily life" I-1.

"The authority (for these duties) is the agreement (*samaya*) of those who know the law" I-2.

"And (the authorities for the latter are) the Vedas alone" I-3.

With regard to the *shistas* both the *Bashishtha Dharma Sutra* and also the *Baudhayana Dharma Sutra* have taken particular care to define who can be regarded as *Shishtas*.

The *Vashishta Dharma Sutra* says:

"He whose heart is free from desire (is called) a *Shishta*". I-6.

Baudhayana goes into much greater details about the qualification of the *Shishtas*. This is what he says:

"5. *Shishtas*, forsooth, (are those) who are free from envy, free from pride, contented with a store of grain sufficient for ten days, free from covetousness, and free from hypocrisy, arrogance, greed, perplexity and anger".

"6. Those are called *Shishtas* who, in accordance with the sacred law, have studied the Veda together with its

appendages, know how to draw inferences from that (and are able to adduce proofs perceptible by the sense from the revealed texts."

Baudhayana has also something very interesting to say about the assembly whom he authorities to decide. The following are his views on the matter:

"8. Now they quote also (the following verses): "Four men, who each know one of the four Vedas, a *Mimansaka*, one who knows the Angas, one who recites (the works on) the sacred law, and three Brahmanas belonging to (three different) orders, constitute an assembly consisting at least of ten members".

"9. There may be five, or there may be three, or there may be one blameless man, who decides (questions regarding) the sacred law. But a thousand fools (can) not do it".

"As an elephant made of wood, as an antelope made of leather such an unlearned Brahmana; those three having nothing but the name (of their kind)".

This review of *Dharma Sutras* shows that the (1) Veda, (2) Tradition (*Smriti*), (3) Practice of *shishta* and (4) Agreement in an assembly were the four different authorities which were required to be referred to in the decision of an issue which was in controversy. It also shows that there was a time when the Vedas were not the sole infallible authorities. That was the time represented by the *Dharma Sutras* of *Vashishta* and *Baudhayana*. *Apastambha* does not invest the Vedas with any authority at all. Knowledge of Vedas is made by him as an electoral qualification for membership of the Assembly whose agreed decision is the law and the only law.

The Veda was not at all regarded as a book of authority and when the only recognized source of authority was an agreement arrived at in an Assembly of the learned.

It is only in the time of Gautama that the Vedas came to be regarded as the only authority. There was a time when an agreed decision of the Assembly was admitted as one source of authority. That is the period represented by *Baudhayana*.

This conclusion is reinforced by the following quotations from the *Satapatha Brahmana*. It says:

How did Dr. Ambedkar's prophecy of Bahujans "blowing up" constitution go wrong ?

Dr. Babasaheb Ambedkar while concluding his marathon historic speech presenting the draft constitution of India to the Constituent Assembly (1949) had made a historic prophecy which is very often quoted.

This prophecy made by the "Father of India" is the subject of this Editorial. He said:

"On the 26th of January 1950, we are going to enter into a life of contradictions. In politics we will have equality and in social and economic life we will have inequality. In politics we will be recognizing the principle of one man one vote and one vote one value. In our social and economic life, we shall, by reason of our social and economic structure, continue to deny the principle of one man one value. How long shall we continue to live this life of contradictions? How long shall we continue to deny equality in our social and economic life? If we continue to deny it for long, we will do so only by putting our political democracy in peril. We must remove this contradiction at the earliest possible moment or else **those who suffer from inequality will blow up the structure of political democracy** which this Assembly has so laboriously built up".

(*Dr. Babasaheb Ambedkar: Writings & Speeches*, Vol.13, p.1216).

This famous speech made 64 years ago deals mainly with the social contradictions for which Brahminism, disguising as Hinduism, is so famous. Babasaheb spoke the truth on this contradictions with which nobody then disagreed in the august hall in Parliament House.

Will Kashmir lead to war with China ?

leaders like Jawaharlal Nehru, Rajendra Prasad, T.T. Krishnamachari, H.V. Kamath, etc.

Babasaheb expressed his grave fears about India retaining its independence because as a student of history he knew how it was ruled by the British and earlier by Muslims etc.

Hindu rulers invited foreigners: How did India lose its independence so often? He said:

"What perturbs me greatly is the fact that not only India has once lost her independence, but she lost it by the infidelity and treachery of some of her own people". (Dr. Ambedkar Writings & Speeches, p.1214).

He said the foreigners were invited by Hindu rulers like Jai Chand. When Shivaji was fighting for the liberation of Hindus, the other Maratha rulers and Rajput kings were fighting on the side of Moghuls. Gulab Singh helped the British in their war against Sikhs. In 1857 when the war of independence was raging, the Sikhs were silent spectators, he said expressing the fear:

"Will history repeat itself?" Will the Hindus place creed above the country?

He also expressed the fear that the hard won democracy was giving place to dictatorship.

Havoc of Hindu bhakti: He also expressed the fear that when a constitution was in place, would the rulers resort to unconstitutional methods.

He also expressed the fear that the Hindu bhakti, hero worship, will enter politics and predicted:

"... In politics, *bhakti* or hero worship is a sure road to degradation and even dictatorship." (p.1216).

After saying all these the "Father of India" comes to the most important warning and concludes with a prophetic utterance and also what would happen to India if his warning was not heeded.

This prophecy is fully quoted on p.3.

Did the oppressed masses revolt: Our question is: Did those who suffer from inequality "blow up the structure of political democracy?"

No.

Even 64 years after Babasaheb's prophecy, the oppressed Bahujans, denied food, clothing, shelter, education, health — on the top of that kicked, killed, burnt, raped and their little property destroyed and form over 50% of the country's 1,300 million population — did they get angry and "blow up the structure of political

democracy", as Babasaheb predicted?

No.

Babasaheb's prophecy went wrong. Why?

Sunset on the Dalit world: Alright. Was there any discussion, debate, or heart-searching over how the "Father of India" erred? What is the role of his children in making the prophecy go wrong? In the year 2000, as the Millennium was ending and the country was entering a new century, we wrote our Editorial: "Sunset on the Dalit World". And suggested a "conclave of 100 Best Brains". Sorry. None responded.

Between 1950 and 2010, already 60 years are over, much water has flown down the bridge. At least four generations of "educated" Dalits have passed. If this is the picture on one side, the other side is shocking poverty.

Who is sucking our blood: At least 50% of the Bahujans (SC/ST/BCs and Muslim/Christian/Sikhs) are so poor, so unconscious; so unthinking that they do not even know who is sucking their blood.

Morning to night they are busy trying to fill their belly. Besides, poverty and illiteracy, they are steeped in superstition as well. And kept divided in their villages by the Hindu caste system.

Why villages are peaceful: That is how the Indian villages are so peaceful. The upper caste landed gentry act as the police plus judge.

The rest of the Bahujans, about 30% having migrated to urban areas lost their caste consciousness and got merged in the urban anonymity — busy working from morning to night. At least they get stomach-full of food which the other 50% can't even think of.

Educated lot join enemy camp: Yes. At least this 30% of the Bahujans who migrated to urban areas could have thought of the "blowing up structures of political democracy" if only Babasaheb's children, educated in his burning thoughts, had prepared their minds, hit back and taken the road to revolution.

The Ambedkarites, Buddhists and all those who today parade in the name of Babasaheb failed.

They failed because they betrayed Babasaheb and crossed over into the enemy camp of the Hindus.

And this is how Babasaheb's prophecy failed.

Dalits hinduised: After Babasaheb made the above prophecy, he quickly realised that if his prophecy had to come true he should present to

his children a philosophy which he gave in the form of Buddhism. Here too, there was a setback. Soon he was killed by a Hindu conspiracy hatched by his own Brahmin wife. (DV Nov.16, 2009, p.20: "Who killed the prophet of new India? Brahmin second wife & her boy friend caused the death, says secretary"). Once he died, his followers quarrelled between themselves and Buddhism itself was perverted and swallowed by Hinduism.

Babasaheb did not realise that the cunning Hindu rulers would scuttle his mission through job reservation to SC/ST which helped convert them into good Hindus. The Hindu rulers could easily *hinduise* the anti-Hindu SC/STs. Yes they did it with a vengeance.

The job reservation also helped the Brahminical enemies to divide the SC/STs. Only the educated micro-minority Dalits got jobs and the rest left behind to rot. And these Dalits who got the jobs became good Hindus — and slaves.

IAS/IPS not interested in DV: When the educated Dalits got jobs (only petty jobs were given) they were also *hinduised* (enslaved) and Buddhism, which was already captured by the corrupt, helped the Hindus to further enslave them. *Vipassana* speeded up the enslavement drive.

Today, we hardly find any IAS/IPS or other top officials among SC/STs as members of Dalit Voice for fear of offending the Brahmins.

DV dying: That is how Dalit movement died. Brahminism killed it.

That is how *Dalit Voice* — the only voice of the Dalit-Bahujans, is also dying.

Babasaheb is remembered only on his birth anniversary.

Buddhism has lost all its revolutionary character outlined by Babasaheb in his magnum opus, *Buddha & His Dhamma*.

The country's most explosive commodity, the SC/STs, have been *hinduised*. And instigated against OBCs and BCs dubbing them enemies. Brothers fighting the brothers.

At the same time SC/ST/BCs are so much *hinduised* that they can be readily made run at the throat of Muslims and Christians.

Meaning of Hinduism: The Hindu job is over. By this process the over 85% of India is enslaved and made to rot. This is the meaning of Hinduism.

India does not belong to the Brahminist foreigners. But the Bahujan children of the soil do not know what they are doing.

In the process the country itself is dying. But the educated "middle class" (read upper castes) live in its own fool's paradise mesmerised by the media magic — painting the picture of "India Shining", "India booming".

Babasaheb weeping in his grave: Babasaheb Ambedkar is silently weeping in his Dadar Chowpatty grave. He is weeping because his prophecy that "those who suffer from inequality will blow up the structure of political democracy" has gone wrong.

But who cares?

The Hindu rulers killed India itself.

Did not our "educated" Dalits help the Hindus to kill India — built so laboriously by Babasaheb?

"CLOSING DOWN DV" — A DEBATE

With DV dying & Bahujan elite indifferent, what will be our future ?

With regard to "Closing down DV", I should say only this much: "No mother ever decides to kill her own child". Can you kill DV to which you alone gave birth? Can you disown your own child, next only to Salil, now the Secretary-General of Amnesty Int. in London?

I know you are facing serious crisis. You do not have a trustworthy lieutenant to carry out the mission which Babasaheb has entrusted you.

MOST FAITHFUL SON OF BABASAHEB

We can never find a better son of India other than Babasaheb Ambedkar and it is your privilege and a blessing to be his child.

In the history of India you alone will be for ever remembered by the enemy of the children of India. The enemy has recorded your name in their CPU.

MYSTERY OF THE MASTER KEY

A few words on the Editorial on "Mystery of the Master key" (DV Edit Aug.1, 2010).

My basic question is: Did Babasaheb ever write on a "cultural revolution" as a pre-requisite to the political revolution?

After China went communist, the Father of the "Chinese nation" Mao Tse-tung launched the historic revolution to destroy all the values, practises, manners — the entire centuries-old rotten system. This came to be known in history as China's "Cultural Revolution" which included destruction of not only religion but politics and everything else. This is the meaning of "cultural revolution" which alone can destroy Brahminism. "Culture" includes religion — EDITOR.

Babasaheb was quoting several incidents from several countries beginning with the religious revolution started by Luther in England and he ended with Guru Nanak in India. How do we interpret social and religious revolution in India? Why you have added "cultural revolution" in the Editorial? "Cultural" is too a vague term under the Indian context. If we as honest children of Babasaheb carefully read and study all the volumes of Babasaheb we will definitely come to the conclusion that without destroying Brahminism (or call it Hinduism) nothing is possible in India.

He had the courage to speak out that to save India we must destroy Hinduism. (*Thus Spake Ambedkar*, Vol.2, pp.29-30).

How to destroy Hinduism? Is it possible through a cultural revolution? Never. Is it possible through a social revolution?

How do we understand or how do we interpret social revolution in India? Social revolution in the Indian context is nothing but religious revolution. But then what is religious revolution? What should be religious revolution in India?

Why our Dalit leaders are afraid of speaking about what is best for our people? Why they are afraid? Whom are they afraid of? Why do

they lack courage? Can these words purchase courage for a million dollar?

WORST CRIMINALS

Why you also do not speak about the conversion of our people for a better future? Babasaheb gave more importance to "religious conversion" than any other aspect. He showed it to his people while he was alive. Why our people are not following his footsteps?

All those who are the beneficiaries of reservation are the worst criminals. They are ungrateful to themselves. They are the enemies of our innocent and illiterate Dalits. They are selfish.

NO HOPE IN HINDUISM

After securing all constitutional rights and remedies why did Babasaheb undertake a "religious revolution" on Oct.14, 1956? Why did you get converted to Buddhism?

Read Vol.V (p.411 to 421). On p.412 Babasaheb clearly wrote that "in Hinduism there is no hope for the Untouchables". Why do our people still remain in Hinduism? Why do we run after political interest? Why our people are addicted to political crumbs? Why are they disobeying their Father?

RELIGIOUS REVOLUTION

History bears testimony that in human history even political revolution is preceded by religious revolution. After Budha, did India have any religious revolution? Had the great social revolutionary, Periyar E.V. Ramaswamy, undertaken a religious revolution of conversion that would have become a model for the whole country and by this time India's destiny would have been entirely different from what we are experiencing today.

DV Editorial of June 1, 2010: "Should we continue DV or not? Are we to die as slaves? Will family members decide", was a terrible tsunami that hit me and the other Bahujans of the Indian subcontinent.

Yes, we have become slaves since over 3,000 years of the alien Aryans (Brahmins). At the time of their intrusion into this subcontinent our ancestors were leading a civilized life (Indus Civilization) but the history said Brahmins were barbaric, nomadic tribes.

What "Closing down debate" revealed?

Too big a Debate has begun on "DV closing down" (Letters are pouring in) but too little money has come (total Rs.3.37 lakhs) which will melt away in 3-4 months.

The most important thing the Debate revealed is that each person is good at complaining against the other. With some minor exceptions, they have nothing to say on what they have done to liberate this society from the enemy oppressor, so clearly identified in DV.

COMPLAINT BOX

At different meetings and in our correspondence when we pin down a person and ask him what he has done to the community, he opens his complaint box. And makes us think that it is because of others that he could not do anything. Who can save such people?

(1) In the early years of DV we suggested formation of "DV members club" in each big town and city so that members can meet and discuss the hot issues raised in DV. We regret to inform that not one member bothered to heed our request.

(2) Then we called for state-wise DV silver jubilee celebrations. Only UP, Orissa,

Himachal, Punjab, AP, Karnataka and Delhi responded. The turn out was not impressive.

Gujarat gave a shock: not even five members turned up confirming wholesale hinduisation of our people.

(3) Our members (with minor exceptions) failed to bring their wives/daughters/mothers despite specific request that without women no Dalit movement can succeed. *Manuwadis* are male chauvinist pigs (MCP) but our people are no less.

(4) In AP, Mala members opposed Madiga demand for separate reservation quota which DV supported. Brothers fighting brothers divided the Dalit movement itself.

(5) Muslims hardly took interest in DV meetings — with minor exceptions. Then we asked reasons for Muslim boycott, we were told that some Dalits were with Hindu terrorist outfits despite telling that "Dalits are not Hindu and never Hindu".

(6) Each member of DV should think DV belongs to him/her and promote its sales/introduce subscribers/order our books. But this is not done.

(7) Some members complained against DV writings on foreign affairs. Our enemy oppressors will be too happy if the Bahujans

leave foreign affairs to Brahmins. In fact, only the three Brahminical parties Congress, BJP, CPM-CPI discuss foreign affairs. All Bahujan parties (BSP/DMK/RJD/Akali Dal/Telugu Desam etc.) just don't bother about foreign affairs — leaving the road free to the enemy.

S.N.D.T. UNIVERSITY MEETING IN BOMBAY

That doesn't mean we have no exceptionally devoted members. Yes. We have a good number of them but most of them are poor. It is only the poor who think in this country.

At a meeting in the SNTD Women's University, Bombay, upper caste women were so vocal in attacking the Editor. But the overwhelming Dalit DV members present never opened their mouth. Either they suffer from inferiority complex or afraid of the upper castes. In the presence of the Brahmin, they are so scared to open the mouth.

By reading DV and our books for the past 30 years, our members should have become tigers. But we are disappointed. Quite number of them read very seriously, order every DSA book. But we don't find any result after their reading. Are they reading for the sake of reading? — EDITOR.

Even being India's most literate, Kerala Dalits continue as slaves

Babasaheb Ambedkar's sweat benefited only the elite Dalits. They however forgot our Father, as you said several times. After Babasaheb there is no Dalit movement.

The cream of our community wants only position, money and luxury. The community is forgotten. The elite Dalits have fallen into the trap of Brahminism.

(1) Nair - 14.41%, (2) Ezhava - 22.91%, (3) Muslim - 24.73%, (4) OBC - 6.3%, (5) SC - 9.82%, (6) ST - 1.12%, (7) Dalit Christians - 3.35%.

See the pitiable condition of Kerala Dalits even though they are the most literate among India's Dalits. In all they constitute (SC/ST/Dalit Christians) about 14.30% which is equal to the population of Nairs. Even though Dalits are members in their sub-caste organizations like Pulaya/Cheramar, Paraya/Sambhava, Kurava/Sidhanar etc., at the time of elections they vote for UDF or LDF. If the all leaders abandon their ego and realise the truth, they can demolish the Brahminical ruling front. The Pulaya/Cheramar community itself can make wonders if they unite and vote like the Chamars of UP.

Dalits are evolving into something great. Palestinians are gradually taking over Israel. It's barely noticeable, but the CIA has predicted Israel will cease to exist in 20 years or so. Palestinians reproduce and work hard, while Jews don't appreciate that Israel was built by Palestinian labor.

You Dalits are taking over "Hindu India". You just can't see it.

I would recommend a Dalit revolt like in America. Rosa Parks wouldn't leave her place in the bus.

One day, Dalits should dress like Brahmins in the sacred thread in a public place like New Delhi, making a very public protest the world will see. Dalits should storm the temples and take the Vedas and Puranas and burn them in a sacred fire.

Thus Spake Periyar

If the sudra attacks a Brahmin with hands or with a stick the part affected should be noted and the sudra should be beaten severely at the same part of his body. His hand should be cut off, if he had used his hands. His legs should be cut off, if he had used his leg. (Chap.9.S.224,248).

If the sudra takes away anything belonging to the Brahmin he should be tortured and killed. (Chap.9.S.248).

If a sudra leaves his trade and seeks the trade of others, the king should confiscate his property and excommunicate him. (Chap.10.S.96).

If a non-Brahmin enjoys with a Brahmin wife, he should be punished till he breathes his last. (Chap.8.S.359).

If a sudra enjoys a Brahmin girl without protection, his male organ must be cut off. If he enjoys a Brahmin girl in a family, his body must be cut to pieces and his property should be confiscated. (Chap.8.S.374).

For eliciting truth and for taking a promise, the sudra should be made to hold a hot iron or be immersed under water. (Chap.8.S.114).

If the sudra's hands are not scorched, and if he does not die in the water then only the words of the sudra could be taken as true. (Chap.8.S.115).

A country where the sudras have no other work than being slaves, is the only right place where the Brahmin can live. (Chap.2.S.24).

A Brahmin should not live in a place where the sudra is ruling. A Brahmin should not live in a place near the abode of the Chandalas (Chap.4.S.61).

No right to the sudras:

A sudra should not be taught the sastras. Brahmin should not give food to anyone other than his disciples or followers. Offerings of the homa should not be given to any sudra. Brahmins should not go for performing rites or pooja to any one who boycotted the Brahmins. (Chap.4.S.80).

The dead body of the sudra should be taken by the south direction. The dead body of the Kshatriya

All punishment for sudra & respect for Brahmin

should go by north. The dead body of the Vaisya should go by the west. The dead body of the Brahmin should alone go by the east. (Chap.5.D.92).

Brahmin rule:

A king should receive preaches of the vedas and the sastras and all Brahmins. Every morning he must meet their demands and rule the country as dictated by the Brahmins. (Chap.7.S.37).

A country ruled by a king will be ruined, if the vedic scholars and the Brahmins are made to suffer for food. (Chap.7.S.134).

If a king does not rule the country as is stated in the Manu's code, (*varnasrama dharma*) the ministers and others should kill the king. (Chap.7.S.26).

A sudra should be suppressed by the Brahmin without minding the powers of the king. If the *varnadharma* is dishonoured by a king, the Brahmins should take up the weapons and fight. (Chap.8.S.348).

A country where a sudra administers justice, will undergo sufferings as a cow caught in the marshy pond. (Chap.8.S.21).

Share in the treasure:

If a king finds a treasure in his country he should first give half of the treasure to the Brahmins and take the other half only to his treasury. (Chap.8.S.38).

Hanging:

Punishment by hanging is not applicable to the Brahmins.

Instead of hanging, it is enough if his head is shaved. Others could be hanged. .. (Chap.8.S.379).

A Brahmin and a snake should not be heckled, even if weak in health. (Chap.4.S.135,136).

Even if the Brahmin commits a very serious offence, he should not be tortured or hung. He should be sent away with his belongings. (Chap.8.S.380).

Women:

Bed, seat, beauty, pregnancy, anger, lie, betrayal etc. were created only for the sake of women. (Chap.9.S.17). *(To be continued)*

"Khatri Sick" as India's worst & the weakest PM

Bangalore: For the first time even the world-famous *Economist* (Sept.4, 2010) owned by the Jews has criticised the "Jews of India" and their "Khatri Sick" PM who has messed up the whole country in his love to please the Brahminical rulers.

India pushed below poorest parts of Africa

New Delhi: India's meeting the Millennium Development Goals (MDGs) by 2015 seems unlikely with around 77% of its people still below poverty line when the poverty bench mark is put at Rs. 20 per capita expenditure, a UN-sponsored study has said.

DOUBTS ON INDIA'S ABILITY

India is below African countries of Djibuti, Burkina Faso and Togo in Global Hunger Index (GHI). It has registered a mere 1% decline in child malnutrition since 1999.

With such a record India is not in a comfortable position to fulfill the MDGs as there are only five years left to meet the deadline by 2015.

The study also expressed doubts whether India could meet the target or universal enrolment of every child to school by 2015. The report titled "A Response to the India - Country Report

on Millennium Development Goals" has been prepared by a conglomeration of civil society groups.

CHAOS IN EDUCATION

Pointing to high rate of dropouts in primary schools, the report said the case was more vulnerable in case of children of marginalised sections of the society and those with some kind of disability and from the most backward areas of the country. India's performance of female literacy in the age group of 15-24 falls below the average of sub-Saharan countries.

Only 66% of the children enrolled in Grade-1 survive to go on to Grade-V.

On an average there are only three classrooms per primary school in India and there are only three teachers per school.

About 14% of the schools have a single classroom each and single-teacher

schools constitute similar proportion. Referring to the area of maternal health as a matter of concern the report said although there were promising patterns of reduction in MMR (Maternal Mortality Rate) within Kerala, West Bengal and surprisingly Bihar and Jharkhand, the most worrying situation was in the states like Assam, Haryana, Orissa, where the MMR increased to 480,186 and 303 respectively.

MATERNAL DEATHS

The statistical projection is that in 2015 there will be at least four states that will have MMR higher than the 2004-06 national average of 254.

Citing figures from the Registrar General, the report said of the 70 to 80 thousand maternal deaths in India each year, 38% could be attributed to heavy bleeding, 11% to infections, 8% unsafe abortion and 5% to obstructed labour.

A significant 20% posts across categories and departments reserved for OBCs remain unfilled.

Documents obtained under the Right to Information Act just 1,93,228 OBC employees, including 2,430 sweepers, were employed in different central govt. departments as on Jan.1, 2008. Reservation for OBCs was implemented from Sept.8, 1993.

Only 5,031 Group A officers from OBCs were employed in central services, which constitutes just 5.5% of the 91,881 employees recruited in that category. The percentage of Group B employees was only 3.9% (1,37,272) and that of Group C was 8.1% (total 18,10,141) and the composition of Group D employees excluding sweepers was 5% (total 6,96,800).

How to kill poor villagers through money-lending big business

Bombay: The theory is micro-finance (MF) aims at enabling the poor to build assets, increase income, reduce vulnerability to shocks and economic stress and improve quality of life by enabling better access to education and health care.

But in Hindu India theory has no connection with practice. Like everything else the MF concept is distorted, perverted and concocted by the Brahminical upper castes who have started monopolising it by sucking the blood of the poor. The govt. which is also controlled by their *jatwalas* is looking the other way.

NARAYANA MURTHY CIRCUS

According to one report (blog), Bangalore IT man Narayana Murthy, has also jumped into MF business to further enrich himself. Is he diverting his funds to MF by gradually preparing to quit Infosys?

Not only that. The Jews have started joining their cousins, the "Jews of India", in this blood-sucking game. George Soros, one of the richest American Jew, has invested in Indian MF venture called SKS Micro finance (SKSM).

LARGEST MF LENDER

There are other issues like commitment of the top management, high remuneration paid to top executives, geographical concentration of business and mismatch in its assets and liabilities. The much talked about initial public offering (IPO) of India's largest microfinance lender, SKSM, hit the capital market on July 28, 2010 with a price band of Rs.850 to Rs.985

per share. The issue closed on Aug.2. The issue again opened for subscription for anchor investors. SKS is issuing 1.67 crore equity shares of Rs.10 each.

BIG PROFITS FROM SMALL LOANS

Financial and other information provided by SKSM appear good on paper. However, there are some issues with the company, like high valuation of the IPO, question of commitment from the top management, high remuneration paid to top executives, geographical concentration of business and mismatch in its assets and liabilities.

Although the company in its draft red herring prospectus (DRHP) claims that it has no competitive peers, SE Investments Ltd, a microfinance lender, is already listed on the Bombay Stock Exchange (BSE). SE Investments' EPS stands at Rs.1.21 in the first quarter of FY10. The company posted a net profit of Rs.17 crore. Based on the EPS of the first quarter of FY10, its P/E works out to 11 (annualised), which is lower than the PE of SKSM.

SKSM reported a net profit of Rs.174.8 crore on total revenues of Rs. 958.9 crore and an operating revenue of Rs. 873.50 crore for the year ended 31 March 2010. It had a negative cash flow of Rs. 541.20 crore for the year ended March 2010.

According to the DRHP, the key management of SKSM has decided to sell their stake in the run-up to the IPO under both stock option and stock purchase plans at a significant premium. Collectively, the transactions would imply a sale of 1.42 million shares or 8.4% of the IPO size. Although the Reserve

Bank of India (RBI) has approved the transactions and there is nothing illegal about en-cashing investments, this raises a larger question of commitment on the eve of an IPO.

Another related fact is that out of the total issue size of 1.68 crore shares, more than half or 55.7% shares are put on sale by Sequoia Capital.

BORROWERS IMPOVERISHED

According to K.A. Prasanna of *firstchoiceipoanalysis.com*, the IPO of SKSM will make the promoters, and other venture capitalists including some private equity funds that have stakes in these companies, millionaires. The hapless borrowers continue to live in abject poverty. Earlier in February, SKSM's founder and chairman Dr. Vikram Akula sold 9.45 lakh shares at Rs. 639 per share to Tree Line Asia Master Fund (Singapore) Pte for \$12.9 million, Prasanna added.

SKSM also offers high remuneration to its top management. Its chief executive and managing director, Suresh Gurumani, is entitled to a consolidated salary of Rs. 1.5 crore per annum, besides a performance bonus of Rs. 15 lakh per year, with annual increments up to maximum of 100% with the board having the liberty to approve any further increase over and above the 100%. Another shocking part is that Mr Gurumani was paid a one-time bonus of Rs. 1 crore in April 2009, barely five months after joining the company.

SKSM has expanded its membership to 6.8 lakh across 19 states during FY10 from 2.02 lakh in five states from FY06. Currently

the company has 2,029 branches with total outstanding loans worth Rs. 2,936.70 crore as on March 31, 2010. During the same period, its debt to equity ratio stood at 2.84:1 with net non-performing assets (NPAs) of Rs. 4.8 crore or 0.16% of outstanding loans.

S. INDIA AS STRONGHOLD

SKSM provides small loans exclusively to poor women located in rural areas across India. The loans extended are purely for business and other income-generating activities and not for personal consumption. The company will use the IPO money to meet future capital requirements.

With increased area of operation and scaled-up activities, microfinance is increasingly gaining credibility in the mainstream finance industry with many traditional large finance organisations contemplating a foray into this business.

From the geographical perspective, microfinance activity has traditionally been concentrated in Southern India as 57% of the microfinance institutions (MFIs) and about 71% of the microfinance borrowers of the country are from this region.

Currently, the National Bank for Agriculture and Rural Development (NABARD) holds the right of regulatory oversight over MFIs except NBFCs. However, there exists a significant regulatory risk as the government may create a separate regulator for all MFIs. More importantly, the high interest rates charges by these MFIs may attract regulatory actions from the government or regulators, which may have a material impact on the ability of these institutions to sustain

high returns. For the year to end-March, SKS charged an interest rate ranging from 26.7% to 31.4% to its customers.

Swayam Krishi Sangam (SKS) Society, a non-profit, non-government organisation (NGO), converted itself into SKSM, a non-banking financial company-non deposit taking (NBFC-ND) in 2005. Later in 2009, SKSM became a

UNETHICAL PRACTICES

The AP Govt. has constituted district level Task Force Committees (TFCs) to investigate the unethical practices of micro finance institutions in the state. The committees were constituted after the government received many complaints against the loan shark practices adopted by some leading MFIs of the state.

The ultimate goal of microfinance is to enable the poor to build assets, increase incomes, reduce vulnerability to shocks and economic stress and improve quality of life by enabling better access to education and healthcare. The microfinance industry has grown at a rapid pace across the world and has created a positive impact in the lives of millions of poor people.

MONEY-LENDING

The Micro Finance Institutions, instead of providing credit at affordable interest rate, are exploiting the situation and looking for a return on investments in excess of 30% per annum.

The borrowers pay exorbitant rate of interest. Most of their income goes for servicing the debt with no

savings. This kind of situation is no better than the one the poor borrowers had experienced with the traditional moneylenders. They also defeat the very purpose of establishing the Micro Finance Institutions.

Despite the vast expansion of the formal credit system in the country, the dependence of the rural poor on

moneylenders continues in many areas, especially for meeting emergent requirements. Such dependence in the case of marginal farmers, landless laborers, and petty traders and rural artisans belonging to socially and economically backward classes and tribes whose propensity to save is limited or too small to be mopped up by the banks.

HIGH INTEREST

Micro finance is the provision of financial services to low income clients, including consumers and the self employed that traditionally lack access to banking and related services. It is a movement whose object is to create a platform, for as many poor and near poor as possible, to have permanent access to an appropriate range of high quality financial services, including savings, insurance and fund transfers, at an affordable cost. Those who promote microfinance generally believe that such access will help poor people out of poverty. Microfinance is one of the tools that can reduce the suffering of people by financial services that enable the poor to use the existing knowledge and experiences.

The interest rate applicable to loans given by banks to micro-credit organizations or by the micro-credit organizations to Self Help Groups/member beneficiaries is left to their discretion. Since the advances to MFIs are classified as priority sector advances, the applicable interest rate is around 15% per annum.

However, the MFIs are collecting interest between 24% to 36% per annum from the hapless borrowers.

George Soros fund, Quantum (M), invested about Rs. 26 crore to pick up a small stake in SKSM, the company that gives small loans exclusively to poor women located in the rural areas.

Soros' Quantum fund is one of the 18 anchor investors in SKSM. In this group of investors are global financial majors like Goldman Sachs, JP Morgan, Fidelity and Morgan Stanley and also domestic fund houses like Reliance and Birla Sun Life. The anchor investors jointly infused nearly Rs. 300 crore to buy about 30 lakh shares of the company.

SKSM aims to raise a little over Rs. 1,600 crore through the IPO.

TIGER STARTS LOVING LAMB

Vikram Akula, chairman of SKS, said that by coming in as anchor investor, these global and domestic financial institutions have shown they were ready to put money into hands of poor women.

SKSM backed by George Soros, gained 18% in its trading debut.

Investors bet that small loans extended to some of the world's poorest people can deliver big profits.

SKSM CRITICISED

The overnight gains handed shareholders a paper profit of \$US288 million (\$320m). SKS lends its 6.8 million borrowers, most of whom are poor rural Indian women, an average of £58 (\$101) each and often makes loans of £10. It claims a repayment rate of 99 per cent.

SKSM was created in 1998 by Vikram Akula (41), a former McKinsey consultant named by the *Time* magazine as one of the world's most influential people.

Akula, an American who founded SKS as a non-profit company, has privately sold shares in the group worth more than \$US12m and holds stock options potentially worth another \$US55m.

The SKS float, only the second by a pure micro-financier, had valued the company at \$US1.6 billion and raised \$US358m.

Among Akula's critics is Muhammad Yunus, 70, the Nobel Peace Prize laureate who is regarded as the godfather of micro-credit.

Akula argues that to help more poorer people he must attract capital by offering profits to investors. ■

Zionist Protocols & Brahmin Arthasastra

Emerging from deep secrecy, portions of the *Protocols Of The Learned Elders Of Zion* were brought to light in the late 19th century in France.

It is a fascinating story, presented here in a unique, unprecedented and thoroughly documented fashion. Months of intense research has gone into this work.

In 1884, Justine Glinka, the daughter of a Russian general, was engaged in Paris in gathering political information for the court of Tzar Alexander III. She employed a Jewish agent named Joseph Schoerst, alias Shapiro, who had passed himself off as a Freemason and a member of the Mizraim Lodge, a Jewish Masonic order with its own particular rites and protocols. None other than Solomon Rothschild, scion of the Jewish banking dynasty, was a prominent member of the French Freemasons. Schoerst offered to Glinka for the sum of 2,500 francs, a document which he said would interest her greatly. This document contained extraordinary dictated writings from assorted speeches which would later be included in the final compilation

of the *Protocols of Zion*. Glinka quickly passed the document to her immediate superior in Paris, General Orgeyevski, who sent them, in turn, to General Cherevin, Minister of the Interior, for transmission directly to the Imperial Court in St Petersburg.

Role of Sergei Nilus: Upon Cherevin's death in 1896, he willed a copy of his memoirs containing the *Protocols* to Tzar Nicholas II.

Glinka's information eventually found its way into the hands of one Sergei Nilus, a highly educated Russian mystic attached to Tzar Nicholas II's court as Minister of Foreign Religions. In 1902, Nilus published, *The Rule of Satan on Earth - Notes of an Orthodox Believer*, in which he cites excerpts from this early aggregation of the material first purchased by Glinka. Next stop for the *Protocols* occurred in 1903 when a prominent publisher by the name of Pavel Krusheva quoted writings from the *Protocols* in his daily newspaper, *Znamya*. After its publication, Krusheva suffered an attempt on his life and from that moment on, he lived in constant fear and had to carry weapons for his own protection. He also took the step of being accompanied by a personal cook to prevent being poisoned.

Death for having the book: In 1905, Sergei Nilus published a new edition of his *Rule of Satan* which included a complete version of the *Protocols* as the final chapter. This was the first time a full compilation of the *Protocols* had been made available to the general public in book form. In 1917, (the of Russian Revolution), Nilus had prepared a final edition — fully documented — but before he could distribute it, Kerensky, a half-Jew, who had succeeded to power after the Revolution, had most of the copies destroyed. Any one caught by the Bolsheviks in possession of The *Protocols* was shot on the spot. In 1918, the *Protocols* appeared again in a Moscow periodical, *The Sentinel*, marked by the Jewish-led Bolsheviks as a counter-revolutionary newspaper.

In February, 1919, the Bolsheviks ordered the newspaper shut down.

Nilus shot dead: In 1924, Professor Nilus was arrested, imprisoned, and tortured. He was told by the president of the court (who was Jewish) that this treatment was meted out to him for "having done them (the Zionist Bolshevik Jews)

incalculable harm in publishing the *Protocols*." A vital weapon in the hands of Jews is bribery, deceit and treachery which are also freely used by the "Jews of India". The *Protocols* says:

Only force and cunning conquers in political affairs. Therefore we must not stop at bribery, deceit and treachery for the attainment of our end. In politics one must know how to seize the rule of others if by it we secure submission and sovereignty.

Might is right: Destruction of Christian society was a basic tenet of the *Protocols*.

A hard copy of the *Protocols* may be obtained from US National Archives in Washington DC its number is 245-1.

From the *Protocols*:

According to the law of being, might is right. Our right lies in force. Through our financial dominance we will manipulate capital, create depressions and bankrupt Gentile states. In our hands is the greatest power of our day — gold. We shall not fail with such wealth to prove that all the evil we have had to commit has served to bring everything into order.

Caste-based political system helps Brahmin rule

Indian political system was carved on the pattern of the British. But it began to fall into the laps of Brahmins right from the day one.

The Britishers gone, the Brahmins took over. The Congress Party was overflowing with Brahmins. Below them were the Baniyas, Kshatriyas or *shudras* and *ati-shudras*, Muslims, Sikhs etc. This is exactly the Hindu social model (caste system) with Brahmins at the top and below them everybody else. The alien top (British) was removed by Brahminic struggle.

On the other side or in non-political field to keep the caste-*varna* pyramid intact, Brahminic organisations under RSS, Hindu Mahasabha and various literary organisations, temple and *maths* were looked after by Brahmins.

Non-Brahmin or *shudras* or OBC, BC politicians along with Untouchables were made to bow before this model. Rebels among these sections were made to surrender by the Chanakyan or Kautilyan policy.

So much so vote politics, which

should have been the weapon to throw out the Brahminic model, turned out to be the model protecting the very thing.

POLITICAL PARTIES

Brahmins managed (non-Brahmin) the Bahujan politicians by every means — by terrorising, by luring, by defaming. All those Bahujan politicians who entered political arena never opposed their social or cultural model. Political parties were moulded on Brahminic model — even the communist parties were a replica of the caste pyramid.

All the political parties were totally Brahminic, subservient to the Brahminic system.

That is how a non-Brahmin head of state at the Centre or at state levels subscribe to the Brahminic model. They serve the Hindu system.

No politician or party has challenged the Hindu social order.

Manu said: "King shall look after Brahmins first and later other *varna* (castes) needs". That dictum is still in vogue. The *shudra* chief minister will first look into the needs of Brahmins, will first listen to Brahmins, will first fulfil the demands of Brahmins and then after of Baniyas, Kshatriyas (if any) *shudras* and Untouchables, Muslims etc.

MUSLIMS ARE ENEMY

Hindu Rashtra propagandists say every Muslim *basti* is a mini-Pakistan and Muslims are enemies of the state. How the political parties and their leaders follow the

Brahminic system can explain this. Brahminic "national" political parties are those founded by Brahmins, such as the Congress, the Communist (all CPI-CPM to Naxalite or Maoists), the BJP.

Below these parties are those founded by non-Brahmins: Janata Dal, RJD, Janata Party, Rashtrawadi Congress, PWP (Maharashtra), DMK and Dalits parties — the RPI, the BSP.

All the non-Brahmin parties are headed more by personalities than by principles or motto. They are led by the names of leaders but not by principles. No non-Brahmin party can run defying the Brahminic norm or culture.

MARATHAS GET 2ND RANK

The hierarchical model is seen in these parties.

Take the case of Maharashtra. Marathas form the second-rank caste below Brahmins. Socially, culturally they are second to Brahmins. Brahmins are their *guru*.

Their role model in politics is Shivaji. He considered himself Kshatriya i.e. below Brahmins and bowed before Brahmins while ascending the king's throne. Today also Marathas are observing the same pattern. They bow before Brahmins or respect Brahmins. The pyramid is maintained.

DALIT PARTIES

There are the non-Maratha middle castes (the OBC). OBCs respect Marathas and Brahmins or consider themselves as below the

Marathas. Dalit parties too take refuge in the Maratha camps. Socially, they are below the middle castes. Without the support of the middle castes or Marathas, Dalit parties cannot come to power.

The political strength of Dalits depends on the middle caste

and Maratha support.

But Maratha power is controlled by Brahminic system.

Thus the *varna* hierarchy model is kept intact. Dalits under the middle castes and Marathas, middle castes under Marathas and Marathas below Brahmins.

Beautiful. The ultimate controllers of the state are thus Brahmins. So, the political model runs parallel to the social model.

This is called the *Hindu Rashtra* — Hindu system.
