2. There are two considerations which should be borne in mind in assessing the implication and sincerity behind these principles. The first consideration is that these principles though adopted by the Federation are for the benefit of all the downtrodden humanity in India. The Federation in that sense cannot be accused of being a communal organization. It may be that it is not open to all, nonetheless it is out to serve all and co-operate with all who prove worthy of co-operation.

3. There may not be anything new in the Principles of the Scheduled Castes Federation. They will be found in the manifestoes of most political parties. But there are two considerations which distinguish the Federation from other political parties. The first consideration is that the principles of the Federation are not adopted by the Federation merely to look politically respectable or merely to delude the voters. They are natural to the Federation. They are born out of the social condition of the Scheduled Castes. The Scheduled Castes Federation cannot exist without adopting these principles and without holding up to those principles and living up to them. The principles of the Scheduled Castes Federation are the life book of the Scheduled Castes Federation. They are not the external marks of a political faith. They are the outward register of the inward feeling. They are not cloak worn for the purpose of winning the election. Many parties may adopt these principles. But no party can be so true to the principles as the Scheduled Castes Federation. This is the second consideration in valuing the principles of the Federation.

The Policy of the Party

4. The policy of the Party will be to try to give effect to the principles set out above. The policy of the Party is not tied to any particular dogma or ideology such as Communism, or Socialism, Gandhism, or any other ism. The Party will be ready to adopt any plan of social and economic betterment of the people irrespective of its origin and provided it is consistent with its principles. Its outlook on life will be purely rational and modern, emperistic and not academic.

British didn't break Brahmin monopoly & caste system

5. The programme of any political party in India must be integrally connected with the legacy left by the British. The legacy of the British has its credit side, and also its debit side. On the credit side must be reckoned (1) a uniform system of law, (2) a uniform system of justice, and (3) a uniform system and administration. On the debit side must be reckoned (1) maintenance of the archaic social system prevalent among the people of the country, (2) maintenance of the privileged class in education and in the services, both civil and military, (3) **complete neglect of the Untouchables, of the Backward Classes and of the Tribal people, (4) impoverization of the country.**

A. Problem of Raising the Backward Classes

6. The Scheduled Castes Federation will fight for the raising of the Backward Classes, the Untouchables and the Tribal people both in the matter of education and services. This will receive topmost priority in the plan of action by the Federation and will be treated as fundamental. Neither delay nor want of means will be allowed to stand in the way of carrying this part of the programme into effect. The sort of education which the Scheduled Castes Federation has in mind with regard to these classes is not primary education, not even Secondary Education. What it has in mind is advanced education of such high order, both in this country and outside, which will enable these classes to fit themselves for taking hold of administration. Similarly, in the matter of services, the Scheduled Castes Federation will insist on reservation, subject to minimum qualifications, so long as these classes are not able to find their place in the civil and military services of the country. Today there is rampant a worst sort of communalism in the civil and military services of the country by the higher classes. The services have become the monopoly of a few communities. When the lower classes are trying to break this monopoly by demanding that they who are at present excluded from services, are decried as communalists. The Scheduled Castes Federation will not allow this perverted logic to stand in the way of the non-privileged classes in the way of the fulfillment of their demand for occupying their rightful place in the affairs of this country. *(To be continued)*

CASTE WAR IN PUNJAB

When Sikhs hate Dalits because of caste, why not reject them & establish Ravidas religion?

The curse of Brahminism is even if you quit Hinduism and convert to any egalitarian religion to seek liberation you cannot get rid of casteism which is the other name for racism. The powerful Jat (*shudra*) castes of Punjab embraced Sikhism to fight Brahmins but within no time they are back in the Brahminical stomach.

Caste decides everything in India

Bangalore: When *Dalit Voice* propounded the theory of "caste identity" that leads to caste struggle (caste war), Brahminical people, the country's worst casteists, simply laughed.

Where is the caste, they said without knowing that caste is everything in India. But the country's premier Brahminical daily, the *Hindu of Madras*, owned by an Iyengar family, writes an editorial on the latest Punjab violence and calls it "The caste war in Punjab" (May 28, 2009).

Caste is our "nation": But when we wrote our international award-winning book, *Caste — A Nation Within the Nation* (Books for Change, Bangalore, 2002, Rs. 140) no Brahminical daily or periodical reviewed it.

But the fact is India continues to be a country of castes and communities. Everything in India is decided on the basis of caste — even inside Sikhism, Christianity, Islam. Even those who deny existence of caste and make fun of our theory also depend upon caste to fight us.

The caste has not only refused to die but growing stronger. The latest parliament election and subsequent developments prove it. Why people find comfort in caste is because caste is our "nation".

fight each other. The principle of Brahminism is divide and rule. Sikhism, a military religion, was born to fight Brahminism and free all the oppressed people including Dalits from Brahminical tyranny and racism. Guru Gobind Singh, the last of the Sikh gurus and the most revolutionary of the lot, declared Brahminism as the Enemy No.1 of the people. Sikhism quickly grew and came to dominate the whole of Punjab.

"Blue Star" & Indira Gandhi murder: But the Brahmins would never forget or forgive their enemy. During the partition (1947), the Brahmins deceived the Sikhs by using M.K. Gandhi who made them remain with Hindus. Sikhism itself was dubbed a reform movement within Hinduism — like Buddhism and Jainism. The enemy was waiting for an opportunity to once for all break the backbone of the Sikh martial race. That opportunity came when Indira Gandhi sent the army itself into Golden Temple and killed the revolutionary leader, Sant Bhindranwale (1984), and thousands of Sikhs on their holiest day and that too inside their holiest shrine, Golden Temple. In DV, we called it "*Hindu war against Sikhs*" (DV Edit June 16 1984).

The Dalit Sikhs did not forget the crime committed by Indira Gandhi. A devout Dalit Sikh (not a Jat Sikh) took the revenge and killed the then Prime Minister (DV Edit Nov.16, 1984: "*A Dalit kills Indira taking Sikhs closer to Khalistan*").

Sikhs corrupted & co-opted: All this is now part of history. But the Khatri and the Jat Sikhs in particular have forgotten their great ancestors like Sardar Kapur Singh, Sant Jarnail Singh Bhindranwale, both Jat Sikhs, and all the crimes committed by the Brahminical people against the Jat Sikhs and allowed themselves to be corrupted and co-opted by the Brahminical force.

What a tragedy that Punjab's sole Jat Sikh party

of Akali Dal is in the pocket of the *Brahmana Jati Party*. In almost every *gurdwara* in Punjab, the Brahminical people have established a unit of their *Rashtriya Sikh Sangat* (RSS) to re-write the *Guru Granth*, the holy book of the Sikhs, and include Hindu gods and goddesses. This is being vigorously done. The Jat Sikh religious leaders or their party never objected to this Brahminical blackmail.

No hope in Jat Sikhs: We have very exhaustively written on the "*Fall & slow death of Sikhism*" by holding a long Debate on the subject (references to DV Debate is given at the end of this Editorial). We say with deep sorrow that we have hardly any hope of the Sikh military religion of Guru Gobind Singh then and Sant Bhindranwale recently, reviving itself. The Khatri Sikhs like Manmohan Singh etc. have no Sikhism in them except their turban and beard. Many have given up their religious symbols also. The Jat Sikhs were the only people keeping the Sikh flame burning. But the deep Brahminical infiltration, with the Akali Dal itself becoming an ally of the *Brahmana Jati Party*, we have no hope in the Jats. The Jat Sikhs only job today is to obey the Brahminical order to attack the Dalit Sikhs.

Targeted assassination: Since the Jat Sikhs themselves are not interested in Sikhism what hope is there for Dalit Sikhs and other Dalits?

The Vienna explosion was clear and loud. Both the Dalit saints had gone there to preach Guru Ravidas message to **only** Dalit Sikhs and other Dalits. It was not a Sikh *gurdwara* but a Ravidas Temple of the Dalits.

Killing Dalits is Hindu dharma: What business the Jat Sikhs or other upper caste Sikhs had to go there when they were not invited or the prayer meeting was not to their liking? That means the

upper caste Sikh assassins went there determined to kill the Dalit saints. This proves the intensity of caste hatred even in a far off foreign land.

Hinduism (Brahminism) is the other name for caste hatred. Dalits are its worst victims — from centuries. The whole lot of Indian Dalits, who form over 20% of its 1,200 million population, are daily suffering the Hindu hatred and violence which is fully justified by Hinduism as their *dharma* (religious duty).

The Babbar Khalsa International (*Hindu* May 27, 2009) says the:

"Indian agencies are behind the Vienna attack and they are trying to split the Ravidasiya community from the Sikh Panth".

When the Brahminical rulers of India and the upper caste Sikh rulers of Punjab say they hate Dalits, why beg them?

Dalits refuse to quit Hinduism: That is why Babasaheb, the Father of India and the country's most audacious warrior against Brahminism, revolted and kicked it out asking his Untouchable followers to quit Hinduism.

But they did not. Even when Hinduism grinds them to dust and they all know who is the culprit. We call it: Slaves enjoying their slavery.

The Punjabi and Haryana Ravidas Dalit followers are also caught in the same dilemma. When Guru Ravidas, Dr. Ambedkar and all the Dalit saints were victims of Brahminism and daily the Dalits are persecuted by the Hindus they are still sticking on to this stinking house.

This is because the Brahminical leaders have given a powerful injection of their religion, the poison of which the Dalits are not able to get rid of.

Jats made monkeys, Dalits bribed: On one side they have made monkeys of Jat Sikhs and continue to instigate them against Dalits. On the other they are riding the back of every Dalit saint, infiltrated their *deras*, tempted them with all sorts of bribery.

Though Guru Ravidas was hated by the Brahminical people, who only finally killed the saint and also his famous disciple, Mira Bai (DV Feb.1, 2009 p.9), the *vaidiks* did not give up the hope of retaining Dalits within Hinduism. M.K. Gandhi's fasting stunts against separate electorate finally reduced the fate of Dalits who are once for all made Hinduism's most obedient

slaves enjoying their slavery. Heard of it anywhere else?

Dr. Babasaheb Ambedkar, the Father of India, and the country's greatest fighter against Brahminism after the Budha, asked Dalits to quit Hinduism and embrace Buddhism. Barring a fraction, Dalits by and large remained within Hinduism as its slaves.

Power of Brahminical media: The Brahminical people wield such enormous influence on all their victims only because of the power of their *manuwadi* monopoly media but Dalits and other persecuted minorities denied human rights have none except the *Dalit Voice*.

So, when Brahminism is reigning supreme, unchallenged, making a bloody fool of every section that challenges them, how to win the war launched by Babasaheb against Brahminism? ■

India as world's only last remaining racist state

Bangalore: As this is written the Brahminical people have raised a furious protest over the "Australian racism against Indian students" — suppressing the historical fact that India is the founding father of racism. Apartheid died in South Africa decades back but the centuries-old Brahminical racism is reigning supreme in India.

No amount of cosmetic social reform can hide its horrible face that shot to international fame in the latest shoot-out in an Indian Untouchables temple (Ravidas Mandir) at Vienna (Austria) on June 23, 2009. Assassination their saint by the upper caste Sikhs is the latest proof of the canker of casteism which is worse than racism.

Sikhism is itself a great religion born out of revolt against Brahminism (Hinduism) but even after conversion, the upper castes within Sikhism continue to be casteists (racists).

It means Hinduism will not accept any social reform. Even after conversion all upper caste Sikhs,

Christians, Muslims maintain their racial identity. Is this not racism?

The Vienna temple belonged to the Dalits. A couple of upper caste Sikhs entered it fully armed, the police said, with the determination to kill the Dalit saint.

Even when a Hindu goes out and settles abroad he continues to be a racist.

Way back in 2001, the Dalits failed at the UN Durban conference to get casteism equated with racism. Last month in Delhi India's Brahminical govt. once again rebuffed fresh efforts from Scandinavian countries to equate casteism with racism.

The Vienna planned assassination is the latest proof of casteism as racism. The upper caste Sikhs hate Dalit Sikhs claiming equality. The contagion of casteism, the foundation on which Hinduism stands, has spread to Christianity and Sikhism. Even Islam.

Not only that. Wherever the Hindu goes he carries his racism.

Sikhs always used to fight Muslims then & Dalits today

The Vienna murder of a Ravidasi saint has two sides: historical background and immediate reasons. (1) Background: Guru Nanak, a Khatri by caste became saint in 1500 AD. He sang songs in praise of Hindu gods. He met two saints at Kashi, Guru Kabir and Guru Ravidas, who changed his course. He started singing *bani* (sermons) of these *gurus*. Some old scholars claim that Guru Kabir was his real guru. Anyhow he spread message of these gurus in Punjab. Nanak's followers were called Sikhs i.e. learners. Sikhism had ten gurus. Early Sikhism is nothing but teachings of Guru Kabir and Guru Ravidas. It completely discarded Brahmins and their rituals.

Brahmins use Sikhs: The ninth Guru was approached by Brahmins. They flattered him and his son Guru Gobind Singh (10th and the last guru). But the 9th guru was beheaded at Chandni Chowk, Delhi.

Guru Gobind Singh (1699) started the *Khalsa Panth*. Mostly Mazahabis and Chamars joined his army. No

Brahmin came. Though it is true that the Sikh religion was born to fight Brahminism, the fact is the Brahmins throughout used the Sikh martial race to attack and kill the Muslims.

Despite M.K. Gandhi deceiving them on Sikh homeland and Jinnah promising the same, they did not join Pakistan but preferred to go with Brahmins. Even after the "Blue Star" massacre of Sikhs, they simply forgot all the crimes and joined the *Brahmana Jati Party* (BJP) as its electorate partner.

Though the Sikhs are not trusted by the Hindu rulers, they will be too eager to fight Pakistan if another war breaks out. To that extent they are hinduised (corrupted).

All the gurus treated Dalits with dignity. So too the Jat Sikhs. But after the death of Gobind Singh, Brahminic people (called *Masand*) took charge of Sikhism.

Dalit-bani in guru Granth: This situation continued till the advent of Dr. Babasaheb Ambedkar. Many

Chamars from Jalandhar area went abroad and became millionaire/billionaires. They promoted Ravidas *mandirs/gurdwaras*. When Kanshi Ram, a Punjabi Dalit, started his movement, Dalits joined him fully.

Guru Nanak carried with him *bani* (writings) of Dalit gurus. He commanded his successors to compile *banis* of all the saints. Almost all Dalit saints' *bani* have been included in the *Guru Granth*. This *bani* is recited in all Sikh *gurdwaras* and also Ravidas *mandirs* called *Dera*.

Some 5-6 years back, some Sikhs came to a *dera* and tried to hoist *Nishan Sahib* (a sword like symbol of Sikhs) to annex Ravidas temples under the Sikh Gurudwara Prabhakar Committee (SGPC). Dalits of all castes resisted and foiled the move. Bloody fights broke out between Jats and Dalits who showed their real strength. It is a historical fact that Dalit Sikhs

sacrificed their lives for Sikh gurus but the upper caste Sikhs always betrayed them. A peace pact was arranged between Dalits and Jats by then CM, Amrinder Singh, at Akal Takhat (the highest seat of Sikhs) which directed the SGPC not to meddle with *deras*.

Dera Sachkhand Ballan is the most popular *Dera* of Guru Ravidas. Two years ago its followers made an idol of pure gold worth crores of rupees, took it thru procession from Punjab to Varanasi. Millions of Dalits joined the procession.

This hurt the caste pride of upper caste Sikhs but they had no courage to touch the Ballan saints. So they chose Austria.

However, the Chamars showed their courage and killed one/two gun-wielding attackers without any weapon.

When toilet papers proved wrong : Union Ministers selected only on caste basis

Bangalore: Our "national" toilet papers and TV screamed, rejoicing over the Congress Party getting a "sweeping victory". They said "regional", "caste and religion-based" parties died a natural death and that for the first time their "heart throb" Khatri Sikh PM gave the "nation" a "stable govt."

The whole thing turned out to be false — a big empty boast. These journalists give only their personal opinion but call it the "opinion of the people" — meaning their 3% Brahminical Social Order.

"Functioning anarchy": Neither the caste and caste-based parties nor the religion died. The Khatri Sikh did not give even a "stable govt". Punjab broke into violence and the army had to be called — delaying the Cabinet expansion. Stability is an impossible dream in this chaotic India, called a "functioning anarchy" by J.K. Galbraith.

He resorted to reckless search for caste and regional representation and that is how the cabinet formation was so badly delayed — giving lie to the Brahminical claim of "stable govt.". Nonsense.

India not a "nation": That ministers from UPA allies were chosen on the basis of caste and religion was fully understandable. Why did the Congress, which got such a big majority, resort to the same caste, region and religion-based selection?

These Brahminical pen-pushers and their shouting brigade in TV do not know the answer. Even if they know it is not in the interest of their "Brahminical nation" to say it in public.

This is the answer: India is not a "nation". The real "nation" is one's caste. The Union Cabinet will be acceptable to the people only if it represents each region and each important caste, community and religion.

Cycle chain principle: So Maharashtra has to represent the Marathas, the single largest caste, and the non-Marathas like the SC/ST/BCs. So also in the case with all the states of India. The Union Cabinet gets its strength from the different regions, castes, tribes, religions.

Just because the BSO has produced some foreign educated "India shiningwalas", who think "merit and efficiency" should be the sole criteria for any selection, the people of India will not get fooled. These "India

shining walas" are waiting to brainwash the *kurta*-clad "future Prime Minister" and inject their "merit and efficiency" virus. This will not work.

If a bicycle has to run smooth, every link in the cycle chain must be free from rust and well-oiled. But the BSO thinks they only constitute the nation and that SC/ST/BCs (65%), Muslim, Sikhs/Christians (20%) plus the powerful landed *shudra* castes who form the bulk of the Hindu (15%) are of no consequence.

Show-boy S.M. Krishna: That is how Virabhadra Singh was selected being a Thakur from HP. There are no Yadavas in the cabinet. The powerful Patels of Gujarat are represented by Dinsha Patel, Gujjars by Sachin Pilot.

Selections from Karnataka are not good except for Kharge (Mala-Dalit) and Muniyappa (Madiga-Dalit). S.M. Krishna is a show-boy Vokkaliga whose caste went with H.D. Deve Gowda and Moily is from a small piper caste. Krishna's choice as Foreign Minister is a big mistake. The country will soon learn it.

The Times licks the wound: The *Times of India*, which was leading the Brahminical bulldogs barking that caste and regional parties are dead, ran a page one story giving caste details of every minister.

The BSO bulldogs have not given up their plot to kill caste, region and religious parties by brainwashing the young, urban-born, urban-bred Rahul Gandhi who has not seen the "real India".

To these bulldogs the "real India" is the sex-driven IPL cricket match, drinking, late night parties, fashion, driving expensive cars and showing off and cheating through stock markets. They have not produced a single honest intellectual.

How can Rahul Gandhi learn from these sleazy suckers?

Rootless Nair: Fortunately, their biggest cheer leaders, the IT honchos, are dying, if not dead. Many more city-bred parasites are dying.

Rahul Gandhi must know that such a youth brigade comprises only parasites. One such parasite was elected from Trivandrum —not because of his popularity but the anti-CPM hate wave. RAJASTHAN YAGNA

Now a report comes from Rajasthan (*Nagsen*, March 23, 2009 the Dalit Adhikar Kendra, Rajasthan). In Bhilwada dt. in a village Tiloli having a population of 11 different Dalit castes totaling 1,965 of 452 families out of total population of about 5,000. The Dalits are fighting for participation in a *yagna* the Hindus are conducting. They approached the govt. The *yagna* organizers denied any discrimination and the authorities prevented the flare-up of tension through a compromise that only the Brahmin priests will be putting the *aahuti* (oblation)

in the fire of *yajna* and none else. The *Adhikar Kendra* people are aggrieved that the authorities did not consider the matter as observation of untouchability and take preventive action; instead, they only took it as a law and order situation. The Dalit youth who are reportedly educated and united, seem to think they are on the correct path. They might be feeling even jubilant at the understanding. But I think, they are on the wrong path.

DR. AMBEDKAR VERDICT

Dalits are not Hindu and were never Hindu. Thus said our savior, Dr. Babasaheb Ambedkar. He organized *satyagraha* for Mahad water tank, when he burnt the *Manusmriti*. When he got deceived by Gandhi and was forced to sign the *Poona Pact* and was even cheated after that, he decided the Hindus would never be willing to give treatment of equality to Dalits and he decided to renounce Hinduism. And then came that famous declaration: I was born a Hindu, which was not in my hand; but I would not die a Hindu".

QUIT HINDUISM CALL

Ultimately he renounced Hinduism and adopted Buddhism (1956). He then gave Buddhism to half a million of followers at Nagpur and Chandrapur. Since then the way of Dalits is decided for them. And that way is the

Way to the Buddha.

If that is our way, why insist on having *darshan* of Brahmin gods or put valuable grains and ghee into fire in wasteful *yajnas*? That is not our culture. That is never beneficial to humanity.

The Buddha renounced it originally, and then time and again. That was the fight of the Buddha against the Brahmins, which ultimately brought in untouchability around the time of Adi Shankara, about thousand years after the Buddha. We worshipped the gods of Brahmins for thousands of years. That did not bring any emancipation to us. That did not bring us health, wealth, prosperity or prestige or any right to learning or even to bear arms. It was because of this, we had to submit to the atrocities of the Brahminic law books; that is how we were reduced to dust.

No Brahmin god came down to earth to wipe our tears. With a great effort by Dr. Babasaheb, we have now learned how to come out of the mud of Brahmanism. So why we are again going back to Brahminism? 62-year-old III-World War against Islam will end only with Palestinian peace

Can we say that the West launched its zionist-inspired prolonged Third World War against Islam on Nov.29, 1947 when the captive United Nations was forced to divide Palestine—that legitimately belonged to Muslims—and called for the establishment of Israel with the full support of the West? It is in the book, *The Losing Battle with Islam* (Indian edition, 2006, Viva Books), he comes out with a very detailed study of the "war on Islam" and says the Third World War actually started on Nov.29, 1947. He lists the different countries and areas where the West and India's Hindu rulers launched wars on Islam.

Salbourne has covered the whole world and hence we are fully justified in borrowing his sentence that what is currently going on is the "Third World War on Islam" and in this war the zionist-led West and Brahminism led-India are defeated.

But, alas, the world's academia, which is supposed to look without blinkers, has also

become a victim of prejudice when it comes to Muslims. As regards India, caste prejudices walk in the front and the "intellectual" follows. (India's Intellectual Desert, DSA-1999).

their properties threatened but even their lives.

Alan Hart, a White British historian, expert on Palestine-Israel conflict and an authority on zionism, warns that "anti-semitism is on the rise".

In his "Author's Note" on the first of the gigantic four-volume American edition of his famous book, *Zionism — the Real Enemy of Jews*, Vol. 1, Published by Clarity Press, USA, describes Israel as "the cancer at the heart of international affairs".

Describing Americans as the "most idealistic people on earth", he says many of them are uninformed about the conflict in Middle East because of the "Israeli-occupied media". make anything, which makes the dollar worth less. The writings of Marx, Lenin and Mao are inspirational, but some things should be noted about their vision. Lenin’s country was too big, and the ruthless Stalin took over. Mao’s country eventually adopted some capitalism, because pure communism doesn’t work. I believe in a capitalism-socialism hybrid myself. The government should never allow bad working conditions or poor pay (our country is good about this). However, America should not allow CEOs to make 300 times more than the lowest paid employee, and the average CEO does make this much more. The poor countries which become richest quickest don’t use bank loans, but have a small flat tax. For instance, you tax everyone only 10%, unless they are a CEO making 20 times more than their employee. With a small flat tax, you fix the economy and shrink big Brahmin government. You allow Dalits to start their own businesses without waiting years for a business petition to sit on the shelf. In Hong Kong, you get a business license in less than a day. But the speakers at the book release function at Nagpur on March 14, 2009 did not do justice to the profundity and the analytical skill displayed by the book. One speaker was afraid of speaking aggressively against the Brahmin rulers and the other one was afraid of his Dalit friends who are too busy with collecting the rewards of reservations and yet another one has perhaps not read the book at all as per his usual style and habit. However, I was pained to read on pages 50 and 51 (Ibid) your observations on Shivaji, the

Great. I think a campaign, systematic, is going on to denigrate Shivaji and his mother Jijabai. Apart from the above observation of yours, you said in your speech at the silver jubilee function of *Dalit Voice* readers at Nagpur on March 15, 2009 that Shivaji stomachached the insult inflicted by Gaga Bhatta at the time of his coronation as a king on June 6, 1674, as per author Vaidya. Similar story was told some years back by Nagesh Choudhari, our esteemed friend at Nagpur. However, he denied the statement when I confronted him a few months back. Yet another such statement was made in my presence by one solo actor at the Shivaji Jayanti celebration at Wadi, Nagpur, where I was the main speaker on the Feb. 22, 2009. The story of "insult" done to Shivaji by Gaga Bhatta is not supported by any respectable writer. Vaidya is no historian. This incident, if at all it happened, has to be corroborated by the foreign dignitaries that were present at the coronation. The envoy of the East India Company, Henry Oxinden, had attended this ceremony. But he has not recorded anything unbecoming of a king taking place at the coronation even in his diary. Other foreign visitors and writers speak very respectfully and in an eulogizing manner about Shivaji. They are:

- (1) Jean de Thevenot, (2) Cosma da Guarda, (S.N. Sen, foreign biographies of Shivaji), (3) Rev. John L'Escalot's (Shivaji), (4) James Grant Duff, *A History of the Marathas*, (5) Oxinden, *English Records on Shivaji*, (6) Abbe Carre's *Appreciation of Shivaji*, (7) Bernier, *Travels of the Moghul Empire*, (8) Aungier, *English Records on Shivaji*, compares Shivaji with Julius Caesar, Alexander the Great and Hannibal, (9) Edward Scott Waring: *History of Marathas*, (10) Francois Martin, (12) S.J. Owen and Grant Duff, (13) Sir E. Sullivan, (14) Jonathan Scott and (15) the Portuguese historian A.B. de Braganca Pereira.

Shivaji required his coronation for the reason that it would have given him powers to punish the guilty Brahmins. Up till then, they were only driven out of the area but never punished with life. Shivaji was the first Indian king who killed the envoy of Afzal Khan, Krishnaji Bhaskar Kulkarni, when the latter attacked Shivaji after Afzal Khan was killed by Shivaji. Shivaji did not support the Hindu religion. Rather, he had his second coronation within a month of the *vedik* coronation. This second coronation was done according to the *Shakta Dharma* under the presiding priests of the Gosavi and other caste. For this ceremony he had gone through a mock marriage with a Mahar woman or a Matang woman which was part of the ritual. Another reason and stronger than the

above one for Shivaji to get himself coronated was that his mother's dynasty was Yadawas of Deogiri now called Daulatabad. The kingdom of Yadavas was sunk by the prime minister priest of Deogiri, named Hemadri Pandit, as he invited Allauddin Khilji to attack Deogiri. As to the notion of Shivaji being a *shudra* (that is the fourth *varna* or class of the four-tier vedic system), it needs examination. When the Aryans established a small foothold in India, called *Bramhavarta*, the Aryans were very small in number. They called the entire population of the *Sindustan* by the name *Kshetriya*, i.e. belonging to the homeland or the soil of India. *Kshetriya* means belonging to the *Khet* (ef *Khatiri*) or a *Shet* in Marathi. The distinction between the warriors of the *Sindustan* and others like the cultivators and the artisans was discovered later by the divisive Aryans. This longish statement on Shivaji was thought necessary as the opinion that you hold as also other small-time Dalit workers hold will estrange the Maratha/Kunbi from you. Besides, such an opinion is absolutely unhistoric, false, ill-conceived and spiteful. I suspect that it has been sponsored by the Brahmin and handed over to the *reservationwala* Dalits for merry-making. The present condition of all the castes of the Indian society including the Marathas, the Dalits and the ethnic groups of North East has been carved out by the Brahmin during a long span of over 3,500 years. If we want to get free from the slavery, the slaves should unite as far as possible and move with determination. The population of the Mahars of Maharashtra and the Minas of Rajasthan with the Dalits of AP and Tamil Nadu will certainly measure up to 2 to 3 crores. Of this 5% have benefitted from the reservation in jobs and other fields, as you say. This figure will be around 15 lakhs. If these meritorious, wealthy and enlightened people make an army of workers any type of revolution violent or non-violent can be brought about. Total SC/ST [population of India is (110 x 22.5) 24 crore roughly. Even if 10% i.e. 2.5 crore of it rises, a total revolution can be brought about, thereby making the Dalit a leader of the Indian society. Now this is not happening in spite of the *Dalit Voice* Editor's best efforts. The rich and bureaucrat Dalit as well as the rich Maratha is not co-operating. Now, for this Shivaji or Babasaheb or Goutam Budha cannot be blamed. At least a few more persons like Editor V.T. Rajshekar, late Kanshi Ram, Mayawati, Lalu Prasad Yadav and Purushottam Khedekar will have to be born to make our dream a reality. Finally, I would request the personalities working in the field

of Dalit awakening not to hurt the feelings of the Marathas or the OBC section just for earning a few points. The Marathas are the only people among the population of India who have a sense of nationhood i.e. Indianhood and can be called upon to defend the country from the external aggression any time, any hour of the day. The Sikhs may fail, the Jats may fail, the Gujjars may fail, the Rajputs may fail, the Dravidians may fail but the hungry, illiterate, the superstitious Maratha can always rise to the call. British Governor Warren Hastings also said so in 1761. Wish you speedy success in the Dalit awakening.

Dr. K. Jamanadas, "Shalimar", Main Road, Chandrapur - 442 402: This refers to the Letter by P. S. Sadar (DV April 16, 2009, p.18). Sadar, who refers himself as a Kunbi, is an eminent scholar, a historian of repute on Harappa culture, a noted linguist and a prominent OBC thinker. His views are respected by all the Ambedkarites. First I wish to clarify that it was a book review I wrote, and so mostly the views of original author (Devare) are depicted. But I agree with all the points raised by Sadar. I only wish to clarify one point. He says: "Why should Devare or Jamanadas grudge if some poor Maratha obtains a Kunbi caste certificate?" I have no grudge against anybody getting reservations. I belong to Kanshiram-Mayawati school of thought, who believes that *jiski jitni sankhya bhari uski utni bhagidari*. I have no objection even if all, including Brahmins, get their share in power. That is what reservations are though some people say reservations are not fundamental rights. My only worry is that, the Marathas and other equivalent people wish to get this reservation from OBC quota, which is already meager 27 for 52%. If they ask for canceling the upper limit of 50% imposed by judiciary and ask for separate quota for Marathas etc., there should be no objection of OBC leaders also. But I have not seen Maratha leaders challenging 50% limit. Actually they are the rulers of this country and can change any laws. But to me, it appears they have no political will of offending the Brahmins. Let us not forget the future of this country rests in their hands, as exclaimed by Dr. Ambedkar. A neglected message from Dr. Ambedkar to OBCs: Gawande, a close friend of Dr. Ambedkar, who was then the Law Minister in Nehru Cabinet in 1947, asked for a message for the Maratha people to be published in the souvenir of *Maratha Mandir* of Bombay. Dr. Ambedkar declined saying that he had no relation with the organization or the Marathas, but on persistent insistence, a message was given and

published in the souvenir on March 23, 1947. It was made available by Vijay Survade recently and was undocumented till now. Dr. Ambedkar said: (translated by me from Marathi):

This principle will apply not only to Marathas but all Backward Castes. If they do not wish to be under the thumb of others they should concentrate on two things, one is politics and the other is education.

One thing I like to impress on you is that the community can live in peace only when it has enough moral but indirect pressure over the rulers. Even if a community is numerically weak, it can keep its pressure over the rulers and create its dominance as is seen by the example of status of presentday Brahmins in India. It is essential that such a pressure is maintained, as without it, the aims and policies of the state cannot have proper direction, on which depends the development and progress of the state.

At the same time, it must not be forgotten that education is also important. Not only elementary education but higher education is most essential to keep ahead in competition of communities in their progress.

Higher education, in my opinion, means that education which can enable you to occupy the strategically important places in state administration. Brahmins had to face a lot of opposition and obstacles, but they are overcoming these and progressing ahead.

I cannot forget, rather I am sad, that many people do not realize that the caste system is existing in India for centuries because of inequality and a wide gulf of difference in education, and they have forgotten that it is likely to continue for some centuries to come. This gulf between the education of Brahmins and non-Brahmins will not end just by primary and secondary education. The difference in status between these can only be reduced by higher education. Some non-Brahmins must get highly educated and occupy the strategically important places, which has remained the monopoly of Brahmins since long. I think this is the duty of the State. If the Govt. can not do it, institutions like *Maratha Mandir* must undertake this task.

I must emphasize one point here that middle class tries to compare itself with the highly educated and well placed and well to do community, whereas lower class all over the world has same fault. The middle class is not as liberal as the upper one, and has no ideology as lower one, which makes it enemy of both the classes. The middle class Marathas of Maharashtra also have this fault. They have only two ways out, either to join hands with upper classes and prevent the lower classes from progress, and the

other is to join hands with lower classes and both together destroy the upper class power coming against the progress of both. There was a time, they used to be with lower classes, now they seem to be with the upper class. It is for them to decide which way to go. The future of not only Indian masses but also their own future depends upon what decision the Maratha leaders take. As a matter of fact it all should be left to the skill and wisdom of the leaders of Marathas. But there seems to be a lack of such wise leadership among the Marathas.

What Dr. Ambedkar said about Marathas equally applies to all OBCs, and still holds true after half a century. Dr. Ambedkar wrote much to educate the OBCs. It is only now that OBCs are awakening gradually. It must not be forgotten that the future of this country depends on them. Secondly, it is not on economic points the OBC list is made; it is socially and educationally made. So let us not talk of "poor Maratha", as Sadar did. Three poverty lines as described by Devare are self explanatory.

S.C. Musafir, Palampur, Kangra dt. - 176 066: In 2006, Dr. Bharat Jhunjhunwala, a noted economist and also a friend of *Dalit Voice* Editor, sent me a detailed agenda on *Maharamayan* with contents of seven stories extracted from the *Yog Vashishth* to know the viewpoint of Dalit-Bahujans. I read his note and prepared a reply with my objections. He told me that his religious *guru*, Subodhanand, wanted him to write a book named *Maharamayana* on the contents of *Yog Vashishth*, a religious text of Hindus (Brahmins). The *guru* extracted seven stories from the *Yog Vashishth* and passed it on to Dr. Jhunjhunwala to prepare the *Maharamayan*. Dr. Jhunjhunwala had sent the complete matter with his comments on the subject to many Hindu intellectuals and one copy to me for my comments. He raised two questions: (1) Why god Brahma felt the need to take incarnation as a human being and (2) How one can get spiritual pleasure through *yoga*? In the introduction to his subject Dr. Jhunjhunwala calls Budha an incarnation of god like Rama, Krishna, Brahma, Vishnu etc. When I asked him about the author of the *Yog Vashishth*, he said he did not know its original author. The seven stories he had sent me are not based on historical facts but were Hindu mythology which will lead the masses into the blind belief of Brahminism. The subject matter of all seven stories is a dialogue between Rama (hero of the *Ramayan*) and Vashisht (another character in the *Ramayan*). Vashisht told these stories to Rama and later called it *Yog vashishth*. Brahmins are the real authors or creators of this cock and bull stories full

of lies. I sent my reply to Dr. Jhunjhunwala after carefully studying his text and consulting about 50 reference books. I later published all the interaction between me and Dr. Jhunjhunwala as a book. He has also published his work titled *Yog Vashishth Ke Saqt Kahaniayan*. The main culprit is the Brahmin Subodhanand who misguided a non-Brahmin Marwari Bania to write *Maharamayana* to misguide the gullible masses of India. Dalit movement is anti-woman ?

To be a woman is a disadvantage; to be a Dalit woman is a double disadvantage. Her sex is her great disadvantage. This is a patriarchal world. Sociology openly demeans her gender and her caste; theology openly deifies her but secretly undermines her dignity and security as a human being. No religion has ever come to her help or help to empower her. Religions have only deified her: but never humanized her. In the *Bible* very subtly she is called by her generic name woman at the birth; only after her fall she is called Eve.

HINDUISM IS ANTI-WOMAN

There was a time, that too, a long time, during which Hinduism was the only religion in our country. Its rituals, and scriptures nurtured and glorified superstitions of all types which encompassed not only its theology but they also enveloped the sociology of the subcontinent. Its superstitions oppressed the inferior castes but specially oppressed the women.

LONG HAIR

The worst sufferings of the women were not only that they were kept under a kind of unannounced house-arrest but they were even pushed to a sub-human condition of existence. Their souls were shrouded and their bodies given prominence and were thereby exploited. Their lives were cheapened and they were involved in the practice of pleasurable arts like *natana* and *natya* and music. In their private and public lives they were merely toys in the hands of their menfolk.

Even their dress were designed by men. Their ornaments and external decorations though

declared only to improve their physical appeal, they even cluttered their movements. Long hair on their heads has no functional value; it only consumed their time in the upkeep. The flowers they wore on their hair and their dress prevented their quick movement.

They were tied to delicate and effeminate gestures which incapacitated them from public participation in social activities. Their flowers and face-wash and their flowing hair were all dove-tailed to the presence or absence of their consorts and became symbols of their marital or windowed state of existence in their family and society. Even their lives were contingent on those of their husbands that *sati* became not only a practice but a sacred ritual. Killing the female fetus or the newborn female baby became an ingredient of the Hindu culture.

LOWEST LITERACY

All these were the fate of women in India. They were worse compounded in the case of the Dalit women. Women's literacy rate was low enough; Dalit women's literacy was the lowest imaginable—97% of Dalits come under poverty-line depending on daily wages. When men folk go to their daily chore, women and girls become baby-sitters or field-workers.

PLIGHT OF EDUCATED DALIT WOMEN

In the urbanized context young Dalit girls some times at the age of 10 years or so are employed as full-time maid-servants where both the couple is employed. Hence they are denied education. Their alienation from education and financial poverty

and dependence nurture their backwardness and superstitions.

Their religion and caste lead to illiteracy and financial dependence which together go to entangle the Indian Dalit woman in her sociological trap. Added to all these her sex has also been constructed into a gender by the ignoble patriarchal philosopher. Genderisation has been the concerted work of not only the conspiratorial patriarch but also the dedicated contribution of the matriarchs in our households.

WOMEN IN PUBLIC LIFE

The small percent of women who were educated and employed and hence have attained a certain level of liberation are refusing to come forward to liberate the still unliberated Dalit woman. They even refuse to participate in public life leave alone Dalit movements and activities. A majority of these liberated working Dalit women do not have the freedom and time to spend their salaries for any pro-Dalit activities. Their lives are controlled by their men, who in most cases are unemployable, unemployed men who try to live in the earnings of their spouses and daughters.

Dalit oppression has not merely been social, economical and political, it has, at its roots, been psychological.

It has killed in the minds of the Dalits even the desire to be self-respecting and dignified. Long-time mental bleaching has made them and kept them as vagabonds and drunkards. It has nurtured their irresponsibility almost as a counter-value. Because of this most of the Dalit families hang round the neck of the Dalit woman. Man has developed the negative capacity to abandon the

family's interest while woman cannot shirk her responsibility as a mother. She plays, tragically, a mother even to her husband

There is another danger the Dalit women have to face. If they overcome all hurdles and become Dalit activists and participate in public programs they are easily mistaken for being light-hearted and men try to exploit them. Such women become easy prey to the evil designs and desires of men. It is also a general opinion of a majority of men that a woman in public life is a sign for her willingness to drink and have a free sexual affair with any man. A woman on a public stage is not held in high regard as a sweet-stay-at-home is. A solo woman has not been able to win respect from

the menfolk in our country. Even other women don't respect her.

A highly professional woman is accused of violating traditional norms and a highly traditional woman is to an equal extent accused of being old fashioned. This is a dilemma for the Indian Dalit woman. She knows not what to do because a liberated woman is easily considered exploitable—socially, physically and sexually.

Women, given the opportunities, have not only proved equal to men, they have even surpassed them in public and professional lives.

One can reel out names from all over the world. Hence patriarchy has skillfully kept women out of many areas of human activity, especially

from society-forming. Child-bearing, a natural biological activity, has been ritualized into a religions drama to insulate the woman from dynamic social involvement.

The British women got their voting rights through street fights. Later and because of that when India got her "freedom at midnight" our women got their voting right even without asking for it. Our Dalit women too got it that way. But it was like a penalty corner, they have failed to convert it because they have gone on trying to get this goal through converting men which has proved impossible. Therefore, if men cannot be converted, there is only one alternative: they have to be conquered. Only a conquest will end the woman's quests for a space in the sun. ■

Greatest weakness is male-domination

We fully agree with Sister Bharati. We go round the country addressing meetings which are attended only by Dalit men. Even when our invitations specifically direct them to bring their wives, mothers, daughters, they come alone. When we ask them why they failed to heed our request their answer is: "Who is there to prepare food when we go home?" Their women are reduced to a mere cooks. It is true that the upper caste society is more male-

dominated but their women get at least a chance to visit the temples which promote Brahminical supremacy. Our women have no such forum. When the male-dominated Dalit movement itself is in doldrums, when can we see the dawn of Dalit women's liberation — despite Mayawati heading the country's most powerful Dalit party? The greatest weakness of the Dalit movement is it is male-dominated — EDITOR. ■

Liberation through English

Upper caste monopoly of English

Bangalore: English (reading, writing and speaking) is restricted to the rulers — meaning the upper castes. They don't want the slaves of India to learn English as that would help their liberation.

The upper castes (15%) went up only by mastering English — though a large portion of rulers still lack proficiency in English.

They captured all important posts and positions because they were the first to learn English. Having gone up, they scented the danger of allowing the slaves to learn English.

Mother tongue mania: So they created the "mother tongue mania" among our people who remained mere clerks and peons — condemned for not learning English. The rulers have kept English as their close preserve. Even after 62 years of "independence" English is restricted to about 3%. Slaves are enjoying their slavery because of the "mother tongue mania".

Upper castes enforce varieties of imperialism. Apart from their "caste imperialism", "English language imperialism" has made their position secure.

Saharanpur (UP): It is a regular morning at the Gochar High School here. Since it is a Hindi medium school, few students know English with even the teachers preferring Hindi. However, there is someone who speaks in English, and that too with an American accent.

I know English fluently. Nobody taught me, says Rakesh, a 14-year-old class 11 student, who is a Dalit.

When he's not at school, he's in the fields helping his family out. And his accented English is because of some hard work over the last three years. He's so hooked to the language now, that Hindi has become a foreign tongue for him. "I speak in Hindi but prefer to speak in English", says Rakesh.

Hindi heartland rejects SP's English hatao call: He has been convincing everyone that English is god's gift to him and an inborn talent. However, if prodded a little and he reveals, I watch a lot of Hollywood films and try and speak like they speak in the films.

Saharanpur in North India is known as the Hindi-heartland. But even here English is becoming very popular.

What is behind this new found craze? It's a mixture of fascination and need for a good career, so because of these two reasons English is very popular, says Rakesh.

While Rakesh takes the English craze to one-extreme, there are those who take it to another idol-worship.

Since Dalits never had any gods or goddesses we decided to build this idol. She stands on a computer, has a pen in her hand and is called the English Goddess. If Dalits want to join the new economy they have to learn English, which is idea behind this idol, says a Dalit journalist.

From believing that it is a god's gift, to worshipping it as god itself, Dalits in India are using English to demand for an equal society.

Bengal restores English

Calcutta: Five years after it re-introduced English in Class I, the WB Govt. took a radical decision on May 26 to offer it as a medium of instruction in all government Bengali-medium schools in the state. The proposal was mooted by Chief Minister Buddhadeb Bhattacharjee and included in the agenda for the state cabinet meeting. The CM was firm that this was needed to improve communication skills of Bengali students.

Parents craze: In 1984, in a controversial move, the state govt. had abolished English from the primary section in all Bengali-medium govt. and govt.-aided schools. Following big protests from all quarters, English returned to class V in 1992, class III in 1998 and finally in 2003, it was decided that it would be taught from class I onwards. The CM now wants to introduce English-medium sections in Bengali-medium schools. Starting this academic year, these would be introduced in class I and class XI. Next year, English-medium sections would be set up in class II and class XII.

A note by the School Education Dept. had commented on the mushrooming of private schools of poor standard and uncertain quality in the state, which were cashing in on parents desire to send their wards to schools which offered English-medium. Teaching in English would also enable students to speak and write the language correctly. Guardians of students studying in private English-medium schools, who pay through their noses for the education of their kids, ask us why even though we have large government schools we could not arrange for English-medium-sections. ■

Mystery of India's "freedom at midnight": Aug. 15, 1947 held inauspicious

Bangalore: Here is a shocking case of India's future being decided by astrologers — not the political leadership. That is how ever since India became "independent" on Aug. 15, 1947, the country has never recovered from tragedy after tragedy — social, cultural, political, economic and even moral — because the country is governed by corrupt and superstitious astrologers, priests, *tantriks* even to this day.

The following passage on the hidden facts of history was found in a book by Tariq Majeed, a retired Naval Commodore, titled, *Masterminds of Air-Massacres*, (2006, pp.750, Rs.475, Baitul Hikmat, Lahore).

He says Lord Mountbatten as the viceroy of the undivided India suddenly announced the date of transfer of power as Aug. 15, 1947 which sent shockwaves across India.

ASTROLOGERS PROTEST

In spite of being the Viceroy's close collaborators they had not received even a hint that he would act with such decisive haste (Collins & Lapierre, *Freedom at Midnight*, p.166). But a strong protest against the announced date rose from the cliques of India's influential astrologers. They "declared that August 13 and 15 were both inauspicious days" (Wolpert: *Nehru*, p.404). The ministers-designate of India's first cabinet wanted their swearing in to be done before midnight on the 14th.

As for the bizarre story of the

astrologers' protests, it is aptly described by Larry Collins and his partner:

As soon as the radio announced Mountbatten's date, astrologers all over India began to consult their charts. Those in the holy city of Benares and several others in the south immediately proclaimed 15 August a date so inauspicious that India would be better advised to tolerate the British one day longer rather than risk eternal damnation.

CELESTIAL CATASTROPHE

In Calcutta, Swami Madamanand rushed to his celestial charts as soon as he heard the date announced. He took out his *navamansh*, an enormous circular chart composed of a succession of concentric circles on which were plotted the days and the months of the year, the cycles of the sun and moon, the planets, the signs of Zodiac and the positions of the 27 stars influencing the destiny of the earth. At its center was a map of the world. He twisted the circles on his charts until they were all set for the 15th of August. Then, from a map of India in the chart's core, he began to draw a series of lines out towards the edge of his wheel. As he did so he sat up aghast. His calculations foretold disaster...

From midnight, 14 August throughout 15 August, Saturn, Jupiter and Venus would all lie in the most accursed site of the heavens, the ninth house of *Karamstahn*. Like thousands of his colleagues, the young astrologer looked up from his chart overcome by the magnitude of the disaster they had revealed. What have they done? What have they done? He shouted to the heavens whose machinations he interpreted for man...

Seizing a piece of paper he sat down and wrote an urgent appeal

to the man inadvertently responsible for this celestial catastrophe. For the love of god, he wrote to Louis Mountbatten, do not give India her independence on 15 August. If floods, drought, famine and massacres follow, it will be because free India was born on a day cursed by the stars. (Collins & Lapierre pp.166-167).

A GREAT MAP OF THE GLOBE

It was beyond the grasp of the stargazing gurus, (or may be some of them realized it later), that the date had been set by the forces of heavens and no one had the power to change it.

Here, recalling the scene of Swami Madamanand bent over his astrological chart, with each circle set for 15 August, feeling alarmed at the inauspiciousness of this date and wishing it to be changed, conjures up in the mind a fascinating scene of another dimension. A great map of the globe showing the silhouettes of the divine plan lies unrolled in the heavens with the appointed date, Friday, 27 Ramadan 1366, 15 August 1947, marked at a dot on the map and an Angel of god is shaping the march of all events to converge on that dot.

THE DIVINE PLAN — AT A GLANCE

18. Agitate for English language to be included in the 8th Schedule of the constitution and remove Hindi's status as one of the official languages — along with English.

Cow slaughter

19. Even fake leftists of Kerala and West Bengal have legalised cow slaughter and make cow slaughter legal in UP.
20. Implement de-Brahminised history and de-brahminised curriculum in schools. Ambedkarism, Periyarism and revolutionary marxist methodology must be specifically taught as part of curriculum in schools and colleges. All pro-CPM and pro-Nehruvian and pro-RSS academic apparatus must be destroyed.

Which BAMCEF should DV support ?

I was indeed shocked to read Brother Gurnam Singh Muktsar's writeup (DV April 16, 2009, p.13) asking DV to support Waman Meshram's BAMCEF and the Editor's consent to support it to fight Brahminism. I know Waman Meshram from very close quarters. He worked here during 1982-1985 in Kanshi Ram's BAMCEF, learnt so many things from Kanshi Ram, pretended to be his ardent follower and later turned so snobbish that he used to have a claim of grooming Kanshi Ram and his movement.

SPLITTING KANSHI RAM BAMCEF

Later in 1986, with a group of supporters in Maharashtra and at the behest of the Congress, he split Kanshi Ram's BAMCEF and got his faction registered. We who worked with Kanshi Ram felt that it was a heinous betrayal of not only Kanshi Ram but of Ambedkarite movement which Maharashtrians are famous for. After reading Brother Gurnam's write-up, a very pertinent question cropped up: how the BAMCEF, factionalised by the Brahminical Congress, would strengthen Ambedkarism and fight Brahminism? This BAMCEF faction still appears to be on the payroll of Brahminical people.

A PAN-INDIAN NON-POLITICAL MOVEMENT

As Waman Meshram claims to have started a non-political Ambedkarite movement, let us remember that he has done so by breaking BAMCEF into several factions after kicking out people who initially supported him and all these kicked out people run their own BAMCEF factions in

Maharashtra. And let us remember that all these worthies have not added anything new other than what Kanshi Ram taught.

They have, very cunningly, hijacked the name BAMCEF along with Kanshi Ram's ideology and now masquerade as all-India leaders or even international leaders.

Educated and semi-educated Maharashtrians suffer from leadership mania, though — they know — they do not possess leadership qualities. That is why they break popular organisations, hijack the name and ideology and sit at the center of their faction like a proud spider sits at the center of its web to victimise smaller insects.

R.P.I. FATE

That is what they have done with RPI and that is what Waman Meshram and his ilk have done to BAMCEF. If these worthies feel that they really possess leadership qualities, they should start new and fresh organisations instead of stealing names of organisations founded by somebody.

INVITATION TO POLITICIANS

If we scan the functions organized by Waman Meshram's BAMCEF, we cannot but find that in majority of his functions some or other political leader is invited.

The question is why politicians of different hues adorn the dias of BAMCEF which claims to have devoted itself to non-political activities?

And, moreover, what non-political institutions have been established and run by Waman Meshram's BAMCEF other than holding conferences and seminars since

1986? He often speaks of strengthening non-political roots of Bahujan Samaj. Fine. But which non-political roots of BAMCEF he has strengthened?

RAT MADE INTO TIGER

The very concept of non-political roots has been borrowed by him from Kanshi Ram. But this very concept has been used by him to spread misunderstanding about Kanshi Ram's movement. When BSP was founded by Kanshi Ram in 1984 and was spreading its base with the help of BAMCEF and DS4, these very people published hand-outs in 1986 saying: "Kanshi Ram was a rat but we made him a tiger". They also wrote: "Kanshi Ram was incapable of providing leadership because he had lost his mental balance".

BREAKING THE EGG

We were so shocked by this handout that we actually sent some people to confirm Kanshi Ram's mental health to Nagpur where he was going to address a rally. But these very people go on inviting political leaders in their functions and nobody asks them the reason. Are these political leaders their mentors?

In fact, after Dr. Babasaheb Ambedkar the political, non-political question has been drawn out of proportion and converted into a controversy unending such as "the egg first or the hen first". The controversy has taken a dangerous dimension such as "whether to break the egg, from the little end or the big end." Whichever end you break the egg the effect will be the same. Dr. Babasaheb Ambedkar ran political, social and cultural movements simultaneously to co-

ordinate them with each other without making them water-tight compartments.

Ever since I became a DV family member, I have known that DV always supports and admires the honest, intelligent and those who believe in social dynamics. But not those who have betrayed Ambedkarite movement in any form. And I sincerely feel that DV itself is a non-political movement devoted to theorizing,

conceptualizing and awakening thousands of simple Ambedkarites in India and abroad. I also feel that Waman Meshram intends to have coverage for his self-styled leadership in DV through brother Gurnam Singh Muktsar.

I am well aware of the intellectual level of Meshram as he has worked with us for quite some years at Nanded. After breaking away from Kanshi Ram's BAMCEF, he has tried his best to wean us away from

Kanshi Ram's movement. But we at Nanded still support wholeheartedly Mayawati and BSP movement which has been making strides throughout India.

As a DV family member I don't want either VTR or Brother Gurnam Singh to be misled by those who have intentionally betrayed Ambedkarite movement. If propped up, Meshram might even claim that he had groomed even VTR and Gurnam Singh Muktsar. ■
