## Thus Spake Ambedkar

### THE INDEPENDENT LABOUR PARTY : A SOURCE FOR BETTERMENT OF THE DEPRESSED CLASSES

On the 14th January 1937, Dr. B.R. Ambedkar reached Bombay from London. The journalist from *Times of India* had interviewed Dr. Ambedkar. The interview is as follows: Editors.

Dr. Ambedkar said that he visited Europe purely for reasons of health and he stayed most of the time in Vienna and Berlin. He was in London only for a week. He had no conversation of a political nature with any one in London.

Asked if he had come to any decision regarding his intention to leave the Hindu fold, he said that the decision still remained, although he had not finally made up his mind which new faith he should embrace.

Dr. Ambedkar said that his immediate concern was the ensuing elections to the Bombay Legislative Assembly and he would devote himself to the election campaign. The Independent Labour Party, which he had started, would work for the betterment of the political and social condition of the Depressed Classes in the Legislature, and he was sanguine that all the candidates put up on behalf of his party would come out successful in the elections.

Dr. Ambedkar was given a rousing reception on arrival. More than a thousand *khaki*-clad volunteers belonging to the Social Equity League lined up the entire route from Ballard Pier Station to Alexandra Dock No.18, cheered him as he passed.

Most of the candidates put up by the Independent Labour Party of which Dr. Ambedkar is the founder, for the ensuing elections to the Bombay Legislative Assembly were present on the wharf to meet him. Among them were B.K. Gaikwad (Nashik District), Mr. Prabhakar Roham (Ahmednagar), Mr. B.H. Varale (Belgaum), Mr. R.R. Bhole (Poona), Mr. B.J. Sawadkar, Mr. S.G. Tipins (Kolaba), Mr. G.R. Ghatge (Ratnagiri), Mr. R.E. Bhatankar (Thana) and Mr. V.A. Gadkari.

exploitation were a violation of civil liberties, not in the conventional sense, but because of the breach of the dignity of whole communities. His reply to the Secretary of the Civil Liberties Union, Dr. K.B. Menon, way back in June 1937, makes meaningful reading:

Barrister-at-Law 8th June 1937.

Dear Mr. Menon,

I am in receipt of your letter No.998 of the 19th of May 1937 and also your post card asking me to sign the manifesto, on behalf of the Indian Civil Liberties Union to be read as a message from India at the conference on civil liberties in India to be held in London. I did not know of your letter till I came to Bombay on the 25th May, and hence could not reply to it earlier.

I have read the manifesto and I am sorry I cannot subscribe to it. You have condemned the Frontier Policy of the Government of India. I do not see how it can be a matter of Civil Liberties of India. On the other hand, you make no mention of the systematic tyranny and oppression practised by Caste Hindus against the Untouchables, which is undoubtedly a matter of Civil Liberties of Indians.

## PM's China visit fails : His mad love for US will not allow him to embrace Beijing

India's rulers intensely hate China and this hate brought about its first China war (1962) led by its Kashmiri Brahmin PM, Jawaharlal Nehru. Not only India suffered a humiliating defeat but the arrogant PM's fake socialism got punctured and he suffered a heart attack and died. Today, nobody remembers India's first PM —not even his Congress Party.

China, according to Indian rules, is occupying large parts of its territory in the North and also East but to this day the great "India Shiningwalas" did not have the courage to get this "aggression" vacated. "Hindi-Chini *Bhai Bhai*" died with the Kashmiri Brahmin whose fake socialism was soon thrown out by his own favourite grandchildren in their rush to embrace the American Jew and the juice they piss daily.

**Brilliant China:** With Nehru's socialism becoming a thing of the past, the hate-mongering "Jews of India" are now in tight embrace with the American Jews. But here also they are losing with the fall of George Bush and the defeat of his Republican Party. Whatever the "Jews of India" touch is turning mud.

**The brilliant Chinese know all these too well. And the part played by the "Jews of India" to discredit China where the Jews are a suspect and hence kept out.**

It is under such suspicious circumstances India's Khatri Sikh PM, a product and protege of the World Bank Jews, visited China in the middle of January with his gang of hate-mongers.

China, the emerging super power, knows all these and how the hate-mongers have deliberately kept India's poor starving so that the 15% Brahminical boasting braggarts remain as rulers.

**World's centre shifting to Asia:** Dr. Manmohan Singh and his upper caste *jatwalas* are great admirers of US. The PM and his *jatwalas* go to US so often as if like a pilgrimage. But in his Beijing tongue-in-cheek speech he tried to deceive the brilliant Chinese but did not succeed.

"We are at an exciting point in history when the centre of gravity of the world economy is moving towards Asia".

The world economy could be about Asia in the 21st century just as it was all about West in the 20th century. "When countries of the size of China and India, together accounting for 2.5 billion people, begin to unshackle creative energies, it impacts the whole world. The world knows it and is watching with interest", he said (*Times of India*, Jan.16, 2008).

**PM knows the truth:** That means the PM knows the Truth. Yet he is not influenced by this Truth. When he knows the

Truth and yet will not follow the Truth how can he make himself (and India he heads) free? Do you know why he is not surrendering to Truth? Because, he is more interested in his *jatwalas* than Justice and Truth. This is the problem with our upper castes.

How many times he rushed to his holy Temple in US and prayed before his god (George W. Bush)? But in contrast this is his first visit to China as PM. And he did not display any enthusiasm there. It was a reluctant visit more to fulfil a formality. Why did he go there to speak out dishonest words saying the "centre of the world is shifting to Asia"?

**Kick out Dalai Lama:** There were hardly any heart-to-heart talks in Beijing. How can China have any confidence in Brahminical India sheltering its arch enemy, Dalai Lama, and given full freedom to play havoc inside this country and outside? As long as this Tibetan traitor is not kicked out India can have no peace with China.

**"Times" admits India's weakness:** India is a pygmy before China. The PM knows it and his Brahminical retinue knows it still better. But their arrogance and false pride will not allow them to admit all this. This is the problem.

India's topmost Brahminical English daily the *Times of India* (Jan.14, 2008) shamelessly admitted all this even as the PM was in Beijing and said that the "unequal status will make it difficult for PM to call the shots".

Today even the US, Japan and every world power is afraid of China. But a beggar country like India does not want to admit the truth — though the boasting brags are licking their wounds unable to get the "Chinese aggression" vacated even after 46 years.

**China has better democracy:** Our boasting Brahminical fellows dismiss all the progress of China and misery in India with their single-sentence favourite reply:

"China is communist and India is democracy".

Yes, this is true on paper. But over 85% of India's SC/ST/BCs and Muslim/Christian/Sikhs — plus women of all communities say with one voice that India has no democracy. China has better democracy. The World Bank itself has said all this.

But whoever may say it but the Brahmin will not accept the Truth. Only when he admits it, it becomes Truth. This is the law of this land

shamelessly hovering between life and death. That is how India has been living in a fool's paradise ever since it became "independent" (1947).

**Chinese Olympics will rattle world:** The Indian rulers boast they are the one of the world's most brilliant people. If so why they are still holding on to the tail of America which is sinking economically, politically and in all other respects? The Jews who control the wealth of America are themselves preparing to shift to Europe.

But China is galloping and soon will be the world's No.1 power. The Olympics it is hosting will rattle the world. Will Indian players get at least a piece of iron there?

The whole world knows the greatness of China. And yet our Brahminical ruling crooks during their latest visit to China, did not display any warmth.

**The Chinese know that India's rulers are a set of crooks. During our two visits to China we were perhaps the first to reveal this secret.**

When the dollar finally sinks what will happen to India if it puts all its eggs in the American basket? During their latest visit the Brahminical leaders should have given hints of India getting closer to China. But they were not only not ready but continued to display their hostility. Particularly the business tycoons who went with the PM were very much hostile.

**India must go with Asia:** The Indian ruling class (15%), as days pass, is not only getting more and more arrogant but insolent. It is licking the shoes of the American rulers and the Jews who control US: without realising that India's future is doomed with such a bear-hug.

**Being Asians, our future has to be with Asia. But the rulers hate the Muslims who are all Asians and the Chinese who too are Asians.**

The Chinese rulers know all this. And they are watching us. *Dalit Voice* is carefully read and studied there.

**Cockroaches:** The rulers are killing the country internally and externally. They have weakened and intellectually destroyed the Bahujan Samaj inside.

The media controlled by its Brahminical rulers is playing a dangerous game — systematically suppressing Truth and putting out falsehood. Sex is its only god, *Kamasutra* is its new *Bible*. Its academics also being Brahminical have shown no spark. There is nothing like an "intellectual class"

in India because the *Manuwadi* media props up only Brahminical cockroaches as intellectuals.

There is a total sunset over India. Only *Dalit Voice* cries out periodically but its voice is drowned in the cacophony of the *Manuwadi* media.

We have been saying this for the past 28 years. Not a single statement of ours has gone wrong. At the age of 61, India should have been a full-

## Persecution of Christians in "Hindu India"

**Bangalore:** Despite India remaining the world's most populous and vibrant democracy, freedom of religion is steadily on the decline, says John Dayal, a journalist-turned-Christian activist, who is now national president of the 1919-founded All India Catholic Union and secretary-general of the All India Christian Council.

"Many of the rights have been systematically diluted over the years by governments, courts and fundamentalist forces," Dayal told Ecumenical News International in an interview on Oct.13 about his soon-to-be-released book on religious freedom in India.

*A Matter of Equity: Freedom of Faith in Secular India*, is a critique of religious freedom in the country. Dayal

says that this freedom, or lack of it, ranges from the steady dilution of constitutional guarantees to harsh treatment meted out to Christians and minorities in every corner of the country.

The book is a collection of articles Dayal wrote both as a journalist, and after he became outspoken on issues concerning India's Christian community. In his writings, Dayal describes a steady upsurge in anti-Christian violence from the late 1990s, when the Hindu terrorist party (BJP) emerged as a strong political force.

## Bungling by rulers causes serious food shortage

**Bangalore:** The over-fed ruling upper castes (15%) have completely suppressed the alarming news that within an year or two India is going to face acute food crisis which will cause starvation deaths and even bloody riots.

The rulers have enough and more money to buy rice or wheat even if the prices go up hundred fold but it is the SC/ST/BCs and Muslims, constituting the country's poorest, who will face starvation. The rich rulers have many other things to eat other than rice or wheat. In fact, their expenditure on food is the lowest.

**Kerala food crisis:** It is the slaves of India who depend only on rice and wheat which constitute their main food. Already meat having become so expensive most of them are forced to be vegetarians. If rice also goes beyond their reach and vegetable prices becoming too high, how will they fill their hungry stomach?

The rulers are not bothered.

Kerala is already facing acute rice shortage. Chief Minister Achutanandan, being a "low caste" Ezhava, has ensured supply of cheap rice to BPL people who are given some low quality rice. And they are satisfied with it.

The problem of Kerala is going to repeat all over India in an year or two. Punjab, the bread basket of India, is already facing wheat crisis. The govt. is importing wheat. India used to export food till recently but now it has started importing wheat. Soon it has to import rice also.

This is because rice cultivation has become expensive and there are none in villages to do the laborious work.

**Gods to control anger:** How did the problem crop up? Rice cultivation needs lot of labour which is not available in rural areas. Most of the labourers have migrated to cities. So the land owners leave the fields fallow but buy rice in the market which works out cheaper than cultivating. This has led to a big fall in rice production and the problem will grow to alarming proportions as urbanisation increases.

The urban-dwelling upper castes with enormous income, however, are unperturbed. They have the capacity to buy however costly rice or wheat becomes. But what about the country's enormous poor whose only food is rice?

The rulers are not bothered. If they get angry, the

Hindus have created 333 millions of gods to calm them down. If they become uncontrollable, they have the police and military to shoot them down.

**The rulers are not bothered because they don't depend upon rice or wheat. They eat the cake.**

**Maratha warlord:** Our oil-faced Khatri PM is least bothered. The Food Minister of India is a Maratha warlord, Sharad Pawar, who presides over his sugar empire. He is more interested in cricket, the upper caste national game which they have converted into the new religion of India. The Finance Minister is a Tamil Chettiar of the money-lending *jati*. The Planning Commission chief is a World Bank nominee. All these fellows are great supporters of the Brahminical values.

**No bread? Eat cake:** If the starving millions come, these Khatri and Chettiars will tell them: "If you have no bread, eat cake".

**When the starving people of France got this very same reply from then reigning queen, they turned furious and launched the French revolution.**

But in India our starving people will not get angry because they are all under Brahminical mesmerism. Their brain is full of Brahminical shit.

Very vaguely the Khatri Sikh made a reference to "food crisis" in one speech but India's national toilet papers simply ignored the warning. To these papers, cricket is more important than any other life and death issue.

**Sonia will be blamed:** The Congress Party will be blamed for all this crisis and the upper castes, whose heart is in BJP, will accuse Sonia Gandhi for bungling on the food front. The party will be out, BJP may take over.

**After the "Modi miracle" in Gujarat all his sins of killing thousands of Muslims are forgotten. He will be the hero for the whole Brahminical race.**

Some votes of the Dalits going to Congress will be taken away by the BSP. Regional and caste-based parties will have their assured votes.

But the main loser will be the Congress. Both the Khatri Sikh and the Ahluwalia Sikh will go back to their World Bank job. But the oppressed SC/ST/BC slaves will not get angry because these people are not only slaves but slaves enjoying their slavery. Who can save these slaves?

**Bombay:** The Times of India Group forges unusual alliances with companies which serve the interests of everybody - except those of readers and consumers. Sucheta Dalal throws new light on this unique "business strategy":

If you are an investor who depends on India's largest-selling economic newspaper for unbiased news, then you must know and understand the concept of "private treaties" (PT). Since the TOI far outsells every other English newspaper and the *Economic Times* is by far the market leader in the economic news category, the concept is of universal interest, especially for MoneyLife readers. Although PTs sound like agreements between two sovereign nations, they are, in fact, pacts between the TOI and approximately 100-odd companies, under which TOI buys shares of small and fast-growing companies. The list is expanding rapidly.

T.N. Ninan, editor of *Business Standard*, described PTs as "basically the transfer of shares in return for advertising". He said, Bennett Coleman & Co, which owns the *Times* group,

"invests in usually mid-rung companies that are keen to jump into the big league but are perhaps without the big

bucks to spend on marketing. The share purchase money is immediately taken back against the promise of guaranteed advertising in Bennett publications - to build the investee company's brand(s). Part of the deal is even said to be editorial coverage, though this remains unconfirmed". "If true, by definition, this will have to be positive coverage" because "the brands have to be built up, so that the shares bought by Bennett gain in value and can be sold".

MoneyLife has in its possession a document to prove that journalists are being designated as "champions" for PT clients to tailor editorial coverage to enhance the value of these companies and TOI's investment. An e-mail by the *Economic Times* editor, Rahul Joshi (late Pramod Mahajan's nephew, dt. Nov. 29, 2007), says:

"At ET, we are carving out a separate team to look into the needs of PT clients. Every large centre will have a senior editorial person to interface with Treaty clients. In turn, the senior edit person will be responsible, along with the existing team, for edit delivery. This team will have regional champions along with one or two reporters for help — but more importantly, they will liaise with REs (Resident Editors) and help in integrating the content into the different sections of the paper. In this way, we will be able to incorporate PT into the editorial mainstream, rather than it looking like a series of press releases appearing in vanilla form in the paper."

## India Shining

India has the world's largest illiterates

Going by the present trends, the goal of universal education by 2015 set by the United Nations seems unattainable for India. "The Education for all" global monitoring report 2008 which was recently released by UNESCO, is a telling commentary on the status of education in our country. India figures at the bottom of the ladder in every aspect, be it enrolment, gender or regional disparities. Despite the increase in literacy rate from 18.3% in 1951 to 67.3% in 2004-05, India has the largest number of illiterates in the world, that is, 35% of the 774 million illiterates. "The Education for All", report places India at 105 among 127 countries. In the 2007 report, India figured at the 100th place. If India has fallen by five places it simply means that it has not done enough, in fact, far less than most of the similarly placed countries, in improving access to education.

**Manoj Padhi**, Plano, TX, USA: Is Orissa Chief Minister's deliberate sleep over a vital anti-discrimination proposal fueling religious conversions and communal riots? He and the Law Minister of Orissa apparently were sleeping on one of their own decision, to put a permanent halt to the discrimination of "lower caste" Hindus. Upon a request from me, a non-resident Indian, in Jan-2006 to remove a discriminatory board "Only Orthodox Hindus are allowed" from the famous temple of Jagannath at Puri, the Chief Minister had directed the State Law Dept. to collect opinion from the Jagannath Temple Managing Committee on the viability of my proposal. The Law Dept. took up the issue with the Temple Managing Committee, headed by the Gajapati Maharaja Dibyasingh Deb. The Law Department and the Temple Management Committee agreed to a countrywide opinion poll to decide on the proposal. A sub-committee had been formed to frame a suitable questionnaire, which was to be circulated among intellectuals, *sadhus*, *mutt* chiefs, senior *sevayats* and researchers all over the country. It was decided that their opinions, when received, will be discussed by the sub-committee before being passed on to the Temple Managing Committee for its final opinion on the proposal. In December 2006, there was a month-long controversy over Dalits entering into Keradagarh Jagannath temple and around 1,000 discriminated "lower caste" Hindu's embraced Buddhism in last year April. The Chief Minister and Law ministers were reminded repeatedly by me, with endorsements from several eminent personalities, inclusive of National Vice-President of BJP Jual Oram and Dhananjay Vaidya, National President (A.V.), Jagadguru Shankaracharya Mahasamsthanam, Poorvamnaya Govardhan Peetham, Shankaracharya Math Marg, Puri. Dhananjay Vaidya confirmed that, if the Govt approaches, the Shankaracharya will be glad to offer his services for this greater cause. But the Naveen

Patnayak Govt. was mum and upon infliction of great frustration by upper caste Hindus, the "lower caste Hindus" finally embraced Buddhism. In Kandhamala district of Orissa, there were fresh anti-Christian violence in the converted Christians and Hindus. Out of severe frustration, several "lower caste" Hindus in tribal areas of Orissa, discriminated by both their society and govt. already embraced Christianity. Frustrated by the attitude of the State Govt., I initiated a public awareness poll-through blog portal [www.HindToday.com](http://www.HindToday.com). I am hopeful that, probably the Govt. will open its eye, after the recent communal riots in Kandhamal district. (See also p.22)

The official justification and pretext for an increased military presence in Pakistan is to extend the "war on terrorism". Concurrently, to justify its counter-terrorism program, Washington is also beefing up its covert support to the "terrorists." It has now become apparent that the insurgency in the FATA region of Pakistan is aided and abetted by the US. It wants to weaken the control of the federal government over Pakistan and it does not care whether it is achieved by Islamists or by ethnic nationalists. Its manifesto seeks to re-write the constitution on the basis of 1940 Resolution. It wants the Federation to have only three subjects — Defence, Foreign Affairs and Currency. While the MQM wants Pakistan to accept the Line of Control as the border in Kashmir, Musharraf is willing to give even Azad Kashmir and Northern Area to joint control with India. Patriotic Pakistanis are thoroughly confused. Should they see Musharraf and the Army as an instrument of the defence of their national interests or a vehicle for compromising them? Would the political administration that results

from the February Elections better defend Pakistan's interests or would it weaken Pakistan even further by infighting and erosion of federal authority. The people of Pakistan do not care whether Musharraf is inept or a collaborator of anti-Pakistan interests; they want to see the back of him. The hope is that the institutions of 'free media' and 'independent judiciary' would protect Pakistan's interests even if the political apparatus cannot. And these would be restored early and fully only if he left the office of the President before the elections

**Praful Sakya**, R.No.216, Survey No.56 - Malwadi, Wadgaon Sheri, Pune - 411 014: Well, the results of Gujrat and Himachal Pradesh assembly election were out and as was expected Bahujan Samaj Party (BSP) did a little below and over margin. After the successful conquest of one of the country's most socially conservative states, with the help of newly dream-up formula of social engineering, the BSP was speculatively fully turbo-charged to make inroads in both the states. But is that the results somewhat faltered Mayawati's pan India dream? Well, it will be too foolhardy to say so. Because, if one goes through the fine print of the results, one would realise the damaging force or nuisance value the BSP wielded especially against the Congress. It may not have won a single seat but it had damaged the prospects of the over dozen candidates of the Congress in Gujarat. Its vote share rose to 2.62% from 0.32% of total votes polled in 2002 Assembly election. Earlier in 2004 parliamentary elections, its vote share was 1.48%. In the state where electorate largely remaining polarised between the BJP and Congress, the BSP came third in around 53 constituencies and fourth in 54 seats. The party had put up candidates in 166 out of 182 constituencies. It is the performance worth applauding as the BSP did this miracle in only 6 months time they had for the election-work, argues the BSP party workers. And in HP it did open its account by winning a seat and increased its share of total votes from 1.5% to 3%. The story here is same as that of Gujrat. It did damage the Congress with more or less same intensity. And before all this it was in Maharashtra Assembly election (2003) the BSP had done the same damage to the Congress-NCP led coalition—it ruined the prospects of over dozen candidates. Clearly, it signifies that the BSP has been able to leave a mark which it can consolidate in years to come. It is just an end of beginning of a long innings which Mayawati intends to play in the western state and yet to play in southern states. So, is it the social engineering formula, which was nurtured so dearly and partially optimized after working painstakingly on social-economic realities and considerations that brought *Behenji* to power in UP, failed comprehensively? Or the poor show of the party could have really been averted had the party played the game differently by giving varied consideration to the local socio-economic and developmental parameters by playing the cards of social engineering aptly? It was a case of

fifth-time unlucky for the BSP which has been contesting some seats in Gujarat since 1990. It is most likely that the poll performance assessment of the BSP is being done under the shadow of the success of the social engineering formula in UP. And why not, the BSP this time too did try to play the trick again. So the out come of the whole fact the BSP's trick of social engineering did not fetch it the results which were being anticipated. But if one would make the assessment of the Gujrat results under the shadow of social engineering formula, then the case is pretty clear it failed, but on the other side it did end up as a gross gainer. The BSP is gainer in terms of vote share that it had managed to muster. In both the state the BSP precisely managed to bring the votes of underclass along with some portion of the Muslim votes under its wing that was once considered the traditional vote bank of the Congress. And the matter of the fact is that the experiments that carried out in the UP were replicated in both the states. Aftermath, the BSP had made a big dent in the traditional vote share of the congress. Why was the underclass votes rallied behind *Mayawati* in these two states after UP, where she and her mentor and founder of the BSP late Kanshi Ram consolidated vote-bank comprising underclass and Muslims? The answer of it laid in the fact her rise to power and becoming the first underclass lady Chief Minister that too with a clear majority on her own charisma. And this really strengthened the wings of 'aspirations' and nurtured a 'can do mindset' in underclass. That's the reason why the underclass been trying to strengthen the BSP's elephant. They are least bothered about the fact whether it would fetch a win for their candidate or not their primary object is to stand behind Mayawati. It is a great success of Mayawati that she brought, if not all, then a sizable chunk of underclass votes (In the states which went to poll recently) under her wings and tried to bring others (OBCs, Tribes, Brahmins and other upper-class) to its fold without jeopardizing her base vote. In reaching out to the Brahmins (and other upper class), the traditional oppressors of the underclass, she has demonstrated her confidence in her own ability to make a success of this seemingly unlikely alliance. There she won half the battle; the fate of the rest will be decided on how innovatively and inventively she forges this different societal aspirational combination for furthering her prospects in the elections. She has to work out on the organizational strengths and build-up, cementing its all sections with common minimum goals and try to win over the support of

the maximum section of the Indian society by breaking the shackles of societal-prejudices, which are deeply embedded in the mind of the so called upper class. The task is daunting but headway is a real necessity. And this will only carve out script of success, as had happened in the UP election. The result of two states indicated a unique trend that her base vote is strikingly making her elephant a potent threat to the prospects of the Congress. And the Congress should on its own peril ignore this fact in the four states which are likely to go in for poll this year viz. Karnataka, Chhattisgarh, Delhi and Rajasthan. The base vote of Mayawati helped her to acquire a strong bargaining position; if Congress decides to forge some sort of pre-poll alliance for brightening its chances, provided it learnt a lesson from the recently concluded two state elections. It's too ruthless expectation that the BSP should have performed the way it did in UP on the basis of the social engineering formula.

But one should not ignore the fact that the 1) understanding the political circumstance in the state, 2) party's work, 3) organizational make-up and build-up, 4) societal parameters, 4) party's and candidate's virtuousness and charisma, 5) party's agenda and its acceptance by the voters, 6) adherence to ideology, 7) mass and class appeal, 8) staunch force of leaders and followers, 9) firm base-voter, 10) management of dissidents (like accepting and taming), 11) election campaign and media management, 12) emotive issues aligned with party's manifesto, 13) good faith earned and generated by the party leaders and workers, 14) identifying the chunk of dejected voters and try to win over them, 15) formulating and offering solutions for the current socio-political entanglement and making it a sellable entity, 16) making socio-economic aspirational commitments and earn a faith to fulfill them, 17) practical bold and reformist move, 18) socio-economic and politically innovative and inventive 19) strong fund raising mechanism and fund's optimum utilization, 20) party's blue print of state's development plan, 21) properly gauging the anti incumbency wave, 22) media management and PRO networking, and the chief factor 23) proper assessment of caste, inter-caste, religious and inter-religious socio-economic political realities and compulsions.

All these 23 points are the governing parameters of success-engineering. Why is that the success of Mayawati in UP is seen as the win on the social engineering plank? Unfortunately, it was projected as the success due to the ticket distribution on the caste calculation, which led her to unanticipated win. But it was widely misunderstood. Why had the caste-based

tickets distribution been encompassed in the social engineering term as a whole which was not heard before? It was typical upper caste mindset that think that an underclass lady could not secure a clear majority by her own and that too right under their noses. It is systematic effort of undermining her achievement. And the same has been continuing when her party failed to muster a win in the two states by ridiculing that her social engineering formula failed, which was mainly whirl around the caste-based ticket distribution. Yes, of course, with the strong emergence of party like the BSP or small state-centric parties in that sense it has been widely understood that caste-based calculation is must consideration for ticket distribution. In reality the social engineering is not caste-based ticket distribution but its one of the dominating factors. Had it been the case then the BSP or for that matter, any national or any other party would have won the maximum seats in elections. The win of the BSP in the UP election was mainly because it had scored better in the above mentioned 23 points over its arch political rivals and partly because it had played a caste card adroitly (one would understand it by going through the ticket distribution of the BSP in UP). And that really heralded the phenomena called social engineering. The other is that, as chief minister-designate Mayawati said after her party's victory, the common man rejected sectarian politics to rise above caste and religion. What does that mean? There is reason why social engineering success phenomenon is used with Mayawati because of her underclass status and win that she managed which otherwise considered an upper class prerogative. Modi in Gujrat, Dhumal in HP won because they scored better in the above mentioned 23 points. And that is not called social engineering even when they played the caste card too. Why is so? Is it not that the Congress or the BJP does calculate caste equation before ticket distribution? If not in the past (half truth half lie), yes, of course, they do, in the present. They have to and the credit goes to the BSP. The best thing that has emerged out of this thing is that every other party is knowingly or unknowingly following the BSP's election punch line '*Jiske jitney sankhya bhari, utni uski Bhagidari*' (as per the one's population it will get representation in the election) which it had coined during one of the Brahmin *Bhaichara* rallies held in UP. How about calling it *Bhaichara* engineering in political circle? It is not a hidden fact that if any political party is to rule over Delhi it has to widen its base in all the sections of the society and the BSP is no exception to it. The Congress has always been harping on secular

credential and boasting for the support of all sections of the society, mainly thanks to its contribution in the "independence" struggle. The BJP which has been chillingly following the dictates of the hard-and-mild *Hindutva* as per the guiding principals of its mentor non-political, spiritual and cultural entities too claims and enjoys hard and mild supports of almost all the sections of the society barring Muslims. There are myriads of the parties on the political horizon of India those too enjoy the support of specific followers depending on how fervently they tune their agenda in to the local flavors with spill-over effect on national polity. Considering the political realities of India one-party rule is clearly a bygone era. Coalition govt. of like-minded groups or combination would, with majority in place, rule over Delhi. The groups have got distributed between the BJP and Congress, by considering the legitimate allowances of some parties which are likely to shift loyalties. But it is quite certain that either the BJP or Congress group would come to power on the basis of pre-or-post poll alliances bonded with common individual-cum-minimum goals. But one should not forget that in the coalition era certainty of political combination is an uncertain phenomena. The attracting forces—depending upon the current situation—among groups trump up alternatives. And if left parties continue to show its performance the way it did in the last general election of 2003, and make swift efforts to revitalize the third front in that case things might go little tougher for either the BJP or Congress, of course, lot will depend upon how third front allies perform and stick together. This will only change certain uncertainties in the Indian politics of coalition otherwise lot will remain predictable after the great or bad show of the BJP or Congress. And the fourth should closely be watched out for alternative is how good the BSP performs. If it does well then the BSP will emerge as a real king or king-maker, of course, it should secure not less than 65 seats. But this is not an easy task. The BSP has to work on the 23 point success formula in each state where it wanted to make a debut. The BSP had managed to strengthen its base vote and that is turning out to be its strong point. Now it's time to widen the vote share and base. Mayawati said after her party's victory, the common man rejected sectarian politics to rise above caste and religion. It's acid test for Mayawati to affirm the faith of common man to prompt them to reject sectarian politics to rise above caste and religion in other states as well. **Sanjay Kumar Rahi**, Dilawarpur, Milkichuk PO, Dharbanga dt. - 846 009: Brahmins were not only beef-eaters but consumed the flesh of horses also which were sacrificed in *yagnas*. ## Orissa violence is "independent" India's biggest attack on Christians

In the last few days, AICC leaders released two reports on the anti-Christian violence in Orissa which began on Christmas eve. They concluded that the attacks on Christians included simultaneous, planned violence by extremist Hindu terrorists and complicity and consistent

Media reports said two members from India's National Commission for Minorities (NCM), Dileep Padgaonkar and Zoya Hasan, are currently in Orissa to investigate the violence. AICC leaders met with the NCM chairman on Dec. 27, 2007 in New Delhi.

Together with the All-India Confederation of SC/ST Organisations led by Udit Raj, the AICC held a "Stop Violence Against Christians" Rally in Bhubaneswar, on Jan. 10, 2008.

The violence began when Christians in Bamunigaon village in Kandhamal district of Orissa began to celebrate Christmas eve. Local Hindu terrorists opposed the event and a quarrel ensued. Also, a Hindu terrorist leader, Swami Saraswati, was attacked by unknown assailants — he alleged they were Christians. The next day a Vishwa Hindu Parishad (VHP)-affiliated group called for a strike and VHP members began attacking Christians across the state. ■

BOOK REVIEW

## Frank admission of caste among Muslims in North India

It is hazardous to review a book which has the ingredients and potentials of opening a Pandora's box. The book by Masood Alam Falahi falls under this category. To consider caste or social stratification in Muslim society is almost a taboo let alone study and follow its ramifications and impacts on society. The credit goes to Falahi to break this taboo and present this malady in all its crude nakedness. Although studies into the reasons for the persistence of Hindu caste structure, particularly among the middle and low caste converts to Islam were, studied in depth with uncertain results for the reason that the Muslim respondents refused to either admit such stratification or took defensive shelter behind Quranic injunctions. The concept of caste among the Indian Muslims with its attending disabilities and social stratification outside the Hindu fold is enigmatic and requires deeper studies. The book is very comprehensive and deals with the subject thoroughly which includes existence of this malady in the Semitic religions in its rudiments.

### TIPU'S GLORIOUS EXAMPLE

With the advent of Delhi Sultanate, the Muslim society as a state policy adopted the *varna* cult and thus evolved its own hierarchical caste system in terms of *Ashraf*, *Ajlaf* and *Arzal* which later consolidated into Syed, Sheikh, Mogul and Pathans. Although in the beginning it was a pure artificial stratification conjured up in the courts of Sultanate for purposes of legitimisation which with the passage of time took roots and established itself as a reality. While

the former two castes carry with it a pretentious claim the latter two connote only their ethnic origin. Their respective *ashrafiat* ends there. The others were rubble and scum. What was most intriguing was the attitude of the historians of the time like Baruni to the present-day revered personalities like Sir Syed, *ulemas* of the stature of Moulana Ashraf Ali Thanavi and many others who not only condoned such practices but also practiced it.

It was the immigrants from Islamic lands who had monopolised and constituted the superstructure of power with the pretentious claims of *Ashraf* and the sultanate retained and patronised this social hierarchy

for reasons of state craft. The natural fall-out was the formation of a rubble class outside this group. This artificial grouping was a contingency of state craft.

**Since then Muslims live in two worlds. One an egalitarian where all are equal, the other the substratum which transcends the egalitarian sphere — an ideal Islam and a compromised Islam.**

But the redeeming feature was the South wherein by and large these practices failed to get the required patronisation from the courts of Sultans. As a matter of fact it fell to the lot of the great saint-king Tupu

Sultan to break up this conjured up caste hierarchy. His *Ahmadi Risala* consisting of converts were given the honorific prefix and affix of Syed and Khan to their names and were settled in his garrison towns all over his domain. In his administration the locals were given precedence over the migrants and for which he had to pay for by his life itself.

### WELL-GUARDED SECRET

The one disappointing feature of the book happen to be its concluding chapter which failed to look beyond the Muslim conglomerate. It failed to provide any blueprint of action to break the barriers of religious borders and join hands with identically placed parallel section of the downtrodden and havenots in other societies on a revolutionary platform. The book deserves to be translated in other Indian languages preferably in English.

With the coming into print of the *Basic Problem of OBC & Dalit Muslims*, a well-guarded secret is out. That their exists large section within the fold of *ummah* who leads a subhuman status and who in the eyes of their *ulemas* do not deserve to be counted as Muslims at all. This in spite of projecting Islam as an egalitarian religion with its lofty *quranic* injunctions. The book has been scholarly edited by A.H. Ansari and the articles have been contributed to this volume by persons of eminence in their respective field ranging from academics to social scientists and political activists. Each of the article contributed is a treat in itself.

The principal role of class and caste

in a religious conglomerate is the principal variable in a social structure of the community.

The Indian Muslim society is divided both vertically and horizontally and these divisions determine the society's interaction between various groups.

It is to be noted that the caste structure obtaining among Muslims, especially in the cow belt, is by and large analogous to the hierarchical principle or a replica of Hindu caste system with all the attending disabilities. This in spite of the egalitarian and lofty Islamic principles of equality. The social structure formalised with an *Ashraf* caste on the top during the Sultanate period continued unabashedly post-mutiny as well. Its greatest protagonists range from Sir Syed Ahmed to plethora of *ulemas*

including figures like Moulana Ashraf Ali Thanavi.

With India attaining "independence" and in its wake migration of a predominant section of *Ashraf* to Pakistan leaving behind the less fortunate to tend their own future there appeared a mobility not seen at any earlier time.

The political and social convulsions in Pakistan can be attributed to these *Ashraf* migrants coupled with the *ulema* combine are sufficient enough to bring its end sooner than later.

There is a subtle shift in this intercaste and intra-caste mobility as it is providing an impetus for interaction with the parallel categories of caste and class in other religious groups. This happen to be a welcome sign in a pluralistic society. Now the term OBC and Dalit which was earlier being used exclusively in

respect of "Hindu caste" is now transformed into a class distinction for the Muslim sections of parallel caste or class. This progressive attitude transcending religious barrier is a welcome sign.

The most welcome feature of the book being its progressive outlook and a blueprint of action in a pluralistic society. The bold and rebellious exposures of the dark niche, the recesses and the cobwebs crowding the minds of the leadership of the community coupled with exposing the hypocrisy of assertion of equality but practicing an attitude of almost untouchability is the welcome feature.

Perhaps it may go a long way in jolting out the political and religious leadership from their smug attitude. Both books are a welcome addition on a subject very rarely traversed. ■

## The nonsense called Rama Sethu

The pre-Aryan, non-Aryan and non-Vedic Indus Valley Civilization thrived in the third millennium BC i.e. between 3,000 and 2,000 BC. Max Muller ascribed the latter half of the second millennium i.e. between 2,000 and 1,500 BC to Vedic period when iron was in use. Aryans were a rural people who never had townships — *puras*. Aryan invaders destroyed pre-Aryan, Dravidian towns and cities. Their god, Indra's another name was *Purandhara* i.e. the destroyers of *puras*. The two *puras* mentioned in the *Rig Veda* are Asandivat and Kampila.

Sanskrit language had not come into existence in the third millennium BC when Prakrit, Tamil and Kannada were in use. There is a derogatory reference to Budha (566-486 BC) who lived in the 6th and 5th century BC in what is claimed as the *Valmiki Ramayana*, according to Dr. Narla Venkateswara Rao, an awardee of the Central Sahitya Academy.

Apart from iron, the concept of fire god i.e. Agnideva was not known to Indus people, while Sita was tested in fire i.e. by Agnideva. Ayodhya was a city, i.e. *pura*. Vasista, the royal priest, refers to Vedic *shastras* whenever the ruler—Dasharatha or Rama—sought guidance. Ravana is described as one of the experts in Sanskrit grammar. All these provide clues to the period of the *Ramayana* i.e. the period ascribed to *Ramayana* by those who conceived the story.

An important aspect of Vedic mythology—of which the *Ramayana* is a part — is the predominance of males. Goddesses like Saraswati, Pritvi, Aditi and Ushas occupy a very subordinate position. In contrast, in the earlier Indus culture, the mother goddess is co-equal with her male partner.

**Sita was victimised more by Rama than by anybody else.**

Even after subjecting her to fire-test

(*Agni Pariksha*), he abandoned her to forest when she was pregnant because of a casual silly comment by a washerman — *dhobi*. In the end unable to bear his cruel accusations, she begs mother earth to swallow her and the earth obliges. In other words, she commits suicide.

**Suspecting and torturing Sita was his chief sport and pastime. Shambhuka episode shows him as an enthusiastic soldier of Manu and as the very personification of the Vedic value system.**

According *vaidiks* he is *Vigrahvan dharma* i.e. the embodiment of *dharma* viz the *dharma* of *chaturvarna*. All this very clearly establishes that the story contained in Valmiki's fiction was conceived in the post-Indus period. It is the faith of all objective thinkers, Periyarists and Ambedkarites that Rama of Valmiki's work was not only not divine, but not even human. Clash of faiths is therefore inevitable. The

cry of the priest class, the exploiters and their apologists — when the exploited react and resent — that their feelings are hurt, is natural but absurd. Their record has been one of oppression and suppression.

### WHAT RAJAJI SAYS

Rajaji, the author of the most popular and the best seller of all the *Ramayanas*, writes in his book:

The *Ramayana* is not history or biography. It is part of Hindu mythology... In Valmiki's work, Rama is portrayed as a great and unique man, not as an incarnation of god". (emphasis added).

Confusions, contradictions and disorder perplexes anyone who wants to know the whole of *Ramayana*. Not only there are so many *Ramayanas* but even in the same book inconsistencies can be seen. Even Rajaji, despite his reputation for an incisive mind, states that Valmiki gathered the story from folklore, that he learnt it from Narada and that he was blessed with the knowledge of Rama story by the four-faced Brahma.

### WORST WOMAN-HATER

Any student of *Ramayana* gets drowned in confusion worst confounded when he finds that the abandoned Sita gave birth to her twin sons in the hermitage of this very Valmiki. Discussing the pathetic episode of Rama abandoning the pregnant Sita, even Rajaji writes angrily:

"...my heart rebels against it... it mirrors the voiceless and endless suffering of our women folk".

**Rama is surely one of the most anti-women characters in the whole of world literature.**

### JAIN RAMAYANA

Long before Valmiki, there were several Rama stories in the folklore depicting Rama as an ideal king, at a time when there was clash on what made an ideal. In one story, Sita is Rama's sister while in another she is Ravana's daughter. In a Rama

story of Buddhist tradition by name *Abhidhamma Vibasha*, Buddhist ideals and values are upheld. Jains have six Rama stories which uphold their concepts and values. Vimala Suri, Swayambhu, Hema Chandra, Guna Bhadra, Pushpa Danta are the authors of these Jain *Ramayanas*. Of all the Jain *Ramayanas*, *Padma Purana* of Acharya Ravishena is very famous. Here Rama is known also as Padma.

At a time when the *vaidiks* needed a hero and a story to attract masses from Buddhist and Jain fold, the fiction attributed to Valmiki developed. They had to send feelers that non-Brahmins too can command respect in Vedic social order. It is therefore not accidental that Rama, Viswamitra, Anjaneya and Valmiki have all been portrayed as non-Brahmins and Ravana their villain as Brahmin.

### VAIDIK AS EXPERTS IN FORGERY

**Renowned scholar, Dr. Suniti Kumar Chatterjee, states that it was Chyavana Mahrshi, a Brahmin who actually wrote the Sanskrit Ramayana and attributed it to Valmiki.**

In order to validate and propagate the values and beliefs of their faiths, Jains, Buddhists and *vaidiks* picked up the Rama story which was already there in the folklore and reshaped it to suit their needs, according to Dr. K.R. Srinivasa Iyengar, former VC of the Andhra University, as well as Dr. Sukumar Sen. *Vaidiks* were adept in plagiarism. According to some scholars the name Rama itself is of Jain origin. A Bengali text, *Lakavatara Sutra*, portrays Ravana as a Dravidian king who took to Buddhism after rejecting the *vedas*, *yajnas* and *yagas*. *Vaidiks* had to demonise him in order to abuse him. The belief that by reading or listening to *Ramayana*, bliss (*punya*) can be attained, was spread.

**The Ramayana thus became an**

**oversized propaganda pamphlet of Vedic religion.**

### VALMIKI'S TIME

Of late, in some *Panchangas* (*vaidik* almanac/calenders) the full moon day of *Ashweeyuja* month (26-10-2007) is shown as *Valmiki Jayanti*. A people who never cared to find out the century in which the poet might have lived are sure of his date of birth. Moris Winternitz and A.B. Keith are the two Western scholars who are extensively quoted in any serious discussion on ancient Sanskrit literature.

Both these scholars have determined that Valmiki lived during the 3rd century BC. Prof. Hopkins and Herman Jacobi who studied the various stages in the growth and development of Sanskrit language have held that the *Valmiki Ramayana* was composed when the Sanskrit language had reached almost the final stage of its evolution and had become completely refined and mature in view of the simplicity and beauty of the *Valmiki Ramayana*. Their finding is in conformity with what Winternitz and Keith have said about the time of Valmiki.

### BUDHA'S BLOW TO BRAHMINS

Budha is the first great Indian whose dates of birth and death are not in dispute.

**Budha was a historical figure while Rama was a cock and bull story.**

He lived between 566 and 486 BC. Valmiki, therefore lived two centuries after Budha. By attracting the masses who had been persecuted by the Vedic social order, Budha gave the first ever moral shock, intellectual jolt and sociological blow to the Brahminic religion.

Rama endlessly boasts about his lineage. Sita's fidelity assumes disproportionate importance. The chief message of the *Ramayana* is

that husband's verdict on wife ought to be final. Rama was noticeably the anti-climax of everything that Budha stood for. Budha left his queen and child in palace and abdicated the throne. Rama stayed in the palace and abandoned the pregnant Sita to forest. Rama obeyed priests and *shastras* while Budha taught how to live without them.

On which century did Rama live? This question that does not arise since in all pre-Valmiki and post-Valmiki *Ramayanas*, Rama is only a character or at best the hero of an over-glorified novel. Let me repeat the words of the most respected among the *Ramayana* votaries, Rajaji:

*Ramayana* is not history or biography.

Even as the elephant headed Ganesha or four-headed Brahma could not have existed, Rama too is part of several or varieties of *Ramayanas*, all of which fictions.

#### RAMA SETHU

The hump beneath the sea between Dhanush Koti and Talai Mannar is described in all official and cartographic records as Adam's Bridge. The unwarranted and unauthorised term Rama Sethu or *Ramar Sethu* is sought to be legitimised by *vaidiks* and their Hindu terrorist outfits to whom the media has always been helpful. Babri Masjid complex and Bababudangiri (in Karnataka) have been unauthorisedly named by these very outfits as *Rama janmabhoomi* and *Dattapeeta*.

The geological truth is that the island Ceylon, called Sri Lanka since about 40 years, was once a part of India and due to corrosion by sea during the past about 1 lakh years, the island was formed and the remnants of land — mixture of rocks and sand is the present Adam's Bridge. The hue and cry of the saffron outfits over Rama Sethu can be easily put

down by gathering expert opinion from geologists. The UPA Govt. unfortunately does not have the political will. The UPA led by Sonia Gandhi blundered by withdrawing the affidavits which contained unqualified truth about Rama and Adam's Bridge, even as Narasimha Rao bungled at Ayodhya.

#### CONTROVERSY ON RAMA'S DATE

Human beings in the present form evolved about 1 lakh years ago when man began to live in caves, according to history of human evolution.

**Geology and seismology too are clearly against the silly propaganda that Rama and vanaras built what is now seen as Adam's Bridge.**

At first they cried that Rama built this bridge 17 lakhs years ago. Someone among them recently came up with the wonderful discovery that Rama took birth in 5114 BC i.e. 51 centuries before Christ. According to the findings of the archaeological excavations at Ayodhya, the earliest occupation of the place by humans could not have taken place prior to 7th century BC (See: *Indian Archaeology-A Review*, 1976-77).

Ayodhya means "impregnable". There is nothing impregnable about the present Ayodhya. All this shows that whoever discovered the years of Rama's birth knows more than even Valmiki about the *Ramayana*. However our Brahminical media gave prompt and wide coverage for this celebrity of sorts.

**Whenever our Hindu terrorists raise non-issues the media turns into a machinery of misinformation.**

A very high profile article on Rama in the *Indian Express* (Sun, Oct. 7, 2007) tells us that Valmiki according to historians lived anywhere between 800 BC and 400 BC, without giving us even a single name among those historians.

The biggest and the most propagated lie is that the nonsense dished out by the Hindu terrorists called Rama Sethu is the faith of millions of Hindus. Nearly half of world's illiterate population lives in India and 47% of India's children under the age of five are "chronically malnourished", according to the United Nations report of 2005. Do our millions suffering from illiteracy and squalor have any time or interest in polemics over the events narrated in mythology?

#### HINDUISM - A MISNOMER

"The word Hindu... has lost all its meaning, for this word merely meant those who lived on the other side of the river Indus (in Sanskrit, Sindhu). This name was murdered into Hindu by ancient Persians... and during Mohammedan rule, we took up the word ourselves... all the people who live on this side of the Indus in modern times do not follow the same religion... therefore would not use the word Hindu... The other words which alone we can use are either the *vaidiks*, followers of the Vedas, or better still the *Vedantists* followers of the *Vedanta*.

"... all the people that live on this side of the Indus no longer belong to one religion. There are the Hindus proper, the Mohammedans, the Parsees, the Christians, the Budhists and Jains. The word "Hindu" in its literal sense ought to include all these; but as signifying the religion, it would not be proper to call all these, Hindus... This perhaps is certain that no man can have a right to be called a Hindu who does not admit the supreme authority of the Vedas".

These are not the words of either Periyar or Dr. Ambedkar but of Swami Vivekananda (pages 118 and 228 of Vol.3 of the *Complete Works of Swami Vivekananda*).

It is a pity that the great Swami did not know that Lingayats (followers of Basavanna-12th century) and Sikhs (followers of Guru Nanak - 16th century) too rejected "the

supreme authority of the Vedas". It is a greater pity that the great Swami overlooked the fact that Vedas had persecuted whom the *smritis* called Chandals and who had to wait for 3,000 years in order to be called by an appropriate name Dalits.

#### GANDHI ON HINDUS

Truth itself had to wait in order to find an expression until Gandhi came to the conclusion: "the Hindus are really not the major community if you put the rest together". Saffron disdain for Gandhi is understandable.

According to the *Goutama Dharma Sutra* (an important *Smriti*) if at all any *shudra* (whose rank is higher than Dalits) hears Vedas molten lead should be poured into his ears. Adi Shankara, the most adored Indian for the Hindu terrorist party, quotes this sanction against *sudras* with approval in the 38th verse of the 9th section of the 3rd part of the 1st chapter of his *Bramhasutra Bhashyam*.

**On this such a famous non-issue called Rama Sethu, Chief Minister Karunanidhi truly represents the millions of non-cross-thread Hindus. In fact millions are indifferent to Rama and trillions are unconcerned about Rama Sethu.**

#### HINDUTVA & ENVIRONMENT

Rama perhaps did not approve the demolition of Babri Masjid and did not bless the Hindu terrorist party in UP. The saffron mafia knows that Rama can become not only an electoral risk, but even a liability in Tamil Nadu, the land of Periyar. The non-issue of Rama Sethu may be of some marginal use elsewhere. They are therefore playing the environment card.

The mafia is adept in politicising every *vaidik* concern by mixing it with larger public concerns, banking on the gullibility of the misinformed masses. Hindu terrorists did not support environmentalists who had objected to Sardar Sarovar Project because no *vaidik* was affected. The

affected poor villages and tribals had nothing to do with *hamari Pracheen Parampara* — our ancient Hindu heritage.

Of all the arguments related to Rama Sethu, the most unsoound and funniest is the one advanced in the name of environment. Whenever a big building is built, railway line is laid, or a factory comes up, air and noise pollution is inevitable, trees are cut, nests are destroyed and earthworms are killed. Even boring a well is a sin since it affects ground water level.

#### RAMA DAMAGED ENVIRONMENT

It is argued that forms of life around Adam's Bridge are covered by laws relating to environment. The truth is that the coral needs etc. and other forms of life get naturally replenished in due course according to geology.

**If it were Rama that built what they call Rama Sethu, he must have been the first to damage the environment for purely personal reasons. Surely he did not go to Lanka for any public cause.**

The argument that the Sethu Samudram Project will affect the lives of fishermen is even more funny. It is too well known that routine fishing on our coast has resulted in the extinction of many varieties of fish. For this irreparable environmental loss, fishermen and fish-eaters alone are to be blamed. It is a pity that fishing is free from any form of regulation.

#### UNTRUSTWORTHY CONGRESS PARTY

Archaeological excavations did take place with the specific object of finding the historicity of the *Ramayana* story at and around Ayodhya. No evidence was found.

Late Dr. Narla Venkateswara Rao, the great rationalist of Andhra, has discussed all this in detail in his book on the *Ramayana*. The UPA Govt. did great disservice to the country

by victimising the officers of the ASI for telling the truth to the Supreme court on lack of archaeological evidence about the historicity of the *Ramayana*.
